3. COMM. 3E-31 (2007) COUNTY EXECUTIVE

WHEREAS, Pandemic influenza occurs when a novel influenza virus appears that causes readily transmissible human illness against which most of the population lacks immunity. By definition, a pandemic flu event would create a disaster at the international, national, state, and local level. Therefore, no amount of preplanning and other preparatory actions will eliminate all mortality, morbidity, and other societal losses. However, reasonable allocation of resources may greatly help minimize risk to the public's health, safety and well being, and

WHEREAS, the following are generally accepted planning assumptions:

- Influenza pandemics are expected but arrive with very little warning.
- Outbreaks can be expected to occur simultaneously throughout much of the U.S., preventing sharing of human and material resources that usually occur in the response to other disasters. With the exception of vaccines and medications, which the CDC and New York State Department of Health will control, and will likely be in very limited quantities, localities should be prepared to rely on their own resources to respond. The effect of pandemic influenza on individual communities will be relatively prolonged (weeks to months) in comparison to disasters of shorter duration.

- Because of widespread susceptibility to a pandemic influenza strain, the number of persons affected will be high. In a pandemic of a moderate influenza strain, it is estimated that as many as 270,000 (30%) Erie County residents would become ill during a 4 8 week period. This could result in 627 deaths. If the outbreak is of a severe strain such as the 1918 pandemic, these numbers would be significantly higher with as many as 6,709 deaths. These figures do not reflect the huge numbers of worried well who will seek medical care.
- Health care workers and other first responders will be at higher risk of exposure and illness than the general population, further straining the health care system.
- Effective preventive and therapeutic measures, including vaccine and antiviral agents, are likely to be delayed and in short supply.
- Widespread illness, the worried well and the necessity of caring for the ill in the community could result in sudden and potentially significant shortages of personnel in other sectors that provide critical public safety services, as well as services to meet all other human needs (e.g., food, shelter, utilities).
- Hospitals will quickly be overwhelmed. The double burden of a massive increase in patient demand and decrease in available staff will push the health care system to the breaking point. Evaluation of many worried well will likely further compound this problem. Medical rationing and altered standards of care will need to be controlled on the federal, state and county levels;

and

WHEREAS, although resources to enhance our (collective) ability to respond to a pandemic flu or similar event are not limitless, additional resources will greatly enhance our capabilities in the event of pandemic flu, and will also bolster our core public health functions throughout the year, and

WHEREAS, the following resources are needed:

A. P. H. Lab, Epi and Environmental Health Division

- 1. Laboratory Supplies: to purchase consumables including:
 - Laboratory reagents
 - Primers, probes, master mix (molecular tools)
 - Specimen collection devices
 - Packing and shipping materials
 - Detection kits
 - Cost: \$97,291
- **2. Personal Protective Equipment:** to protect staff/employees from exposure to infectious, hazardous, toxic materials (i.e. long-sleeved gowns, eye protection, disinfecting solutions)
 - Cost: \$3,000
- **3. Biohazard Supplies:** for safe and proper disposal of contaminated materials (i.e. biohazard equipment, sharps containers)
 - Cost: \$20,000

- **4. Communications/Computer Equipment:** to maintain connectivity to public health organizations, clients, regulatory agencies, etc. for reporting, notification, information gathering, etc (5 air cards w/ monthly internet accounts, 3 laptop computers, etc).
 - Cost: \$5,000

B. Medical Examiner

- **1. Personal Protective Equipment:** to protect staff/employees from exposure to infectious, hazardous, toxic materials (i.e. long-sleeved gowns, eye protection, disinfecting solutions)
 - Cost: \$20,000
- 2. Body Bags: 1,000 needed to process additional surge capacity.
 - Cost: \$25,600
- **3.** Autopsy Saws & Hoods: 3 autopsy saws with HEPA bone dust collectors and stands and 2 Luminar fume hoods are needed to upgrade office to protect workers.
 - Cost: \$27,278

4. Verichip Identification System: In order to handle the additional deceased in an efficient manner it will be necessary to implant chips in the remains so that a positive identification system will be used. This will allow tracking of the remains without opening the body bags and will be needed so that families can relocate their loved ones to permanent internment sites.

- Cost: \$27,700

WHEREAS, the project also includes the investigation, reporting and resolution of complaints against specific providers, and

WHEREAS, the resolution also provides for the substitution of a Senior Caseworker position for a Caseworker position currently in the grant as the Senior Caseworker position is needed due to the growing complexity of program operations and responsibilities, and savings from turnover and vacancies enable the overall personnel appropriation to be reduced while still providing for the salary difference between the Senior Caseworker and the Caseworker, and

WHEREAS, Erie, Monroe, Westchester, Onondaga, and Wayne Counties share sales tax revenue with school districts; and

WHEREAS, the current STAR benefit system is calculated locally using property tax revenues as the sole local component; and

WHEREAS, the sales tax revenue these counties distribute to local school districts is not credited in the local share for calculation of the STAR benefit; and

WHEREAS, as these counties increase school district funding with sales tax revenues, the state STAR program benefit for residents does not increase; and

WHEREAS, if sales tax figures were included in the calculation of STAR benefits, county residents would receive an increase of twenty five million dollars in their STAR benefit without experiencing an increase in their school district tax rates; and

WHEREAS, residents of counties that provide support for school districts, by sharing sales tax revenue, should not be adversely affected or penalized with lower STAR benefits because of the sharing of their counties; and

WHEREAS, changing the formula for calculating STAR benefit amounts would return an additional \$25 million to Erie County taxpayers and have an economic impact benefit of \$100 million; and

WHEREAS, changing the formula for calculating STAR benefits has no impact on school district tax rates and has no adverse impact on Erie County taxpayers; and

WHEREAS, the original STAR resolution submitted by the administration that changed school district tax rates was received and tabled by the legislature as unworkable.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature requests that the local state delegation introduce and support legislation that would include sales tax revenues destined for school districts to be included in the calculation of the local share for STAR benefits; and be it further

WHEREAS, The purpose of H.R. 569, of which Higgins is a cosponsor, is to reauthorize appropriations for section 221 of the Clean Water Act, which provides grants to municipalities and states to control combined sewer overflows (CSOs) and sanitary sewer overflows (SSOs). CSOs and SSOs are overflows of untreated waste that can occur during wet weather episodes as a result of poor maintenance, deteriorating infrastructure, infiltration and inflow, and inadequate capacity, among other factors; and

WHEREAS, CSOs and SSOs present significant public health and safety concerns because raw sewage can overflow into rivers, lakes, streets, and basements, adversely affecting public health and the environment.

RESOLUTION NO. 53

RE: Senior Services - Authorization to Amend the AAA Transportation and III-B Grants (COMM. 4E-12)

WHEREAS, the Erie County Legislature has already appropriated funds for the AAA Transportation Program (AAA Transit) grant for the period April 1, 2006 to March 31, 2007 and the Area Agency on Aging (III-B) grant for the period January 1, 2007 to December 31, 2007, and

WHEREAS, the AAA Transit grant funds are intended for transportation operating expenses related to serving the elderly, and

WHEREAS, the Department has reviewed the budget in light of the short timeframe remaining in the start-up grant and has identified the following revisions are necessary to maximize use of State funds and achieve grant objectives, and

WHEREAS, the Department desires to enter into a contract with PLS III, LLC, dba as the Center for Transportation Excellence, for a 45-day demonstration pilot project to expand the number of rides available to seniors and to cover the instances whereby the existing fleet is unavailable and to allow for early or late pick-ups that cannot now be accommodated, and

WHEREAS, the Center for Transportation Excellence has agreed to work in conjunction with our established dispatch system using additional transportation providers in the community to accomplish the above objective, and WHEREAS, the Department will reimburse the Center for Transportation Excellence on a per trip basis (one way) for an estimated 225 trips, at a total cost not to exceed \$8,000, and

WHEREAS, the Department desires to use a portion of these funds to replace the receiver and repeater equipment, originally purchased in 1984, to eliminate "dead spots" and to maintain the current dispatch system, and

WHEREAS, the Department desires to use a portion of these funds to cover a portion of the salaries and fringe benefits costs for the three Dispatcher positions (position nos. 3072, 3073 and 51001745) and the Community Service Aide PT, position no.1803, who transports senior volunteers to work sites up to the amounts already appropriated in the budget, and

WHEREAS, the AAA Transit grant budget need to be revised, and

WHEREAS, no County funds are required for the AAA Transit grant, and

WHEREAS, the III-B grant budget has \$32,683 appropriated for Coordinated Care to operate the county-wide Telephone Assurance Program (TAP) during 2007, and

WHEREAS, Coordinated Care no longer wishes to coordinate the TAP program; and

WHEREAS, the Department issued a Request for Applications to agencies in the county already operating volunteer programs and home-contact services, and has identified the American Red Cross as best qualified to assume the coordination function for Telephone Assurance, and

WHEREAS, the American Red Cross, Greater Buffalo Chapter, will provide \$13,119 in agency and United Way funds as local match, and

WHEREAS, the Department desires to enter into a contract with American Red Cross, Greater Buffalo Chapter for the remainder of 2007 to provide the telephone assurance program.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is hereby authorized to contract with PLS III, LLC, dba as the Center for Transportation Excellence, for the period February 15, 2007 to March 31, 2007, for a demonstration pilot project to expand the number of rides available to seniors and to cover the instances whereby the existing fleet is unavailable and to allow for early or late pick-ups that cannot now be accommodated, at a total cost not to exceed \$8,000, and be it further

RESOLVED, that a portion of the three Dispatchers and the Community Service Aide PT salaries and fringe benefits be charged to the AAA Transit grant for the current grant period, and be it further

RESOLVED, that the budget for the AAA Transit grant, 163AAATRAN0607 be revised as follows:
