WHEREAS, the State of New York on January 1, 2007 raised the minimum wage to \$7.15; and

WHEREAS, the County must compete for these monitors with other Civil Service Authorities such as the State of New York and the City of Buffalo; and

WHEREAS, other Civil Service authorities pay a higher rate ranging between \$10 and \$11 per hour; and

WHEREAS, when the County is unable to procure sufficient monitors, it must bring in County employees to administer the exams, who in accordance with collective bargaining agreement are paid one and a half times their hourly rate; and

WHEREAS, using county employees at time and a half can cost anywhere between \$20 and \$60 per hour; and

WHEREAS, it would be substantially more cost effective to utilize less expensive monitors; and

WHEREAS, the civil service monitors have not received a pay raise since 1999.

RESOLVED, that effective for 2007, the new rate for monitors administering civil exams will be \$10 per hour and that hall monitors be paid \$8.00 per hour; and be it further

WHEREAS, the County of Erie desires to advance the Project by making a commitment of 100% of the non-Federal share of the costs of the Preliminary Engineering stage (Design Phases I-VI) of the Project, PIN 5756.87, and

WHEREAS, the NYSDOT initially programmed only a portion of the funds required for the Project and is now able to fully fund the Preliminary Engineering stage (Design Phases I-VI) of the Project, and

WHEREAS, the funds required have increased from \$70,000 to \$153,000, proportionally increasing the local share to \$30,600, and

WHEREAS, FRA Engineers was authorized to perform Design Services for this project by County Resolution 25E-15 on February 24, 2003.

NOW, THEREFORE, BE IT

WHEREAS, in order to make the Project economically feasible for Southwind Landing Apartments, L.P. to operate the apartment complex, it is necessary to obtain tax relief from the County of Erie and the Town of Cheektowaga.

WHEREAS, PPTS, now doing business as XSPAND [PPTS/XSPAND"], and American Tax Holding, LLC ["ATH"] each submitted timely written responsive proposals to said RFP; and

WHEREAS, due to this low reimbursement rate counties are forced to dig into their already financially strapped coffers to pay for something that the state should actually pay for, and

WHEREAS, In 2005 Erie County billed for 6,757 days for state ready prisoners to the State of New York, resulting in an unfunded state mandate negatively impacting Erie County in the total amount of \$547,317, and

WHEREAS, if this legislation was enacted into law, county governments would be reimbursed for the actual cost of housing state ready prisoners when an inmate has not been accepted by the Commissioner of the State Department of Correctional Services within five days of receipt of written notification, and
