COUNTY OF ERIE LOCAL LAW INTRO NO. 4- 2007 LOCAL LAW NO. \_\_\_\_\_- 2007

A **LOCAL LAW** entitled The Energy Efficient Products Act which mandates that Erie County only purchase electrical products that are Energy Star rated.

BE IT ENACTED BY THE LEGISLATURE OF THE COUNTY OF ERIE AS FOLLOWS:

## **SECTION 1. Findings and Purpose**

- (A) FINDINGS—The Erie County Legislature finds that:
- 1. The cost of energy is skyrocketing and will likely continue to increase, as such, Erie County's energy bills will continue to increase.
- 2. Energy use by municipalities contributes substantially to the problems of pollution and global climate change.
- 3. Energy costs can be reduced by purchasing energy efficient air conditioning, lights and electrical appliances.
- (B) PURPOSE—This law is enacted to more efficiently spend public funds and protect the health and welfare of Erie County residents.

## **SECTION 2. Definitions**

DEFINITIONS. In this section,

- 1. "Erie County" means every County office, board, commission, committee, bureau, department or public institution of higher education.
- 2. "Energy Star products" means products that are certified by the United States Department of Energy or the United States Environmental Protection Agency as Energy Star or that are certified under the Federal Energy Management Program.

## **SECTION 3. Procurement Standards**

- 1. Erie County shall purchase Energy Star products when such products are available. The County may include non-Energy Star rated equipment as an alternate in the bid documents to enable lifecycle costing analysis to be performed as part of the analysis of responsive bids. The County shall be required to award a contract that includes the procurement of Energy Star rated equipment unless the agency can demonstrate, in writing, that the interests of the County would be better served by procuring non-Energy Star rated equipment.
- 2. Prior to initiating a request for procurement of any product, an agency shall review the specifications for such product to determine whether an Energy Star product is available. If an Energy Star product is available, the agency is required to include in its bid specifications the requirement that the product be an Energy Star product unless the agency can demonstrate, in writing, to the satisfaction of the agency head, that a product with an Energy Star rating meets at least 1 of the following criteria:
- (a) The product is not available competitively.
- (b) The product is not available within a reasonable time frame, or
- (c) The product does not meet appropriate performance standards.

**SECTION 4.** If any article, section, subsection, paragraph, phrase or sentence of this local law is for any reason held invalid or unconstitutional by any court of competent jurisdiction, that portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portion hereof.

**SECTION 5.** This local law shall take effect immediately in accordance with the provisions of the Municipal Home Rule Law.

# COUNTY OF ERIE LOCAL LAW INTRO NO. 5- 2007 LOCAL LAW NO. - 2007

A LOCAL LAW entitled The Green Buildings Act which adopts LEED standards for the construction or renovation of buildings owned by Erie County.

BE IT ENACTED BY THE LEGISLATURE OF THE COUNTY OF ERIE AS FOLLOWS:

## **SECTION 1. Findings and Purpose**

FINDINGS—The Erie County Legislature finds that:

- 1. Energy costs for public buildings are skyrocketing and will likely continue to increase.
- 2. Energy use by public buildings contributes substantially to the problems of pollution and global climate change.
- 3. Public buildings can be built and renovated using high-performance methods that save energy costs, preserve the environment, and make workers and students safer and more productive.
- (B) PURPOSE—This law is enacted to more efficiently spend public funds and protect the health and welfare of Erie County residents.

## **SECTION 2. Definitions**

DEFINITIONS—In this section:

- 1. "LEED silver standard" means the United States Green Building Council Leadership in Energy and Environmental Design green building rating standard referred to as silver standard.
- 2. "Major facility project" means:

a. A building construction project larger than 2,500 gross square feet of occupied or conditioned

space; or

b. A building renovation project when the cost is greater than 50 percent of the assessed value and

the project is larger than 2,500 gross square feet of occupied or conditioned space.

3. "Erie County" means every County office, board, commission, committee, bureau, department or

public institution of higher education.

**SECTION 3.** 

**GREEN BUILDING STANDARDS** 

All major facility projects of Erie County shall be designed, constructed and certified to at least the

LEED silver standard. This provision applies to major facility projects that have not entered the

design phase prior to , 2007

**SECTION 4.** If any article, section, subsection, paragraph, phrase or sentence of this local law is

for any reason held invalid or unconstitutional by any court of competent jurisdiction, that portion

shall be deemed a separate distinct, and independent provision and such holding shall not affect the

validity of the remaining portion hereof.

**SECTION 5.** This local law shall take effect immediately in accordance with the provisions of the

Municipal Home Rule Law.

# COUNTY OF ERIE LOCAL LAW INTRO NO. 6- 2007 LOCAL LAW NO. - 2007

A LOCAL LAW, amending Local Law No. 12-1974 known as the "Erie County Hotel Occupancy Tax Law":

BE IT ENACTED BY THE ERIE COUNTY LEGISLATURE AS FOLLOWS:

Section 1: LEGISLATIVE INTENT

The purpose of this Local Law is to amend Local Law No. 12-1974 known as the "Erie County Hotel Occupancy Tax Law":

This change would <u>add</u> a new Subdivision C of Section 21 to clarify the intent of the confidentiality provisions set forth in Subdivision B of Section 21. This amendment will clarify that the confidentiality provisions of Subdivision B will only be honored so long as any Person or Operator subject to the reporting, filing and payment provisions of the Hotel Occupancy Tax Law is in compliance with the Hotel Occupancy Tax Law's reporting, filing and payment requirements.

#### Section 2: AMENDMENT TO ERIE COUNTY LOCAL LAW 12-1974:

#### **NEW SUBDIVISION C OF SECTION 21**

(c) In the event that any Person or Operator fails to timely and accurately file a Return and/or collect and remit the tax due and owing to the County, and/or fail(s) to adhere to the terms and conditions of any agreement said party enters into with the County for the payment of taxes due hereunder, the restriction on county officers and employees contained in subdivision (b) of this section compelling them to keep certain information secret shall be lifted. Only authorized officers or employees of the Office of Comptroller, Division of Budget and Management, Division of Real Property Tax, and/or Department of Law are permitted to release limited identifying information regarding the delinquency, including, but not limited to, an Operator, Person or taxpayer's name, including the names of the principals of said Operator and/or taxpayer, and the amount of the delinquency.

Section 3: EFFECTIVE DATE

Immediately.

Section 4: SEVERABILITY

If any clause, sentence, paragraph, subdivision, section or part of this Local Law or the application thereof, to any person, individual, corporation, firm, partnership, entity or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order of judgment shall not affect, impair, or invalidate the remainder thereof, and shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part of this Local Law or its application to the person, individual, corporation, firm, partnership, entity, or circumstances directly involved in the controversy in which such judgment or order shall be rendered.

RE: Medicaid Sales Tax Intercept Review and Request for Further State Medicaid Relief (INTRO 14-4)

A RESOLUTION SUBMITTED BY LEGISLATORS LOCKLEAR, MARINELLI, WHYTE & MAZUR

WHEREAS, the 2005 "Medicaid Cap Legislation" enacted by the State Legislature provides a "one-time" option to New York State Counties as an alternative to paying its local share of Medicaid to the state as an annual expense under the Medicaid Cap regime; and

WHEREAS, under this option, if a county elects to swap Medicaid payments for a Sales Tax Intercept, the state will keep a fixed portion (which, based on a complicated formula instituted by the State will, for Erie County be 1.4% of its sales tax revenues), and give the rest back to the county. In turn, the County would no longer make *any* Medicaid payments to the State; and

WHEREAS, the State has put severe limitations and consequences on the Sales Tax Intercept. Once made, the election to opt into the Sales Tax Intercept <u>cannot be rescinded</u>. The "window of opportunity" for evaluating this option and making the election is limited. Counties which determine to elect this option must do so by legislative adoption of a statutorily proscribed resolution which must be received by the NYS Department of Health <u>no later than September 30</u>, <u>2007</u>. Once that date has expired, <u>the option is no longer available</u>; and

WHEREAS, mindful of the severity of these consequences the Legislature has, through its Health Committee undertaken a detailed review of the financial and economic impacts and forecasts of the impact of the Sales Tax Intercept vs. the known results under the Medicaid Cap; and

WHEREAS, this detailed review has been in collaboration with the Administration's Budget Director, the Comptroller's Office and the Erie County Fiscal Stability Authority; and

WHEREAS, the analysis provided to the Legislature from the Administration's Budget Director had been based on that Department's intensive work with the State's Department of Taxation and Finance and the State's Department of Health; and

WHEREAS, the Budget Director has also been in close collaboration with peer professionals throughout the State and with the New York State Association of Counties; and

WHEREAS, this intensive deliberation has focused on several factors including:

- 1. The knowledge that this option is most beneficial to counties whose annual rate sales tax growth is at or under 2.7%;
- 2. That this option penalizes counties whose annual rate of sales tax growth approaches or exceeds 3%;
- 3. Data showing that Erie County's own trends in sales tax growth are tending toward 3% and higher;
- 4. The highly speculative nature of making the Election; and then the questionable result of "hoping" for moribund economic development and sales tax growth to stay under the 2.7% threshold:
- 5. The escalating costs of Medicaid and the fact that even under the Cap, the County's share for Medicaid will increase by over \$5 Million each year; and will have increased by over 27% over the Base Year of 2005 by 2014; and
- 6. The irrevocable nature of the election; and

WHEREAS, in the course of our investigation we also learned of payment cycle disparities between the Counties of New York State and the State Department of Health which have an adverse effect on the Counties cash flow.

NOW THEREFORE BE IT

RESOLVED, this Honorable Body does hereby confirm its decision to remain under the Medicaid Cap regime; and be it further

RESOLVED, that this Honorable Body does hereby lobby our Western New York State Assembly and Senate leaders to change the counties' weekly payment dates for Medicaid from Wednesday to Tuesday, which change will facilitate the management by all New York State counties of Medicaid expenses in years that have 53 payment cycles; and be it further

RESOLVED, that this Honorable Body further urges our State Assembly and Senate representatives to continue to work toward further and more effective legislation to truly "cap" the local share of Medicaid. # A RESOLUTION SUBMITTED BY LEGISLATORS KENNEDY, MARINELLI, WHYTE, LOCKLEAR, KONST, IANNELLO, REYNOLDS, MILLER-WILLIAMS, GRANT and KOZUB

WHEREAS, the Erie County Industrial Development Agency (ECIDA) is a public benefit corporation created in 1970 by an act of the New York State Legislature to promote and assist private sector business development; and

WHEREAS, the ECIDA's main mission is to create and advance job opportunities and advance the economic welfare of the people of Erie County; and

WHEREAS, it is well known that Erie and Niagara Counties have experienced flat or decreasing population levels for several decades; and

WHEREAS, Erie and Niagara Counties have suffered from scattered development that has resulted in residential and commercial development activity taking place on farm land, which resulted in a 28% decrease in the percentage of land used for farming; and

WHEREAS, this scattered development has lead to a disinvestment in urban areas, older suburban areas and town and village centers; and

WHEREAS, these development patterns have added to the cost of doing business in Erie County and have led to significantly higher operating costs for towns and villages throughout Erie and Niagara Counties, with no corresponding increase in services; and

WHEREAS, the elected leadership of Erie and Niagara Counties have been working together since 2002 to develop a regional growth plan; and

WHEREAS, a bi-County Steering Committee, comprised of 16 members began meeting in 2002 to discuss and develop a regional growth plan; and

WHEREAS, the Steering Committee developed a regional development plan entitled *A Framework for Regional Growth*; and

WHEREAS, the *Framework for Regional Growth* will serve as an important tool to inform County officials, development agencies, local governments, private developers and the citizenry when making development decisions within the region; and

WHEREAS, the Erie County Legislature recognizes the importance of regional development strategies and, after in-depth discussion, enacted, by a bi-partisan vote, the *Framework for Regional Growth* in an attempt to normalize the development patterns; and

WHEREAS, the ECIDA, as a leading development agency in Erie County, should approve the *Framework for Regional Growth*.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature believes that economic prosperity and recovery are linked to rational regional development strategies; and be it further

RESOLVED, that the Erie County Legislature recognizes the Erie County Development Agency as a key player in implementing regional development strategies and calls upon the Erie County Industrial Development Agency to adopt the *Framework for Regional Growth*; and be it further

RESOLVED, that the Erie County Legislature hereby invites the Erie County Industrial Development Agency to the next scheduled meeting of this Legislature's Economic Development Committee to discuss the implementation of the *Framework for Regional Growth*; and be it further

RESOLVED, that certified copies of this Resolution be sent to the Erie County Industrial Development Agency, each Industrial Development Agency in Erie County, Buffalo Niagara Partnership, the bi-County Steering Committee and the Western New York Chamber Alliance.

WHEREAS, an Intermunicipal Exchange Agreement (the "Agreement") was entered into on May 28, 2004, by and among the State of New York, the State University of New York, Frank Lloyd Wright's Rowing Boathouse Corporation ("FLWRBC") and the County of Erie (the "County") to facilitate the construction of a rowing boathouse in the City of Buffalo on the Niagara River in the immediate vicinity of the West Side Rowing Club; and

WHEREAS, pursuant to the Agreement the State of New York conveyed a parcel of Stateowned waterfront property to the County, which parcel was then leased to the FLWRBC to build the rowing boathouse; and

WHEREAS, among other things, the Agreement calls for the County to either provide the New York State Division of Military and Naval Affairs ("DMNA") with a replacement parcel of land and construct a motor vehicle storage facility or pay the State University of New York a sum of eight hundred thousand (\$800,000.00) dollars, as consideration for the State's conveyance of the parcel of property to the County; and

WHEREAS, to satisfy its obligations pursuant to the Agreement, the County desires to purchase a replacement parcel of land on which to construct a motor vehicle storage facility for DMNA; and

WHEREAS, 929 South Park Avenue, Buffalo, New York, is parcel of vacant land consisting of approximately 2.45 acres which is available to the County at a sale price of \$50,000.00; and

WHEREAS, the County Director of Real Property Services has reviewed the asking price of 929 South Park Avenue and determined that it is a fair price based on a review of comparable sales.

NOW, THEREFORE, BE IT

RESOLVED, that based on the Full Environmental Assessment Form completed by the Department of Environment and Planning with respect to the proposed action, the proposed action will not have a significant environmental impact and a Draft Environmental Impact Statement will not be prepared; and be it further

RESOLVED, that the Erie County Executive is authorized to enter into a contract with the owner(s) of 929 South Park Avenue, Buffalo, New York, subject to the review and approval of the County Attorney, for the purchase of the parcel of real property on which to construct a motor vehicle storage facility for DMNA for the sum of \$50,000.00, subject to the availability of funds pursuant to a Bond Resolution to be adopted later this year; and be it further

RESOLVED, that the County Attorney shall prepare all necessary legal documents for the purchase and acquisition of the property, including but not limited to a purchase contract that is acceptable to him; and be it further

RESOLVED, that certified copies of this resolution shall be forwarded to the Erie County Executive, County Attorney, Commissioner of Public Works, Division of Budget, Management and Finance, and the Office of the Comptroller.

WHEREAS, in a resolution, being Communication No. 9E-34, dated May 9, 2002, the Erie County Legislature authorized entering into a contract with Siemens Building Technologies, Inc. related to instituting a construction Performance Contract on the Erie Community College (ECC) campus buildings, and

WHEREAS, a preliminary energy audit of their facilities has been completed at these facilities and a program has been developed that meets with the Commissioner of Public Works' directives, and

WHEREAS, the total program's capital construction cost for the North and South Campuses without any reimbursements will be approximately \$4,818,630.00 with energy and other savings estimated at an average of approximately \$437,000.00 per year over the ten-year program, and

WHEREAS, the State (DASNY) will reimburse Erie County half of the construction value as approved at their May 31, 2007 meeting, or approximately \$2,409,315.00 and NYSERDA is expected to reimburse another almost \$77,796.00 for the program if implemented, and

WHEREAS, in a resolution being Communication No. 7E-27 dated April 19, 2007, the Erie County Legislature authorized various construction improvements at the ECC North and South Campuses with an estimated maximum cost of \$6,000,000.00 of which this work is a part, and

WHEREAS, by ECC Board resolution, ECC supports this project, and

WHEREAS, Erie County must take the lead on this project, however, as the County owns the facility and to qualify for the State (DASNY) matching funds, and

WHEREAS, the Commissioner of the Department of Public Works recommends acceptance of the program and that the construction be implemented,

NOW, THEREFORE, BE IT,

RESOLVED, that the Erie County Legislature authorizes the County Executive to execute a Supplemental Agreement to the County's Performance Contractor, Siemens Building Technologies, Inc., in an amount not to exceed \$4,743,630.00 to perform the Energy Conservation Measures

Program derived from their preliminary energy audit work to be charged to an SAP account to be established by the Comptroller's Office in accordance with the resolution of April 19, 2007, being Communication No. 7E-27 and approximately \$75,000.00 annually over the ten-year program for the Technical Services Program contingent upon the execution of an MOU between Erie County and ECC for reimbursement of the Technical Services Program, and be it further,

RESOLVED, that the Erie County Legislature authorizes the County Executive to execute a Supplemental Agreement with C.J. Brown Energy, P.C. in an amount not to exceed \$75,000.00 to perform program review and construction review of the work, and be it further,
