## LOCAL LAW No. \_\_\_\_ LOCAL LAW INTRO. No. \_11\_

A LOCAL LAW in relation to support of the Buffalo and Erie County Public Library.

BE IT ENACTED BY THE LEGISLATURE OF ERIE COUNTY AS FOLLOWS:

## Section 1.

Erie County Local Law Number One of nineteen hundred fifty-nine, constituting the Erie County Charter, as amended, is amended by amending section sixteen hundred twelve thereto to read as follows:

1612. Support of Public Libraries.

- a. A portion of the annual real property tax shall be annually levied and collected for library purposes, and shall be separately set out on the real property tax notices as the "amount for library purposes." The entire amount of funds allocated in the general budget for library purposes shall be available to the Buffalo and Erie County Public Library, and shall not be subject to withholding, modification, or reduction by the County after adoption of the annual Erie County budget, consistent with library powers in section two hundred fifty-nine of the education law, except that the trustees of the Buffalo and Erie County Public Library shall not authorize, without the prior approval of the County Legislature, the transfer of any appropriation from one branch or contract library to another which would necessitate the closing of any branch or contract library.
- b. The Erie County Legislature shall, by majority vote, annually determine the amount to be raised for the Buffalo and Erie County Public Library under this section. Such amount shall not exceed the anticipated county share of the Buffalo and Erie County Public Library expenses adopted in the annual Erie County budget.

## Section 2.

This local law shall be construed to be in all respects consistent with chapter seven hundred sixty-eight of the laws of nineteen hundred fifty-three and not to alter any provision of that statute, but to carry out the purposes and intent of that statute.

## Section 3.

This local law shall be effective January first, the year two thousand ought seven upon adoption by a two-thirds majority of the Legislature, or, if adopted by a simple majority, this local law shall be effective immediately following approval by the electors of the County at the next general election of state or county government officers held not less than sixty days following the adoption of this local law.

This Lease is made and entered into effective as of January 1, 2007 by and between W. J. Milligan of 4751 Southwestern Blvd, Hamburg, New York 14075, referred to as the "Landlord", and the County of Erie, 95 Franklin Street, Buffalo, New York 14202, hereinafter referred to as the "Tenant".

#### Witness, that

Whereas, Landlord is the owner of a duly licensed public/ private airport, including hangar and landing areas, known as Evans Airways and located at 7941 Versailles Plank Road, Angola, New York 14006.

Whereas, Landlord desires to let Tenant and Tenant desires to hire from Landlord, on an exclusive basis the building identified as Hangar No. 1 hereinafter referred to as the "Premises" which includes the landing area, heliport pad, and shared landing strip.

#### IT IS THEREFORE AGREED:

- Landlord hereby leases, and grants the exclusive right to use the Premises to the Tenant, i.e. Hangar and Paved Landing Pad.
- 2. The term of this Lease will be two years, commencing on January 1, 2007, and ending on December 31, 2008 (the "Term"). There shall be three (3) options to renew the Term upon the written consent of the parties and approval by the Erie County Legislature.

- 3. As of the commencement of the Term, Tenant accepts the Premises in the Premises' existing condition and acknowledges that Landlord has made no representation or warranty concerning the condition other than the condition of the Hangar. In no event, shall Landlord be liable for any defect in the Premises or limitation on its use so long as Premises may still be used for its intended purpose.
- 4. Tenant may use the Premises to conduct normal helicopter operations, including helicopter maintenance, by the Erie County Sheriff's Office, its employees and other employees or contractors of the Tenant.
- 5. Tenant shall pay to Landlord as rent during the Term, the amount of Eighteen Thousand Dollars (\$18,000.00) in 2007, and Nineteen Thousand Dollars (\$19,000.00) in 2008, as annual rent. If the Term is extended, the annual rent shall be as follows: for the year 2009, Twenty-One Thousand Dollars (\$21,000.00), for the year 2010, Twenty-Two Thousand Dollars (\$22,000.00), and for the year 2011, Twenty-Three Thousand Dollars (\$23,000.00). The rent shall be payable to the Landlord at the address stated above or at such other place as Landlord may designate in writing. One-half or fifty percent (50%) of the rent shall be payable by February 1<sup>st</sup> of each year of the Lease, and the remaining 50% by July 1<sup>st</sup> of each year of the Lease. If the rent is not received by the fifteenth (15<sup>th</sup>) of the month due, a penalty of Five Hundred Dollars (\$500.00) will be assessed to that payment and an additional One Hundred Dollars (\$100.00) per month until the payment is received.
- 6. Landlord shall pay all real estate taxes, general and special assessments assessed against the Airport during the Term.
- 7. Landlord shall provide snow removal and lawn care service. Landlord shall also pay natural gas, electric and water utility charges incurred at the Hangar during the Term, provided that Tenant shall use its best efforts to manage utility consumption and not commit waste with regard to

utility consumption. If Tenant is wasteful with regard to utility consumption, Tenant shall pay those portions of the utility charges reasonably attributable to its wasteful consumption. Landlord shall not be liable for any interruption or delay, if any, of the above services for any reason.

- 8. Landlord shall perform all maintenance and repairs to the Premises during the Term, including all needed maintenance and repairs of all heating systems: hot water tank, interior and exterior lighting, overhead door and door lift. Tenant shall keep the Premises in neat and orderly condition, and at the end of the Term, shall surrender the Premises in as good a condition as they were at the beginning of the Term, except for wear and tear caused by reasonable use consistent with the provisions of the Lease.
- 9. During the Term, Tenant may make leasehold improvements, alterations and additions to the Premises, but only with Landlord's prior written consent. Any leasehold improvement made by Tenant may, at upon mutual agreement, become the property of the Landlord upon the termination of this Lease; provided, however, that Landlord shall have the right to require Tenant to remove any fixtures installed by Tenant, at Tenant's sole risk and expense, upon the termination of this Lease.
- 10. In its use and occupation of the Premises, Tenant shall fully comply with all Federal, State and Local laws, rules, ordinances and regulations, including those relating to the use, maintenance, removal and disposal of the Fuel Cell.
- 11. Tenant shall indemnify, defend and hold the Landlord, its officers, directors, shareholders, and employees, harmless with regard to any and all losses, claims, demands, actions or other proceedings, including, but not limited to, claims for personal injury or wrongful death; whether brought by third parties or employees of Tenant, claims for property damage; including damage to the Premises, and claims for damage to the environment arising out of or resulting from the use or occupation of the Premises by Tenant or the use, maintenance or removal of the Fuel Cell

at or from the Premises. Landlord shall not be responsible for the loss of or damage to property or injury to persons, occurring at or about the Premises by reason of existing or future condition, defect, matter or thing in or at the Premises or the property of which the Premises are a part, or for the facts, actions, omissions or negligence or other persons at or about the Premises or the property of which the Premises are a part.

- 12. Landlord shall indemnify, defend and hold harmless the Tenant, its officers and employees, with regard to any and all losses, claims, demands, actions or other proceedings, including, but not limited to, claims for personal injury or wrongful death, whether brought by third parties or employees or either Landlord or Tenant, and claims for property damage, arising out of or resulting from the use or occupation of the Premises to the extent that such losses, claims, etc., are caused by the negligence or other culpable conduct of Landlord or its officers, agents, servants or employees. Landlord's obligation to defend Tenant shall be fulfilled by counsel reasonably satisfactory to, and approved by, Tenant.
- 13. Neither this Lease nor any interest therein shall be assigned, mortgaged, sublet or otherwise encumbered or disposed of by Tenant without the prior written consent of Landlord.
- 14. The happening of any one or more of the following events shall constitute an event of default ("Default") under this Lease:
- (a) The failure to make a rental payment when due, which failure continues for a period of ten (10) days;
- (b) The failure to comply with any other term or requirement of this Lease, which failure continued for a period of ten (10) days after written notice of such failure from Landlord to Tenant; or
- (c) A levy upon or taking of the leasehold interest created by this Lease in execution, attachment or other process of law. In the event of Default, Landlord may, at any time

thereafter, terminate this Lease by giving thirty (30) days written notice, specifying the Default and the effective date of termination, to Tenant. Upon such termination, this Lease and all rights of the Tenant hereunder shall terminate and Tenant shall peaceably surrender the Premises to Landlord. No termination of this Lease shall relieve Tenant of Tenant's liabilities and obligations hereunder and such liabilities and obligations shall survive any termination. In the event of termination, whether or not the Premises or any portion or part thereof have been relet, Tenant shall pay Landlord the rent required to have been paid up until the time of termination. Thereafter, Tenant, until the end of what would have been the Term absent termination, shall pay the Landlord the amount of rent which would be payable hereunder, less the net proceeds, if any, to Landlord of reletting.

- 15. Any notice under this Lease shall be in writing and delivered to Landlord or Tenant, as the case may be, at the address of that party state above, or any address subsequently provided by such party in writing as its address for notices, in one of the following ways:
  - (a) By personal service;
  - (b) By Certified Mail, return recipe requested;
- (c) By any nationally recognized courier service which provides written evidence of delivery.

Such notice shall be deemed to be effective upon receipt, regardless of the method of delivery.

16. No waiver of any right of Landlord hereunder with respect to a particular action or failure to Tenant shall be deemed or construed to be a waiver of such rights with respect to other future actions or failures of Tenant.

- 17. In the event that Tenant shall remain in possession of the Premises beyond the termination of the Term, Tenant shall pay for each month of continued possession, or any part thereof, one-twelfth of the yearly rent plus ten percent (10%) as outlined in paragraph five (5) above.
- 18. This Lease is intended and shall be deemed to be the complete statement of the term of the agreement between the parties and may only be amended by a writing executed by both the Landlord and Tenant.
- 19. The Fuel System (tank/pump) supplied by the Tenant, shall remain the property of the Tenant, at the conclusion of the Lease, and may be removed by the Tenant at their option, at the termination of the Lease. The Tenant shall be responsible for maintenance, required inspections by Federal and local law ordinances and indemnify the Landlord from any all liabilities.
- 20. This Agreement shall be deemed executory only to the extent of moneys available to the County for the performance of the terms hereof and appropriated hereto by the Erie County Legislature, now or in the future, and no liability on account thereof shall be incurred by the County beyond such moneys.
