RESOLUTION NO. 313

RE: 2007 Capital Borrowing (COMM. 27E-2)

WHEREAS, in 2006 and 2007, the Erie County Legislature duly adopted bond resolutions for the issuance of general obligation debt to fund certain County and related capital projects, and

WHEREAS, pursuant to § 3959 (2) (i) of the Erie County Fiscal Stability Act, the County cannot issue debt without the approval of the Erie County Fiscal Stability Authority, and

WHEREAS, on November 2, 2007, the authority rejected the County's request to issue such debt and reasserted its desire to issue such debt on behalf of the County, and

WHEREAS, on November 29, 2007, the Erie County Legislature formally voted 11-4 to reject any such borrowing by the Erie County Fiscal Stability Authority, and

WHEREAS, for several months, in an attempt to resolve the borrowing issue, the Erie County Comptroller has been in discussions and negotiations with the Erie County Fiscal Stability Authority, facilitated by the office of New York State Governor Eliot Spitzer and the New York State Division of Budget, and

WHEREAS, the parties have arrived at a compromise in which the authority will issue sales tax revenue bond debt in an amount not to exceed \$51,930,000 on behalf of the County and on the same day, the County will issue general obligation mirror bond debt in the same amount to the authority, and

WHEREAS, under the terms of the transaction, as laid-out in a separate written communication provided to your Honorable Body and myself by the Erie County Comptroller, once the County attains two (2) ratings in the "A" category from nationally recognized ratings agencies, the authority's bonds will be defeased and the authority's bondholders will receive the County's bonds in exchange, with the bondholders then no longer owning authority bonds, but County bonds, and

WHEREAS, this mechanism ensures that the authority cannot perpetuate its existence for the life of its bonds if the County continues its ongoing financial recovery, and

WHEREAS, this proposal has the support of myself, the County Comptroller, and the Erie County Fiscal Stability Authority.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature does hereby express its support for this compromise in which the Erie County Fiscal Stability Authority will issue sales tax revenue bond debt in an amount not to exceed \$51,930,000 on behalf of the County and on the same day, the County will issue general obligation mirror bond debt in the same amount to the Erie County Fiscal Stability Authority, and be it further

RESOLVED, that through this transaction, the County's 2007 capital program will be facilitated and urgent County capital needs satisfied through these bond proceeds, and be it further

RESOLVED, that the Erie County Fiscal Stability Authority is hereby authorized to issue sales tax revenue bond debt in an amount not to exceed \$51,930,000 on behalf of the County, and the Erie County Comptroller is hereby authorized to, on the same day, issue general obligation mirror bond debt in the same amount to the Erie County Fiscal Stability Authority, and be it further

RESOLVED, that certified copies of this resolution be transmitted to the Erie County Executive, Erie County Comptroller, Erie County Fiscal Stability Authority, Director of Budget and Management, County Attorney, New York State Governor and New York State Comptroller.
