WHEREAS, pursuant to Agriculture and Markets Law Section 303-a(2)(b) the Erie County Agricultural and Farmland Protection Board reviewed the district, prepared a report to the Erie County Legislature and voted unanimously on December 5, 2011to recommended that the district be continued without modification; and

WHEREAS, the district has been reviewed in accordance with the New York State Environmental Quality Review Act of 1975 and adopted review procedures and the criteria set forth in Part 617; and

WHEREAS, it has been determined that the continuation of the district will not have a significant effect on the environment.

Wheelchair Capability for the

Department of Senior Services Going Places Transportation Program (COMM. 1E-33)

WHEREAS, the Department of Senior Services (Department) has applied for and been awarded, by the New York State Department of Transportation (NYSDOT), Federal Transit Administration Section 5310 Program funding for the purchase of a new vehicle with wheelchair capability for the Department's Going Places Transportation Program; and

WHEREAS, the vehicle will provide transportation to ten additional frail elderly clients daily and 2,500 additional annual one way passenger trips to medical, nutrition services, socialization and group recreational activities; and

WHEREAS, terms of the agreement with NYSDOT require the Department to provide a 20% (\$8,516) local match towards the vehicle purchase price, with NYSDOT using Federal funds for the remaining 80% (\$34,064) of the vehicle purchase price; and

WHEREAS the Department is required, on or before February 1, 2012, to deposit the 20% local share monies into a Bank of America bank account from which NYSDOT will take the monies to buy the vehicle from a New York State purchasing contract and subsequently deliver the vehicle to the Department in late spring 2012; and

WHEREAS, the Department proposes to use local revenues, collected from the Independent Health Association (IHA) for wrapping existing Going Places vans with IHA advertising, to fund the 20% local share; and

WHEREAS, 2012 IHA revenue for the wrapping of the vans is currently budgeted for in the Areawide Agency of Aging (163III-B2012) grant, account #466330, Other Local Match, in the amount of \$57,000; and

WHEREAS, for the year 2012, IHA has actually agreed to pay the Department \$60,800 for wrapping the vans, \$3,800 more than the current budget amount; and

WHEREAS, the Department proposes to use this additional \$3,800 of revenue to fund part of the 20% local share, with the remaining \$4,716 of local share to be obtained by reductions in various appropriation accounts, initially intended to be funded out of the IHA van wrapping revenues, in the Areawide Agency of Aging (163III-B2012) grant; and

WHEREAS, the Areawide Agency of Aging (163III-B2012) grant budget is in need of revision.

- (d) For the period beginning March 1, [2011] 2012, and ending February [29, 2012] 28, 2013, the provision for credit or refund described in subdivision (d) of Section 1119 of the New York Tax Law, relating to Qualified Empire Zones Enterprises, shall apply to the taxes imposed by this enactment.
- Section 2. This resolution shall take effect March 1, 2012, and shall apply to sales made, services rendered and uses occurring during the period March 1, 2012, through February 28, 2013, in accordance with the applicable transitional provisions in sections 1106, 1216 and 1217 of the New York Tax Law.
