Re: Veto Message – 2013 Budget Amendments

Dear Honorable Members:

On December 4, 2012, your Honorable Body approved Comm. 18E-3 as amended (the 2013 Budget"), and the certified resolution was transmitted to my office on December 5, 2012. As amended, six legislators approved a budget amendment that allegedly reduced appropriations by \$8,514,324. For a variety of reasons described in my letter to the Legislature dated November 28, 2012, these amendments will create a multi-million dollar budget gap in the 2013 Budget. As you are aware, the Erie County Fiscal Stability Authority and the County Comptroller also shares these concerns.

Although I cut \$20 million from the budget prior to its submission to the Legislature, it will in all likelihood be necessary to make additional real spending cuts to balance the 2013 Budget. As

the County's Chief Budget Officer, I am now required to implement strict austerity measures throughout the government and to make cuts that will bring the budget back into balance. Let me be clear: all options are on the table for addressing the budget gap created by the adopted as amended 2013 Budget.

In addition to the purported cuts, the amended 2013 Budget also includes a combined \$195,134 in additional spending in the Office of the Comptroller (Director of Grant Accounting Services), County Clerk-Registrar (overtime), Cultural Agencies (Amherst Symphony Orchestra) and Youth Bureau (Operation Prime Time). Section 2508(c) of the Erie County Charter ("Charter") states the following concerning legislative additions to the Executive Recommended Budget:

The county executive may object to any one or more of such added or increased items, and in such case shall append to the budget a statement of the added or increased items to which he or she objects with the reasons for his or her objections, and shall return the budget with his or her objections to the clerk of the county Legislature who shall present the same to the county Legislature on or before the Monday preceding the second Tuesday in December.

Pursuant to my authority under Section 2508(c) of the Charter, I hereby veto the \$195,134 in additional spending as more specifically identified in the attached six appendices.

I am not against all of the proposed additions *per se*. However, because of the unreasonable budget amendments made by six legislators purporting to cut spending in eight accounts, I am forced to address a major structural imbalance in the 2013 Budget. In light of such drastic amendments I cannot support additional spending. I believe that your Honorable Body should support the vetoes and I urge you to do so.

In addition, please be advised that my administration is conducting a legal review of all amendments passed by the Legislature for their adherence to state and county law and the Charter and we reserve the right to exercise any and all options that may be available to this administration.

It is my hope that your Honorable Body will work with me and my administration to bring the 2013 Budget back into balance with reasonable and real spending reductions in order to offset the financial gimmicks passed last week.
