WHEREAS, the United States Department of Energy and the New York Independent System Operator have identified New York State electric transmission lines as being aged and unable to deliver adequate capacity, a condition known as "transmission congestion;" and

WHEREAS, there is a growing demand for electricity in the New York City area, but because of the inadequate transmission system in New York State, specifically the "choke points" for electrical transmission from Utica going east, and Albany going south, plants in Upstate New York that have abundant available power, NRG Huntley included among them, cannot get their product to this demand market; and

WHEREAS, there are a number of reasons why importing power is bad for New York State, not the least of which are the lost opportunity for our WNY power generation facilities having the ability to compete and retain good paying jobs; New York State losing its fuel diversity and energy independence, placing us at the mercy of supply and demand price spikes; and the abandonment of renewable energy projects that could create a significant number of green jobs; and

WHEREAS, several plants in Upstate New York are facing uncertain economic futures and the owners of one facility have put that facility up for sale because of its inability to compete; and WHEREAS, the ability to move abundant, available power from these plants in Western New York to the downstate area would have a positive effect on these struggling facilities, saving hundreds of jobs, and significant tax base for all of WNY; and

WHEREAS, tens of thousands of jobs in transmission construction and power generation, including renewable energy, will occur from investing in New York State's energy infrastructure.

RESOLVED, that the Erie County Legislature goes on record requesting that the State of New York make needed investment in upgrading of New York State's electric transmission line infrastructure by using existing mechanisms for funding transmission upgrades that would hold the ratepayers harmless, and will go a long way in stabilization employment at existing power plants, while creating enormous opportunities in renewable energy development; and be it further

WHEREAS, there does not appear to be a huge outcry from the public demanding the addition of a New York State Senate seat, yet the chorus supporting smaller government grows more vocal with each passing year; and

WHEREAS, the Erie County Legislature undertook not one, but two, downsizing efforts during the last decade, and successfully implemented both – a downsizing from 17 seats to 15 seats in 2002, and again a downsizing from 15 seats to 11 seats effective 2012; and

WHEREAS, it would be fitting for New York State to consider the downsizing efforts at both the county and federal levels as a lesson in 21st century civics and the direction the taxpaying public wants government to head in for the foreseeable future.

WHEREAS, New York State Transit Operating Assistance to the NFTA has been reduced six separate times from 2009 to 2011, and this reduction in state subsidy now totals \$4.3 million; and

WHEREAS, the NFTA also has experienced delays in receipt of its state transit operating assistance, further compounding a difficult financial situation; and

WHEREAS, an additional pool of state funds supporting critical safety projects and the Metro Light Rail Rapid Transit Railcar Rebuild has not been released since fiscal year 2008, and the cumulative total of these funds is \$11 million through fiscal year 2011; and

WHEREAS, annual Federal Transit Administration assistance has remained nearly flat since 2009, despite the NFTA's rising costs of maintaining an aging transit system; and

WHEREAS, both Erie and Niagara Counties provide 18B funding to the NFTA, and this funding is matched by New York State; and

WHEREAS, Erie and Niagara Counties provide the NFTA with another source of revenue – the Mortgage Recording Tax; and

WHEREAS, from Erie County alone, this source of revenue for the NFTA has decreased by \$2.1 million, and by a comparable percentage from Niagara County, since the nation's economic downturn in 2008; and

WHEREAS, on the expense side of the NFTA's budget equation, there have been increases of 35% in workers compensation, 16% in health insurance and 12% in maintenance and repair costs; and

WHEREAS, in addition to the streams of revenue cited above, Erie County also distributes a 1/8 of 1% share of its county sales tax to the NFTA for operating costs; and

WHEREAS, the fiscal dilemma facing the NFTA has occasioned numerous cost containment measures, including administrative streamlining that has saved \$20 million, fuel hedging that has

saved over \$3 million, energy audits that have saved over \$900,000, utility and telecommunications audits that have saved over \$216,000, new internal control guidelines that fully comply with the federal Sarbanes-Oxley Act of 2002, and enterprise resource planning that has resulted in increased efficiency and automatic scheduling of preventative maintenance, as well as other cost-containment initiatives; and

WHEREAS, the NFTA has taken every possible cost-saving step to limit any negative impact on the customers of Metro Rail and Bus, yet deep service cuts and fare increases are on the horizon; and

WHEREAS, the NFTA's financial challenges call for a robust regional response, including the exploration of additional revenue from previously untapped sources; and

WHEREAS, one such source lies in Niagara County directing a share of its sales tax to the NFTA.

NOW, THEREFORE, BE IT

RESOLVED, that this Honorable Body request the Honorable Members of the Niagara County Legislature to step forward and assist our region's transportation system by distributing a portion of its sales tax to the Niagara Frontier Transportation Authority; and be it further

WHEREAS, the local program will achieve three outcomes: 1) to make heating costs more affordable, leaving families with greater financial resources to provide for themselves; 2) to enable individuals and families to live in a more comfortable indoor environment throughout the winter; and, 3) to impart skills that can be utilized for immediate job placement in energy conservation and later transferrable to private sector job opportunities in housing rehabilitation; and

WHEREAS, the skilled jobs to be created by the "green energy" improvements PUSH will provide to these homeowners will be compensated by wages that can support a family, further providing a positive economic impact well beyond the initial family participating in the program; and

WHEREAS, PUSH estimates that homeowners will be able to save 20% or 30% on their utility bills; and

WHEREAS, the program start date is January 30, 2012 and homeowners begin the process by accessing a free energy audit; and

WHEREAS, if the energy audit calculations reach a threshold whereby the work will eventually pay for itself, the family becomes eligible for a retrofit through low-rate financing of 2.9 percent that will be added onto utility bills; and

WHEREAS, the low-interest loan program is available only through utilities that combine gas and electric, such as National Grid, but is not limited to low-income individuals; and

WHEREAS, the "community jobs pipeline" and job training opportunities afforded by this new program will prepare individuals in our community for higher-paying jobs and will open up a new market for women and minority contractors.

WHEREAS, the far greater number of tickets the Buffalo Bills must sell in order to sell out 72 hours before a game, thereby ensuring local broadcast of that game, is far more challenging to our NFL franchise than most other NFL franchises, given the smaller seating capacity of their stadiums relative to the size of Ralph Wilson Stadium; and

WHEREAS, this archaic rule has not kept up with advances in technology and changes in economics whereby the NFL teams realize more of their revenues from television and merchandizing revenues than from ticket sales; and

WHEREAS, the blackout rule reduces the number of Buffalo Bills game viewing parties in the community – particularly in the homes of Bills fans – and reduces the positive economic impact of increased sales of food, beverage and party supplies that retailers experience when a Buffalo Bills game is televised locally; and

WHEREAS, that suppressed economic activity has a negative impact on the sales tax revenues that accrue to county government to do such things as maintain Ralph Wilson Stadium, which is required by the current lease between Erie County and the Buffalo Bills.

NOW, THEREFORE, BE IT
