COUNTY EXECUTIVE AS AMENDED

WHEREAS, assisting law enforcement reduce the supply of deadly narcotics related to the opioid epidemic is an important public health objective; and

WHEREAS, the Buffalo Urban League will administer the contract and facilitate employment opportunities for youth located within the City of Buffalo, while Catholic Charities will focus on youth employment in the surrounding suburbs and rural areas; and

WHEREAS, ECDSS estimates that the county will receive \$1,400,540 in funding to support the SYEP contract; and

WHEREAS, it is essential that the SYEP contract be established as soon as possible in order to provide sufficient time for the agency to be program ready when the youth have completed school for the summer.

WHEREAS, the New York State Department of Transportation has agreed to increase the Project scope and allowance as well as anticipated federal and New York State Marchiselli funds via a Supplemental Agreement No. 1 in the amount of an additional \$115,000, a total of \$225,000, for the Project's Preliminary Engineering and Right of Way Incidental phases; and

WHEREAS, the Supplemental Agreement No. 1 increases Erie County's local share from \$11,000 to \$15,000 of which the difference of \$4,000 is available from SAP Project B.15015, 2015 Highway Safety Program, Fund 420, Business Area 123; and

WHEREAS, the firm of Clark Patterson Lee, after a public RFQ process, has been selected as having the necessary expertise, experience, and manpower to provide the County of Erie with design engineering services for the safety improvements of the above noted Genesee Road (CR 49/409), Route 240 (CR 27/198) and Sibley Road (CR 432) intersection required.

WHEREAS, the design phases I - IV and incidental right of way phase of the Project, PIN 5761.77, is currently estimated at \$115,000 and the County is required to pay the estimated local share for the Project in the amount of \$23,000 which is available in Project B.15019, Fund Center 123, Fund 420, 2015 Capital Road Overlay Program; and

WHEREAS, this new project requires a new capital project, established in the amount of \$92,000 in Fund Center 123, Fund 420;

WHEREAS, an amendment to contract document no. 10-961-PW with project designers Foit Albert & Associates of Buffalo, New York will have to be negotiated for the tasks in the Project agreement.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature hereby approves the Pontiac Road Bridge over Big Sister Creek, BIN 3327820, PIN 5761.77 Project; and be it further
