WHEREAS, the draft Memorandum of Understanding presently under consideration by your Honorable Body assigned roles and responsibilities between the State, County and the Buffalo Bills; and

WHEREAS, pursuant to the MOU the County shall be designated as the lead agency (following solicitation) under the New York State Environmental Quality Review Act ("SEQRA") and responsible for coordinating review of all permits and approvals required under SEQRA, and any applicable state or local building codes and zoning ordinances, as may be applicable, and shall also be the responsible party to coordinate any non-environmental permitting, regulatory and construction matters; and WHEREAS, a Consultant Selection Process consistent with Section 26.08 of the Erie County Administrative Code occurred; and

WHEREAS, the consultant selection committee recommends Phillips Lytle LLP for the engagement.

NOW, THEREFORE, BE IT

RESOLVED, that the authorization is hereby provided for the County Executive or Deputy County Executive to enter into all agreements necessary to implement the environmental review and permitting of the new Buffalo Bills stadium; and be it further

RESOLVED, that the Erie County Executive, upon acceptance of a complete Full Environmental Assessment Form for the contemplated multi-use stadium, as representative of his office, and Erie County and the Erie County Legislature, is, through its Department of Environment and Planning, authorized to solicit Lead Agency Status for the environmental review of the Project, and upon the completion of the environmental process; and be it further

#### 4. COMM. 9E-8 (2022) COUNTY EXECUTIVE

WHEREAS, replacement of the Sharp Street (CR 181) Bridge over Spring Brook, BIN 3328440, Town of Concord, PIN 5763.79 (the "Project") is eligible for funding under CFR Title 23 U.S. Code, as amended, that calls for the appropriation of the costs of such program to be borne at the ratio of 95% Federal funds and 5% non-Federal funds under the BridgeNY Program; and

WHEREAS, the bridge needs to be replaced due to its age, functional, and structural deficiencies; and

WHEREAS, the County of Erie desires to advance the Project by entering into an agreement with NYSDOT and making a financial commitment to advance the reimbursable 95% Federal share and commit to payment of the 5% Non-Federal share of the costs of the Preliminary Engineering (Scoping & Design phases I-VI) and Right of Way (ROW) Incidentals phases of the project; and

WHEREAS, the roadway has a slight S-curve south of the bridge to accommodate an old railroad crossing which is no longer needed and is to be removed as part of the Project due to the railroad ROW being converted into a recreational trail; and

WHEREAS, the engineering design services for the removal of the S-curve are not part of the NYSDOT BridgeNY Sharp Street Bridge Replacement funding and are therefore a 100% County cost; and

WHEREAS, the estimated total cost of the engineering services for Preliminary Engineering (Scoping & Design phases I-VI) and Right of Way (ROW) Incidentals phases for the bridge replacement and elimination of the S-curve is \$315,000; and

WHEREAS, the BridgeNY Program will provide a total \$291,000 (95% federal - \$276,450 and 5% local - \$14,550) in project funding; and

WHEREAS, the estimated cost for the design engineering services for the elimination of the S-curve and a small design contingency, a 100% local share, is \$24,000; and

WHEREAS, the total local share will be \$38,550 (\$14,550 + \$24,000) which is available in Fund 420, Funds Center 123, Project B.18014 -2018 Fed Aid Project Bridge NY Program; and

WHEREAS, the County of Erie will design, let, and construct the Project; and

WHEREAS, using the Federal Aid RFQ process, the firm of Greenman-Pedersen, Inc., was selected as having the necessary expertise, experience, and manpower to provide the design engineering services required for the replacement of the above noted bridge; and

WHEREAS, the BridgeNY program requires that the Project shall begin no later than twenty-four (24) months after award and the construction phase of the Project shall be completed within thirty (30) months after award.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature hereby approves the Replacement of the Sharp Street (CR 181) Bridge over Spring Brook, BIN 3328440, Town of Concord, PIN 5763.79 (the "Project") and the associated roadway realignment for elimination of the S-curve; and be it further

WHEREAS, the County Executive is requesting authorization to enter into an Agreement with Ashley McGraw Architects DPC to provide professional design and construction administration services for the SUNY Erie Community College North Campus 2021 Bretschger and Kittinger Halls Classroom Infrastructure Improvements project.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is authorized to enter into an Agreement with Ashley McGraw Architects DPC to provide professional design and construction administration services for a total amount not to exceed \$550,000.00 including reimbursables and a design contingency, for the SUNY Erie Community College North Campus 2021 Bretschger and Kittinger Halls Classroom Infrastructure Improvements project; and be it further

WHEREAS, it is going to be approximately 9 more months before a new rental can be incorporated into the generator portion of Phase 2 of the Energy Performance Contract (EPC) at a reduced rate and the associated savings will be documented as part of the EPC; and

WHEREAS, it is necessary to continue renting the portable generator for up to an additional nine months until the EPC contract is signed; and

WHEREAS, during the preparation of the 2022 budget request, the Department of Public Works (DPW) was unaware of the need for the extra \$65,000 for equipment rental, so the additional funding was not requested in the rental line in the 2022 DPW Operating Budget; and

WHEREAS, it is necessary for the Rath Building to have a working emergency generator available in case of a power outage; and

WHEREAS, funding is available in Funds Center 14020, Fund 110, GL Account 570050.

NOW, THEREFORE, BE IT

RE: Erie County Resiliency in Communities After Stress and Trauma Initiative (INTRO. 10-2)

## A RESOLUTION TO BE SUBMITTED BY LEGISLATOR BASKIN

WHEREAS, according to US Department of Health and Human Service's Substance Abuse and Mental Health Services Administration, trauma "is a widespread, harmful and costly public health problem. It occurs as a result of violence, abuse, neglect, loss, disaster, war, and other emotionally harmful experiences"; and WHEREAS, resiliency is defined by the American Psychological Association as "the process of adapting well in the face of adversity, trauma, tragedy, threats or significant sources of stress" and this process occurs at multiple different levels, both individually, and within in a family, as well as at the community-level; and

WHEREAS, in understanding the impact of trauma on a community, and how resiliency can help address reconciling with past trauma and absorbing future trauma, there have been multiple efforts across the country in recent years to build trauma-informed, resilient communities; and

WHEREAS, a community is trauma-informed if the people in the community realize the widespread prevalence of trauma, recognize the signs and symptoms, respond in an understanding and supportive manner, and resist doing further harm; and

WHEREAS, Buffalo was very recently traumatized by a racist, terrorist attack that inflicted profound, personal hurt on the families and friends of the ten lives that were lost and three individuals who were physically harmed; and

WHEREAS, Buffalo's Black community was also traumatized by the intent to inflict as much harm as possible on Black people, by choosing to attack the heart of Buffalo's Black community at its only major supermarket; and

WHEREAS, this racist attack was the latest incident in decades of trauma-inflicting actions on Buffalo's Black community, from segregated schools and redlining of home ownerships, to a historic lack of public investment in parks, streets, and sidewalks and overwhelming gun violence, there is significant, deep trauma plaguing Black people; and

WHEREAS, after many years, racism and trauma have been recognized as public health issues, both nationally and locally; and

WHEREAS, it is vital to our existence as a responsive, equitable, empathic local government system that we address this trauma and its embedded, long-standing causes by creating long-term solutions that build resiliency through trauma-informed processes and programs.

NOW, THEREFORE, BE IT

RESOLVED, that this Honorable Body commits to developing a Resiliency in Communities After Stress and Trauma Initiative in partnership with pertinent County branches and departments, non-government organizations, and other levels of government; and be it further

RESOLVED, that this initiative shall develop a plan to address the trauma exacerbated by the recent racist attack at Tops Markets on Jefferson Avenue, which should include, but not be limited to:

• Creation of permanent location for trauma counseling, including free access to counseling services.

• Plan to address underinvestment in development on Buffalo's East Side commercial corridors, including funding mechanism for security upgrades for small business and public gathering spaces.

• Long-term investment in programming and services for Buffalo's communities of color, particularly its young people of color.

• Psychological First Aid training for residents, block clubs, community organizations, and faith institutions located in densely-populated minority neighborhoods.

RE: Erie County Anti-Gun Violence Annual Reporting (INTRO. 10-4)

### A RESOLUTION TO BE SUBMITTED BY LEGISLATOR BASKIN

WHEREAS, on December 2, 2021 the Erie County Legislature passed the 2022 amended county budget which included a new Anti-Gun Violence Community Coordinator position in Central Police Services; and

WHEREAS, the position will involve assisting anti-violence and other public/private organizations involved in public safety with planning, coordinating and implementing programs to promote a safer community; and

WHEREAS, Erie County provides funding to multiple local community organizations to administer anti-violence programming and intervention services in order to mitigate gun violence in Erie County; and

WHEREAS, the county departments most known for partnering with these organizations include Probation, Social Services, and the Division of Youth Services; and

WHEREAS, as a 2018 study by the NY Extreme Risk Protection Orders Coalition found that Erie County had the highest rate of gun homicides, and that in 2020 the Erie County District Attorney noted that deaths from gun violence surged, rising from 34 in 2019 to 46 in 2020, and in June 2021, the New York State Division of Criminal Justice Services released a report indicating Erie County was the county that had the highest rate of violent crimes involving a firearm in 2020, per capita, across New York State (130.7 crimes involving a firearm per 100,000 residents), which was more than double the state average (57.4 per 100,000 residents), and even much greater than New York City's rate (77.6 per 100,000 residents); and

WHEREAS, on July 5, 2021 a three-year-old boy, Shaquelle Walker, Jr., was shot in the head while riding his bicycle in front of his grandparents' home on Donovan Drive and succumbed to his injuries three days later; and

WHEREAS, on May 14, 2022 ten Black men and women were murdered and three injured by a white supremacist in the largest mass shooting in Buffalo's history; and

WHEREAS, on July 20, 2021, Erie County Executive Mark Poloncarz declared gun violence to be a public health crisis in Erie County and directed county officials to form a task force to work in concert with local law enforcement as well as local anti-violence organizations and leaders, and the Live Well Erie Task Force to prepare programs and initiative; and authorized the Commissioner of the Department of Probation to increase the number of monthly home visits, known as Individual Custom Notifications, performed by Department of Probation officers with probationers who are at high-risk of involvement with guns and violence under the Gun Involved Violence Elimination ("GIVE") Initiative; and expedited the investment of the additional \$530,727 received by Erie County from New York State for additional summer youth employment opportunities, under the new age and geographic residence restrictions provided by New York State, thereby making more at-risk youth and young adults eligible for the program, and to work with local anti-violence organizations and leaders to identify at risk youth and young adults for the initiative; and work to transition said young adults into permanent employment opportunities using the Department of Social Services' Placing Individuals in Vital Opportunity Training ("PIVOT") program; and

WHEREAS, the residents of Buffalo and Erie County are desperately in need of action that will alleviate this public health crisis which has resulted in the untimely deaths of local residents and inflicted violence and trauma on their families and neighbors; and

WHEREAS, it is imperative that our community has clear understanding of all of the measures being taken by Erie County as public dollars are invested in mitigating gun violence; and

WHEREAS, an anti-gun violence community impact report that outlines the local community organizations that receive county funding to alleviate gun violence, progress on initiatives, and recommendations for improvements, as well as initiatives and programming by the Erie County Anti-Gun Violence Task Force, will help in providing transparency on County action and assist in strengthening collaboration across all local government agencies that touch gun violence.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature directs the Commissioner of Central Police Services to submit annually an anti-gun violence report that outlines the services funding allocations and data outcomes of all programs and initiatives implemented by Erie County to reduce gun violence in our community; and be it further

RESOLVED, copies of this resolution will be given to the Erie County Anti-Gun Violence Task Force, Erie County Executive, the Erie County District Attorney, the Erie County Sheriff, , the New York State Attorney General, the Erie County Commissioner of Central Police Services, Erie County Commissioner of Health, Erie County Commissioner of Probation, and the Erie County Commissioner of Social Services.

**RESOLUTION NO. 87** 

RE: Bills, NYS & EC MOU Regarding Construction of New Stadium (COMM. 7E-15, 2022)

WHEREAS, Ralph C. Wilson, Jr. formed a professional football team in 1960 that became known as the Buffalo Bills; and

WHEREAS, the Buffalo Bills is an original American Football League franchise and has been located in Buffalo and Erie County for the last sixty-two years; and

WHEREAS, the Buffalo Bills football team has played in what is now known as Highmark Stadium since 1973 pursuant to the original 25-year lease, said stadium having been constructed and paid for solely by Erie County; and

WHEREAS, after a one-year extension in 1998 a new 15-year lease was entered into that expired on July 30, 2013. The 1998 Lease included stadium improvements that extended the structural and economic life of the Stadium; and

WHEREAS, in 2013 a subsequent 10-year lease was entered into that will expire on July 30, 2023. The 2013 Lease also included stadium improvements that extended the life of the structural and economic life of the Stadium; and

WHEREAS, the Stadium turns forty-nine years old at the end of this lease year. At this age many of the elements of the Stadium are dated and do not function adequately to serve the public's interest in today's marketplace, nor does it conform to the accepted standards of an NFL franchise; and

WHEREAS, the Stadium will be more than fifty years old at the end of the 2013 Lease and it is prudent to begin to plan for a new stadium in order to keep the Buffalo Bills in Erie County for years to come; and

WHEREAS, the Buffalo Bills football team has been an important part of New York for more than 62 years. The Team brings pride, distinction, and a sense of community to Erie County and New York State; and

WHEREAS, the Buffalo Bills, as part of the regional and New York State economy, bring large amounts of sales tax, hotel occupancy tax, and personal income tax to public sector coffers; and

WHEREAS, the Buffalo Bills are a part of the efforts to promote Erie County and Western New York as a major community where companies may settle and grow; and

WHEREAS, it is the desire of the Buffalo Bills, Erie County, the State of New York and the numerous fans of the Buffalo Bills who are located throughout the world, that the Buffalo Bills, remain in Erie County; and

WHEREAS, the State, County and Buffalo Bills (the "Parties") have negotiated a Memorandum of Understanding ("MOU"), that contains the terms of the construction of a new multi-use stadium to be owned by the State of New York, and a corresponding thirty-year lease; and

WHEREAS, the MOU specifies that there will be a total of approximately \$1.4 billion contributed to the construction of a new stadium with the County contributing \$250 million, Erie County Stadium Corporation, on behalf of New York State, contributing \$600 million, the Buffalo Bills contributing the remainder of the project budget, including any cost overruns associated with the project, and also contributing rent payments of \$900,000 per annum; and

WHEREAS, the Buffalo Bills have agreed to enter into a Non-Relocation Agreement that can be enforced by specific performance or liquidated damages in the amount of the public's contribution for the first fourteen years and declining thereafter; and

WHEREAS, on Monday, March 28, 2022, Governor Kathy Hochul, Erie County Executive Mark Poloncarz and the Buffalo Bills each announced an agreement on the new stadium construction and lease terms and signed the MOU as of Tuesday, March 29, 2022; and

WHEREAS, The County's approval of the MOU is to be effective upon the approval of the County Legislature; and

WHEREAS, the approval of the MOU between the Parties is a reasonable step necessary to set forth the process pursuant to which the Parties will move forward and commit substantial

resources to the design and siting of a facility which will meet the respective needs of the Parties, and comply with all applicable federal, state, and local laws, and regulations including but not limited to compliance with Article 8 of New York State's Environmental Conservation law ("SEQRA"); and

WHEREAS, in order for the Parties to move forward, and for the County Executive to negotiate the final documents that will include a Stadium Lease, a Construction Coordinating Agreement, a Non-Relocation Agreement, an Extension Agreement of the 2013 Stadium Lease, a Community Benefits Agreement, along with all other necessary documents, it is necessary for the Erie County Legislature to approve the MOU that is attached to this Resolution; and
