WHEREAS, the Department of Social Services did not solicit lease proposals due to its management's focus on responding to the COVID-19 crisis and the aforementioned uncertainty; and

WHEREAS, the County included funds for this lease in the 2020 Adopted Budget; therefore, there will not be a fiscal impact to the County in 2020.

NOW, THEREFORE, BE IT

RESOLVED, the County Executive is authorized to execute the lease extension for 43 Court Street at the rental amount of \$24,013.82 per month and under the rental terms herein presented; and be it further

Desired services include gathering all documents required for a comprehensive fiscal review, analyzing case activity for each case reviewed, working collaboratively with legal partners if necessary, and drafting a comprehensive report of findings; and

WHEREAS, the Department distributed a request-for-proposal for this service and received only one response. The scoring committee determined that Bonadio & Company LLP, the sole respondent, exceeded the qualifications for this service and recommended the Department enter into a contract; and

WHEREAS, the Department of Social Services has a long-standing contractual relationship with Bonadio & Co. LLP. Bonadio & Co. has provided forensic accounting services for the Department of Social Services to examine a subset of Medicaid cases; and

WHEREAS, the Department wants to expand the services it utilizes from Bonadio & Co. LLP but does not have Legislative authorization to do so; and

WHEREAS, funds are available in the adopted 2020 County Budget in Account 516021 (Bonadio Group - Professional Services Contract), there is no additional local share necessary for these awards, and there is no budgetary impact based on this resolution.

3. INTRO. 10-10 (2020) CHIMERA, BASKIN, MEYERS, HARDWICK, JOHNSON, GILMOUR & VINAL

WHEREAS, as a result of the COVID-19 pandemic and the resulting states of emergency issued to help stop the spread of the coronavirus, Erie County has experienced a significant loss of revenues, including sales tax, hotel occupancy tax, and others; and

WHEREAS, this revenue loss negatively affects not just the County government, but the cities, towns, villages and school districts in Erie County which cumulatively receive approximately 45% of the County's 4.75% local sales and compensating use tax; and

WHEREAS, due to New York State's underlying budget deficit – prior to the COVID-19 outbreak – and enhanced by the coronavirus, the State government is reducing State aid to local governments, including the County by 20% and perhaps as much as a 50% reduction; and

WHEREAS, on May 4, 2020, the Erie County Comptroller formally declared the County to have a 2020 Budget deficit, stating that the 2020 deficit is \$206.6 million; and

WHEREAS, the Erie County Division of Budget and Management has indicated their projection of the 2020 Budget gap to be \$230 million; and

WHEREAS, in response to the budget gap, the County Executive has already engaged in measures including a hiring freeze and directing departments to develop plans to reduce their budgets and spending for the remainder of 2020 at a time when people need services and government assistance more than ever; and

WHEREAS, this financial situation – one shared by local governments – is not due to any actions by the County government or our local government partners and will likely continue into 2021; and

WHEREAS, the federal government has already enacted several economic recovery legislative packages providing financial assistance to governments to directly provide COVID-19 assistance, as well as other relief packages for unemployed workers and small businesses; and

WHEREAS, the federal government has not yet provided any economic recovery packages to local governments to address revenue shortfalls and gaps caused by the pandemic.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature respectfully calls on the President and the Congress to develop an economic recovery program and funding for local governments to specifically address the revenue gaps created by the COVID-19 pandemic; and be it further

RESOLUTION NO. 110

RE: Support for Federal Stimulus Funding for EC & Local Governments (INTRO. 11-4)

A RESOLUTION SUBMITTED BY LEGISLATORS BASKIN, MEYERS, HARDWICK, JOHNSON, CHIMERA, VINAL AND GILMOUR

WHEREAS, among the terrible medical issues, illnesses and tragic deaths, the COVID-19 pandemic has resulted in a massive loss of revenues to Erie County and to the cities, towns, villages and school districts that receive sales tax revenue from the County; and

WHEREAS, current estimates of the size of the revenue loss for Erie County government alone are in the \$206.6 million-\$230 million range (worst case scenario); and

WHEREAS, analysts say the pandemic is the worst economic crisis to affect the United States since the Great Depression; and

WHEREAS, county and local governments across the country have requested and pled for federal financial assistance to address the crisis, similar to the federal financial assistance provided to localities after the Great Recession in 2008-2009, wherein Erie County received over \$100 million in federal stimulus funds which were provided with no conditions and helped to cover revenue gaps; and

WHEREAS, on May 12, 2020, the US House of Representatives introduced a coronavirus financial assistance bill that would allocate more than \$3 trillion to states, local governments, and health systems, as well as provide a second round of stimulus checks to millions of Americans; and

WHEREAS, the legislation, called the Health and Economic Recovery Omnibus Emergency Solutions Act (HEROES Act) would allocate a proposed \$516.6 million in federal financial assistance to Erie County over two years, more than closing and addressing the 2020 budget gap and closing a certain 2021 budget gap also; and

WHEREAS, the legislation would also appropriate and allocate millions of dollars to the cities, towns and villages in Erie County, providing fiscal relief to our local partners; and

WHEREAS, for instance, as proposed, the Town of Alden would receive \$4.9 million, the Town of Aurora would receive \$6.8 million, the Town of Clarence would receive \$16.1 million, the Town of Concord would receive \$4.1 million, the Town of Elma would receive \$5.8 million, the Village of Kenmore would receive \$7.4 million, the City of Lackawanna would receive \$8.7 million, the Town of Lancaster would receive \$21.3 million, the Town of Newstead would receive \$4.2 million, the Town of Orchard Park would receive \$14.5 million, the Town of West Seneca would receive \$22.3 million, and the Village of Williamsville would receive \$2.5 million; and

WHEREAS, the bill establishes a \$200 billion "Heroes Fund" to extend hazard pay to essential workers, send a second and larger round of direct payments to individual Americans, up to \$6,000 per household, increase nutrition assistance benefits, provide \$175 billion in housing assistance, extends a \$600 weekly increase in unemployment insurance through January 2021, and directs an additional \$75 billion for coronavirus testing and contact tracing; appropriate \$850 million for states to provide child and family care for essential workers, and provide funding for personal protective equipment for emergency health care and essential workers; and

WHEREAS, the HEROES Act funding for the County would close 2020 and potential 2021 Erie County budget gaps due to the loss of state aid, sales tax, hotel occupancy tax, mortgage recording tax and transfer tax revenues, among others, and potentially forestall and prevent reductions in spending on important programs and the reductions in force of County employees via layoffs.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature expresses its support for the HEROES Act, especially its provisions for providing financial assistance to local governments to close COVID-19

revenue gaps, urges the US House of Representatives to approve said legislation, urges the US Senate to introduce and pass a companion bill, and urges the President to sign said legislation into law expeditiously; and be it further

A RESOLUTION TO BE SUBMITTED BY LEGISLATORS RATH, LORIGO, TODARO & MILLS

WHEREAS, NYS has seen almost 5,400 confirmed or suspected COVID-19 deaths in nursing homes and other adult care facilities; and

WHEREAS, in Erie County over half of the deaths attributable to COVID-19 infection stem from nursing facilities; and

WHEREAS, the number of infected residents in NYS is directly attributable to Cuomo's policies, the negative impacts of which have been compounded by low staffing levels, vulnerability of the target population, and insufficient supply of personal protective equipment; and

WHEREAS, NYS has enacted a mandate that nursing homes accept COVID patients who have been deemed "medically stable." This directive of the NYS Health Department was recently rescinded but not before it put many of the state's nursing home residents at unnecessary risk of infection; and

WHEREAS, Governor Cuomo has indicated he intends to have the NYS Attorney General's office investigate what happened and that the NYS Health Department would lead the investigation; and

WHEREAS, it is difficult to see how the Health Department can reasonably be expected to evaluate their own policies and decisions that could have directly resulted in the deaths of thousands more residents than would have happened had they simply not made any of the questionable directives; and WHEREAS, there are bipartisan calls from state legislators, including Chairman of the Assembly Health Committee Assemblyman Richard Gottfried (D), Senate Health Committee Chairman Senator Gustavo Rivera (D), and Republican Senate and Assembly leadership, for an independent probe into the high rates of Covid-19 deaths at nursing homes. Local representatives have also weighed in supporting an independent investigation, including Senators Pat Gallivan, Rob Ortt, and Chris Jacobs.

NOW, THEREFORE, BE IT

RESOLVED, that this Honorable Body is in support of, and hereby calls for, an independent inquiry and public hearings to review the circumstances regarding the high number of Covid-19 infections and fatalities at nursing homes, and make recommendations to ensure the safety and wellbeing of each resident and employee; and be it further

RESOLVED, this honorable body calls on the NYS Attorney General's Office and the Commissioner of the Department of Health to recuse themselves from any investigation into the administration's actions and the actions of the health department and to allow investigation to be conducted by an independent investigator; and be it further

RESOLVED, that certified copies of this resolution be sent to the Western New York Delegation to the New York State Senate and Assembly, the New York State Attorney General's office, the office of the Governor of New York, the Commissioner of the NYS Department of Health, and any other party deemed necessary and proper.

WHEREAS, the Governor recently stated that the New York State Department of Health and New York State Attorney General's Office would conduct an investigation into the CIVID-19 deaths and outbreaks, raising questions and concerns about the propriety of the State Health Department, which regulates and oversees such facilities, conducting an investigation of itself; and

Delete the 2nd Resolve Clause in its Entirety and Replace with the Following:

RESOLVED, that the Erie County Legislature expresses its support for the establishment of an independent investigator, working with the New York State Attorney General's Office, to inquire into this matter; and be it further

A RESOLUTION TO BE SUBMITTED BY LEGISLATORS TODARO, LORIGO, RATH & MILLS

WHEREAS, due to the Covid-19 pandemic, a record number of Americans are out of work, leading to the national unemployment rate increasing to 14.7% in April, 2020, according to the Bureau of Labor Statistics; and

WHEREAS, over 1.8 million New Yorkers have received more than \$7 billion in unemployment benefits since the beginning of the pandemic, while \$2.1 billion in benefits were paid in all of 2019; and

WHEREAS, thousands of individuals have been waiting numerous weeks or in many cases more than a month or two to successfully apply for unemployment benefits; and

WHEREAS, despite the NYS Department of Labor's efforts, which include (DOL) hiring an additional 3,000 employees to process and distribute unemployment benefits, implementing a new online portal for applications developed by Google Cloud after the DOL website crashed due to the volume, and a recent announcement that the DOL will begin emailing and texting applicants a status update for their claims; and

WHEREAS, the severe lag time between initially filing for unemployment and finally receiving unemployment benefits is causing major financial hardship for thousands of New York families; and

WHEREAS, it is the finding of this Honorable Body that there needs to be an efficient processing of existing and new unemployment benefit claims; and

WHEREAS, it is the finding of this Honorable Body that the state Assembly and state Senate need to hold hearings with the DOL and appropriate agency heads to seek an action plan and

additional measures that could be implemented to reduce the backlog of claims and efficiently process new claims, and this Honorable Body requests the state Comptroller's Office conduct a performance audit of DOL's procedures and processing of unemployment applications; and

WHEREAS, several state lawmakers, including state Senators Joseph Griffo and James Seward, and Assemblymembers Marianne Buttenschon and Mark Walczyk are calling for the above noted action to increase oversight and accountability, to improve DOL's management of the unemployment claims process.

NOW, THEREFORE, BE IT

RESOLVED, this Honorable Body supports a state legislature inquiry into processing delays of unemployment benefits, and to seek measures to increase the processing of new and existing unemployment benefit claims; and be it further

RESOLVED, this Honorable Body supports a performance audit to be conducted by the state comptroller of the Department of Labor's procedures and administration of the unemployment insurance program; and be it further

Budget Gap (INTRO. 10-11, 2020)

A RESOLUTION SUBMITTED BY LEGISLATORS VINAL, BASKIN, MEYERS, HARDWICK, JOHNSON, CHIMERA & GILMOUR

WHEREAS, due to the COVID-19 pandemic and the state of emergency declared in New York State and Erie County, and the NY-Pause gubernatorial executive order designed to maintain social distancing and stop the spread of coronavirus, many businesses and entities have been closed; and

WHEREAS, this has helped cause a situation in which Erie County, like other local governments across the state and country, is not receiving significant revenues from sales tax, hotel occupancy taxes, and other revenues such as County Clerk fees; and

WHEREAS, the Erie County Division of Budget and Management has variously estimated a negative fiscal impact in 2020 from a loss of revenue to the County government of between \$198 million and \$230 million; and

WHEREAS, on April 30, 2020, the County Executive held a conference call with Erie County elected officials and informed them that he was asking all County departments to develop contingency plans for proposed reductions to their 2020 budgets and spending for the rest of 2020 by 13%, and to submit said plans to his office by May 14, 2020 for review; and

WHEREAS, on May 4, 2020, the Erie County Comptroller issued a letter to the Legislature declaring the existence of a \$206.6 million deficit in the County's 2020 fiscal year and this action was done without consultation with the Division of Budget and Management or the County Executive; and

WHEREAS, Section 2511 of the Erie County Charter prescribes a process and timeline for the County Executive, Comptroller, and County Legislature to follow when a deficit is formally declared; and

WHEREAS, the County's Budget Monitoring Report for the first three months of 2020, issued on May 5, 2020, shows that the County has a \$2.5 million positive variance for the first quarter as closed by the Comptroller's Office and for which all revenue and expense accruals has been completed for 2020 so far; and

WHEREAS, this suggests that while the County has a looming budget gap that needs to be addressed, for the quarterly reporting period that was just formally closed on April 30 2020, the County did not have a "deficit"; and

WHEREAS, it is clear that the County faces significant fiscal challenges due to the COVID-19 pandemic and the loss of revenues, for which the County Executive has been in a variety of discussions and dialogue with County officials concerning a variety of remedial actions to close the future budget gap; and WHEREAS, the County Executive is engaged in discussions with the National Association of Counties and US Senator Charles Schumer, both in his role as a Senator representing New York, as well as Minority Leader of the US Senate, seeking federal economic recovery/stimulus funding for local governments to address COVID-19 revenue losses; and

WHEREAS, there are ongoing negotiations and discussions about a possible new round of federal stimulus funding for local governments designed to address revenue gaps or amendment of the CARES Act, and according to federal representatives, potential action on this may occur by the end of May 2020; and

WHEREAS, while contingency planning for possible reductions in County spending to address the COVID-19 revenue loss should begin and should be in-progress for all departments, it is premature to trigger the Section 2511 deficit provisions of the Erie County Charter and to formally act and reduce or terminate County spending, including potentially on important community services such as parks, libraries, culturals, road work, public health, and public assistance programs that the public needs, deserves and wants, until such time as the status of federal stimulus funding is determined, because such federal funding could help to offset County spending reductions, help preserve critical County services, and reduce the amount of the County's looming 2020 deficit.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature reaffirms its commitment to fiscal responsibility and the provisions in Section 2511 of the Erie County Charter requiring action to address a deficit; and be it further

RESOLVED, that this Honorable Body hereby informs the County Executive of our willingness to allow him to formally transmit a 2020 deficit reduction plan to this Body on/by June 2, 2020, to provide time for federal negotiations and discussions to continue on establishing federal stimulus plan for local governments to address the COVID-19 revenue losses; and be it further

RESOLVED, that the Erie County Division of Budget and Management and Comptroller's Offices are directed to attend upcoming meetings of the Legislature's Finance and Management Committee to discuss the looming budget gap and contingency measures which can be undertaken or considered; and be it further

RESOLVED, that certified copies of this resolution shall be transmitted to the County Executive, Comptroller, and Erie County government independent elected officials.
