WHEREAS, the addition of this initiative necessitates the execution of contracts with the NYSDEC; the adoption of a grant budget; the continued funding of an existing Senior Environmental Compliance Specialist (JG-12) position and the part-time support of an existing Corrections Officer (JG-12) position.

WHEREAS, as we begin to reopen the economy and return to normal guidelines put in place to keep people safe include social distancing, wearing masks in public, limited occupancy at establishments, continuing to work from home, and self-quarantining when one feels ill; and

WHEREAS, social distancing is intended to assist with containing the spread by limiting germs that can be transferred and received between persons; and

WHEREAS, many social distancing guidelines present serious challenges for businesses, particularly restaurants, to reopen successfully; and

WHEREAS, upon reopening it appears that restaurants will be forced to limit their occupancy levels significantly which will seriously impact their ability to reopen successfully; and

WHEREAS, the City of Buffalo's Common Council is currently considering a resolution proposed by Councilman Feroleto that will allow restaurants to utilize the parking spaces in front of their restaurants to add outdoor seating as well as exploring other alternatives to expand outdoor offerings including closing certain streets to traffic; and

WHEREAS, the goal is to enlarge the space the restaurant has to operate safely so they are able to get their occupancy levels closer to normal.

NOW, THEREFORE, BE IT

RESOLVED, that this honorable body hereby supports the actions of the Buffalo Common Council in expanding dining options in light of the issues posed by COVID-19 and urges the Erie County Health Department to work with the City of Buffalo in regards to any additional permitting and health inspection requirements; and be it further

A RESOLUTION TO BE SUBMITTED BY CHAIR BASKIN

WHEREAS, the Erie County Legislature stands in strong support of assisting community members during the COVID-19 pandemic, providing appropriate public assistance benefits, as well as performing critical public health functions; and

WHEREAS, among these functions is the need for COVID-19 testing of symptomatic and asymptomatic persons who are reasonably believed to have the Coronavirus or were exposed to the virus, as well as antibody testing of persons to determine if they were already exposed to or had COVID-19; and

WHEREAS, COVID-19 has particular and specific negative effects on persons of color, such as African-Americans and Latinos, who often live in poverty, in poor housing, and with limited access to preventative and primary healthcare; and

WHEREAS, members of this Honorable Body have advocated and fought for more testing and testing sites in our community, such as the 14215 Zip Code in Buffalo, including unanimously passing a resolution calling for a testing site to be established due to the high positive cases in the area; and

WHEREAS, this advocacy helped lead Kaleida Health, in partnership with the County, to establish a COVID-19 testing site at the Leroy Coles branch library of the Buffalo and Erie County Public Library; and

WHEREAS, through a partnership with Erie County, the City of Buffalo, Kaleida Health, the African American Health Disparities Task Force, Legislature Chairwoman April NM Baskin and various community stakeholders, a testing site opened at the Leroy Coles branch library at 1187 East Delavan Avenue one month ago to address the lack of accessible testing locations in the 14215 Zip Code; and

WHEREAS, Kaleida Health has determined that due to current usage trends at the Leroy Coles testing site, they will close that testing site shortly; and

WHEREAS, this needs to be properly communicated to members of the community, to allow them to use that site for COVID-19 testing before it closes, and information on the six other available COVID-19 and antibody testing site options in the 14215 Zip Code or vicinity needs to be shared with the community, to alert residents to the other locations; and

WHEREAS, some of the alternative sites include the Community Health Center of Buffalo (34 Benwood Avenue, Buffalo, New York 14215), Rite-Aid (2474 Bailey Avenue, Buffalo, New York 14215), Urban Family Practice (1315 Jefferson Avenue, Buffalo, New York 14208), and Kaleida Health (28 Best Street, Buffalo, New York 14209); and

WHEREAS, 14215 continues to be among the three-highest zip codes with positive cases, perhaps due to the fact that many healthcare workers, especially nursing home, skilled nursing and acute care workers, live in the neighborhoods of this zip code; and

WHEREAS, there are many positive COVID-19 cases rampaging through these nursing homes and related facilities, putting residents and employees at risk; and

WHEREAS, the goal of this community education and information-sharing needs to be about decreasing positive cases and allowing for all community members to get tested; and

WHEREAS, this Honorable Body presently has a principal goal of decreasing the spread of COVID-19, particularly in vulnerable in zip codes, as we begin to re-open Erie County under the New York Forward plan.

RESOLVED, the Erie County Legislature strongly encourages the County to provide clear information and guidance to residents in the 14215 Zip Code of the transition from the Leroy Coles testing site to alternative sites and testing options, including conducting a targeted campaign on media, social media and print materials alerting residents of other testing options at healthcare providers, private labs, and drug stores; and be it further

RESOLVED, that while private entities are offering testing options in this area, it is still a responsible of the County to insure impoverished, underserved communities have County-provided oversight and services associated with decreasing the spread of COVID-19, and as a result, this Honorable Body strongly encourages the Erie County Department of Health to conduct testing on its own at an appropriate facility in the 14215 Zip Code on a bi-weekly basis to assist this disproportionately-affected community; and be it further

RESOLVED, that the Erie County Department of Health is encouraged to implement antibody testing, such as that currently being offered throughout Erie County, at a location in the 14215 Zip Code on a bi-weekly basis to help slow positive Coronavirus cases in this Zip Code and neighboring Zip Codes; and be it further

RESOLVED, that certified copies of this resolution be transmitted to the County Executive, Commissioner of Health, CEO of Kaleida Health, CEO of Erie County Medical Center Corporation, and the Chairpersons of the African American Health Disparities Task Force.

A RESOLUTION TO BE SUBMITTED BY LEGISLATOR LORIGO

WHEREAS, by Executive Order of the Governor of New York, signed March 16, 2020, bars and restaurants have been able to provide alcoholic beverages with take-out orders as long as the beverage is in a sealed container; and

WHEREAS, as per the attached State Liquor Authority guidance the order allows any establishment with an on-premises consumption license to sell alcoholic beverages for off-premises consumption; and

WHEREAS, the persistence of the Corona virus has currently caused the mandated closure of all bars and restaurants for anything other than take out and will likely severely limit the seating capacity of these same establishments for the foreseeable future once in-person dining has resumed; and

WHEREAS, it is estimated that restaurant's, licensed to sell alcohol on site, derive 30% of their revenue from the sale of alcoholic beverages; and

WHEREAS, takeout orders have been the only source of revenue for bars and restaurants for much of the past three months. Without the ability to sell alcohol, many of these establishments would not have been able to survive; and

WHEREAS, considering the likelihood that many restaurants will see state-ordered diminished seating capacity, and a general reluctance of patrons to return, until the corona virus is contained, establishments with an on-premises consumption license should be allowed to continue to sell alcoholic beverages for off-premises consumption.

NOW, THEREFORE, BE IT

RESOLVED, that this body supports the executive decision to allow the sale of alcoholic beverages for consumption off-premises by establishments typically licensed only for consumption of alcohol on-premises; and be it further

RESOLVED, that this honorable body further supports permanent policy changes to allow for the responsible sale of alcoholic beverages for off-premises consumption by any bar or restaurant licensed to do so; and be it further RESOLVED, that this Resolution be forwarded to the New York State Liquor Authority, Governor Andrew Cuomo, the Western New York Delegation to the New York State Senate or Assembly, and any other party deemed necessary and proper.
