WHEREAS, buildings at all three locations have deteriorated over time due to the extreme conditions seen by the building during the training sessions and are now beyond their useful life; and

WHEREAS, the Live Burn Training Facilities are used by Fire Departments throughout the Western New York area including municipalities, as well as Volunteer Fire Departments, to do their mandated yearly training and instruction; and

WHEREAS, the Fire Coordinator and Fire Safety Division of the Erie County Department of Homeland Security and Emergency Services controls and oversees all state, county, and local agency training that takes place at these facilities; and

WHEREAS, repairs to all three buildings were publicly bid by the Purchasing Department with the Cheektowaga location as the base bid and the Chestnut Ridge Park as well as Amherst locations being bid as separate alternates at that time; and

WHEREAS, the Purchasing Department opened bids on March 6, 2020, however, Erie County did not have the funding in place to repair all three locations so only the Cheektowaga location has been repaired to date; and

WHEREAS, Erie County is required to adhere to the manufacturer requirements of Fire Facilities Inc. (FFI), requiring that only certified contractors, through FFI's own certification process, are allowed to install their Live Burn Building System to ensure the building system and components are installed as designed by the manufacturer to be able to withstand the extreme environment seen by the building during training sessions; and

WHEREAS, the Department of Emergency Services and the Purchasing Department are recommending award to Harty Construction Inc. considering they are the only certified contractor in New York State and were the only contractor that submitted a bid proposal when it was publicly advertised by the Purchasing Department; and

WHEREAS, Emergency Services received updated pricing from Harty Construction Inc as it has been over 2 years since the project was originally bid.

NOW, THEREFORE, BE IT

RESOLUTION NO. 112

RE: ECSO BTAT Positions (COMM. 12E-9, 2022)

WHEREAS, On May 14, 2022, the African American Community was viscously attacked in a racially motivated massacre; and

WHEREAS, following that mass shooting, law enforcement and the world learned of the attacker's evolution into a radicalized white supremacist. Initial investigations discovered the individual's plans, activities, and law enforcement encounters leading up to the attack; and

WHEREAS, although each step seemed unique and separate when viewed together, these activities lay out a path to a murderous rampage specifically targeting African-Americans; and

WHEREAS, following the mass shooting, Sheriff Garcia contacted the U.S. Secret Service and Monroe County Sheriff to learn of plans, operations, and groups developed to investigate, mitigate, and redirect individuals in the early stages of the subject's plans; and

WHEREAS, on June 9, 2022, Sheriff Garcia announced the Erie County Sheriff's Office Behavioral Threat Assessment Team (ECSO BTAT) alongside federal, state, and local law enforcement partners and stakeholders from the county government; and

WHEREAS, the ECSO BTAT's team structure consists of one Senior Detective and five Detectives that will receive training from the U.S. Secret Service; and

WHEREAS, following the team's certification, these Detectives will work collaboratively with federal, state, and local law enforcement agencies, community organizations, schools, mental health providers, and numerous local stakeholders to build a network designed to stop and redirect individuals before they can initiate their evil plot; and

WHEREAS, on May 18, Governor Kathy Hochul issued Executive Order No. 18, which states in part:

"Every county and the City of New York must perform a comprehensive review of current strategies, policies, procedures, practices. Every county and the City of New York must develop and maintain a plan to identify and confront threats of domestic terrorism that includes racially or ethnically motivated violent extremists. This plan must include input from law enforcement, mental health professionals, school officials, and other key stakeholders within their jurisdiction and be submitted to the Division of Homeland Security and Emergency Services' Office of Counterterrorism on or before December 31, 2022. These plans will be used to inform funding distributions in forthcoming grant opportunities;" and

WHEREAS, although the executive order mandates every county to create a plan to confront domestic terrorism threats by the end of 2022, Sheriff Garcia and local leaders believe Erie County must develop and deploy a team immediately to detect and prevent an incident such as our community witnessed on May 14, 2022, and

WHEREAS, because there is a limit to the number of Deputies deployed for the event, there is no financial impact on the 2022 County Budget.

NOW, THEREFORE, BE IT

RESOLVED, the Erie County Legislature authorizes the Erie County Sheriff's Office and the Personnel Department to create one (1) Sheriff-Senior Detective position (JG X); and be it further

RESOLVED, the Erie County Legislature authorizes the Erie County Sheriff's Office and the Personnel Department to create five (5) Sheriff-Detective positions (JG X); and be it further

RESOLVED, that the Division of Budget and Management and the Commissioner of Personnel are authorized to make any changes necessary to effectuate the change; and be it further

RESOLVED, certified copies of this resolution shall be forwarded to the County Executive's Office, the Department of Personnel, the Division of Budget and Management, and the Erie County Sheriff's Office.
