## **COUNTY OF ERIE**

LOCAL LAW INTRO. NO. 7-2 2019

LOCAL LAW NO. \_\_\_\_\_ 2019

A Local Law entitled "ERIE COUNTY CORRECTIONS SPECIALIST ADVISORY BOARD" in relation to establishing an advisory board for the Erie County Jail Management Division.

Be it enacted by the Legislature of the County of Erie as follows:

#### SECTION 1. LEGISLATIVE INTENT AND OVERVIEW

It is the Erie County Legislature's intention to establish the Erie County Corrections Specialist Advisory Board (the "Advisory Board") to provide advice to, and oversight over the Erie County Sheriff Office's Jail Management Division which administers the Erie County Holding Center and the Erie County Correctional Facility.

In 2010 this Honorable Body created a Community Corrections Advisory Board ("CCAB") via legislative resolution following evaluation and investigation and a lawsuit by the U.S. Department of Justice against Erie County and the Erie County Sheriff deeming federal oversight of the Erie County Holding Center and Correctional Facility as necessary and in the public interest due to a myriad of issues at both facilities. The CCAB's purpose was "discussion of corrections facilities programs and services to offer suggestions and advice for the improvement of such programs at the Erie County Correctional Facility and the Erie County Holding Center." The Legislature also desired that the CCAB could help prevent further improper treatment at the facilities, and devise solutions to improve procedures and operations and provide a mechanism for oversight.

One of the major issues plaguing the Jail Management Division involves mentally-ill inmates and prisoners who may be suicidal or who are need in need of treatment while detained. The Erie County Department of Mental Health is administratively responsible for planning, directing, coordinating, and monitoring programs of prevention, treatment and rehabilitation involving detainees with mental health and/or intellectual or developmental disabilities and substance abuse services.

Over the intervening years, the state's regulator over local jails, the New York State Commission of Correction, has issued a series of critical reports over the Holding Center and Correctional Facility due to inmate escapes from custody, facility conditions, assaults on prisoners, mental health and healthcare deficiencies, and the deaths of prisoners or detainees in the custody of the Erie County Division of Jail Management. This includes a February 2018 report entitled "The Worst Offenders Report: The Most Problematic Local Correctional Facilities of New York State", that labeled the Holding Center and Correctional Facility as one of the "worst offenders for being in violation of state law."

For a variety of reasons, the CCAB did not function as hoped and expected and in 2013 the CCAB functionally stopped meeting or acting and was not subsequently convened.

Section 2205 of the Erie County Charter states: "Advisory boards shall meet at least four times per year, and meetings shall be held in compliance with the Open Meetings Law. If a board fails to hold the minimum number of meetings, the creating authority shall investigate why, and is authorized to remove an ineffective chair or any inactive members, or to recommend that the legislature abolish the board.

Because the CCAB has not met since 2013, and due to the host of problems, issues and concerns over the Erie County Holding Center and Correctional Facility, it is recommended that the Legislature create a new robust and inclusive corrections advisory board comprised of current and/or retired professionals who have expertise in criminal justice, public safety, restorative justice and reducing recidivism that will more effectively serve the people of Erie County.

The Advisory Board is intended to focus on restorative justice, serve as a bridge between the community, the Erie County Department of Mental Health, and the Erie County Sheriff's Office's Jail Management Division, and will be dedicated to enhancing the safety and conditions in the Erie County Holding Center and Correctional Facility. Its mission will be to bring leaders and professionals in our community together to help monitor and improve the County's correctional facilities, improve the lives of those who have left correctional facilities and reduce recidivism and help with re-entry to society, and work together for solutions to problems while continually looking for ways to improve internal operations and procedures in the correctional facilities.

# SECTION 2. CREATION OF AND MEMBERSHIP OF THE ERIE COUNTY CORRECTIONS SPECIALIST ADVISORY BOARD

The Erie County Corrections Specialist Advisory Board is hereby established.

#### Membership

The Advisory Board shall consist of eleven (11) voting members as follows:

- One member to be recommended by the Chair of the Erie County Legislature
- One member to be recommended by the Majority Leader of the Erie County Legislature
- One member to be recommended by the Minority Leader of the Erie County Legislature
- One member to be recommended by the Erie County Executive

- One member to be recommended by the Erie County Sheriff
- One member to be recommended by the Erie County Commissioner of Probation
- One member to be recommended by the Erie County Commissioner of Mental Health
- One member to be recommended by the Bar Association of Erie County
- One member with demonstrated experience in advocacy for prisoners to be recommended by an organization working on behalf of prisoners' rights
- One member with demonstrated experience with restorative justice to be recommended by an organization that is dedicated to restorative justice
- One member with demonstrated experience in assisting former offenders' transitions who is a former prisoner of a county or state holding/correctional facility to be recommended by an organization that is dedicated to ex-offender transition from jail/prison to life in the general public

Members shall be approved by a majority vote of the Erie County Legislature and shall serve without compensation.

## Terms of Advisory Board Members

Advisory Board members shall serve three-year terms. No member may serve more than two (2) consecutive terms, including the completion of a term of another voting member. Those who have served two (2) consecutive terms may be eligible again after a two (2) year absence to serve on the Board.

## SECTION 3. QUALIFICATIONS OF MEMBERS

All members must meet the minimum requirements set forth in Section 2205 of the Erie County Charter including:

- a. Each Advisory Board member shall be a resident of Erie County at the time of appointment and shall remain a resident of Erie County while holding a position as a member of the Advisory Board.
- b. Members of the Advisory Board may not hold elective office.

## SECTION 4. MEETINGS

At the first meeting of the Advisory Board the Board shall elect a member as chairperson, and another member as vice-chairperson. The chairperson and vice-chairperson shall serve in such positions for two years and may not serve more than two consecutive terms. The vice-chairperson shall serve in the absence of the chairperson and in such other capacity as the chairperson shall delegate.

The Advisory Board shall establish a schedule of regular meetings for the year, but the Advisory Board shall meet a minimum of four (4) times per year.

Unless otherwise provided by law, a majority of the members shall constitute a quorum at any duly held meeting of the Advisory Board. The affirmative vote of a majority of all members shall be required for Advisory Board action on any matter.

At each meeting of the Advisory Board, time will be set aside for public comment on issues relevant to the stated intent in the adopted bylaws of the Advisory Board. If no such individuals or organizations have contacted the Chairperson of the Advisory Board to request time to testify, the Advisory Board will forgo the time for public comment at that meeting of the Board. Requests to testify can be made to the Chairperson of the Advisory Board by filing such request with the Clerk of the Erie County Legislature at least five (5) business days prior to the Meeting of the Advisory Board.

#### SECTION 5. PROCEDURES.

The Advisory Board shall adopt standards of conduct and disclosure of interests intended to ensure that the actions of the Advisory Board are carried out in an ethical manner. The ethical standards shall be consistent with the Erie County Code of Ethics.

The Advisory Board may adopt such bylaws and/or rules and procedures for the efficient and orderly conduct of its business as it deems necessary or appropriate under Section 2205 of the Erie County Charter. Such rules and procedures shall provide reasonable opportunity for public comment and engagement.

The Advisory Board shall adopt bylaws that are not in conflict with Section 2205 of the Erie County Charter or any provisions of this Local Law, and subject to the approval of the Erie County Legislature.

It is hereby established, this local law does charge the Advisory Board the ability to design and enforce the bylaws under which such board will function. Bylaws must be in writing, filed with the Erie County Legislature, and open to inspection by members of the Advisory Board, the Erie County Legislature, and other elected officials. Bylaws may include, but are not limited to, the procedures for the taking of meeting minutes, the procedures for submitting grievances, the procedure for recommending the use of the Legislature's subpoena power, and the procedure for writing and submitting reports to the Erie County Legislature. Bylaws must be filed with the Erie County Legislature at least thirty (30) days prior to the first Advisory board meeting. In order to establish bylaws, the members of the Advisory Board must be in quorum, and at least seven (7) affirmative votes submitted. Amendments to the bylaws must be passed in quorum, with the affirmative vote of at least seven Advisory Board members.

The Advisory Board will produce, annually, a report on the progress of the Board for the previous year and their goals for the upcoming year. The report is to be filed with the Clerk of the Erie County Legislature and shall be reviewed by the Public Safety Committee of the Erie County Legislature.

## SECTION 6. POWERS AND FUNCTIONS

## **Powers**

The Advisory Board shall:

1. Function in an advisory capacity to the Erie County Legislature as well as to the Erie County's Sheriff's Office.

## The Advisory Board may:

- 1. Recommend that the Chairperson of the Erie County Legislature utilize his/her subpoena power under Section 2607 of the Erie County Charter, as necessary, to compel the presence and testimony of persons or the production of records to the Advisory Board when other mechanisms to compel such presence or data are otherwise unsuccessful through the following procedure:
  - (a) A formal recommendation suggesting utilization of the Legislature's subpoena power may be submitted to the Erie County Legislature's Public Safety Committee. After which, members of the Public Safety Committee shall vote on whether to submit the request to the Chair of the Erie County Legislature. Requests that pass by a majority vote of the Public Safety Committee shall then be submitted to the Chair of the Erie County Legislature for a final decision on the potential utilization of subpoena power.

## **Functions**

The Advisory Board may undertake functions and activities intended to:

- 1. Develop strategic plans and policies to be considered by the Legislature and the Sheriff's Office that will improve the conditions, systems and practices at the Erie County Holding Center and Correctional Facility and help reduce recidivism in Erie County.
- 2. Allow public comment on the issues related to the Erie County Holding Center and Erie County Correctional Facility
- 3. Make formal advisory recommendations to the County Legislature and the Erie County Sheriff's Office on the programs, funding and services for the correctional facilities in Erie County.
- 4. Receive complaints regarding the Erie County Holding Center and the Erie County Correctional Facility from the public and refer such complaints to the Public Safety Committee of the Legislature.

## SECTION 7. STAFF SUPPORT

The Chair of the Erie County Legislature shall choose amongst the staff of the Legislature one person to serve as Clerk of the Advisory Board. Such staff member will communicate with members, and the public through notices, regarding meetings, agendas and items that are before the Advisory Board. The Clerk will be responsible for taking the roll, recording votes of the members at meetings and communicating with groups seeking to testify before the Advisory Board. The Clerk will also be responsible for disseminating the minutes of the meetings to Advisory Board members and working with the Chair of the Advisory Board to produce an Annual Report to be filed with the Clerk of the Erie County Legislature and reviewed by the Public Safety Committee of the Erie County Legislature.

#### SECTION 8. EFFECTIVE DATE

This Local Law shall take effect upon filing with the New York Secretary of State.

#### SECTION 9. SEVERABILITY

If any clause, sentence, paragraph, subdivision, section or part of this Local Law or the application thereof, to any person, individual, corporation, firm, partnership, entity or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional such order of judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section, or part of this Local Law or in its application to the person, individual, corporation, firm, partnership, entity, or circumstance directly involved in the controversy in which such judgment or order shall be rendered.

(INTRO. 7-2, 2019)

# A RESOLUTION TO BE SUBMITTED BY LEGISLATORS LORIGO, DIXON, RATH & MILLS

WHEREAS, Governor Cuomo and the New York State Legislature have recently passed a ban on single use plastic bags provided to retail consumers, the second such statewide ban in the United States; and

WHEREAS, arguments in favor of the ban have cited the frequency with which plastic bags end up in the environment only to break down into harmful byproducts or be mistaken for food by wild animals; and

WHEREAS, the law limiting the use of plastic bags in New York State also authorizes local governments to impose as additional tax of \$0.05 on each paper bag used, now the only alternative to reusable bags; and

WHEREAS, to avoid the fee customers would be required to bring their own bags into the store to carry out their purchases; and

WHEREAS, these fees are nothing more than an additional convenience tax on the residents of New York State and Erie County, and for a region with nearly 15% of our residents living below the poverty line many of our people simply cannot afford to pay more taxes to New York State; and

WHEREAS, the imposition of the same tax on plastic bags was previously denounced by Governor Cuomo and the State Assembly in 2017 as being a regressive tax on poor consumers, the imposition of the same fee on paper bags would be just as burdensome to the people of Erie County; and

WHEREAS, this body does not object to necessary regulations to protect our environment but does acknowledge the industry concerns many retailers have expressed including an increase in theft, which is made easier thanks to opaque reusable bags, and the environmental impact of a complete switch to single use paper bags; and

WHEREAS, recycling laws and programs in New York State have progressed rapidly over the past 25 years since their introduction and continue to become more effective; and

WHEREAS, it is a finding of this body that we, as community leaders, should work towards encouraging better participation in and compliance with area recycling programs as well as voluntary commitment to the proper use of reusable shopping bags as opposed to imposing additional taxes on residents.

NOW, THEREFORE, BE IT

RESOLVED, that this honorable body hereby opposes the imposition of any additional taxes related to the use of paper bags; and be it further

RESOLVED, that this honorable body encourages residents to choose reusable bags whenever possible, and when it isn't possible this honorable urges residents to reuse and recycle their paper bags properly; and be it further

RESOLVED, that certified copies of this resolution be sent to Governor Andrew Cuomo, the Western New York Delegation to the New York State Legislature, County Executive Mark Poloncarz and any other party deemed necessary and proper.

WHEREAS, according to the National Conference of State Legislatures, in April 2019, New York State became the third state in the United States to enact legislation imposing a statewide ban on single-use plastic bags at retail stores; and

WHEREAS, the New York State Bag Waste Reduction Act establishes that county governments may opt-into the state law on paper bags by authorizing, effective March 1, 2020, a \$0.05 fee per paper bag sold/provided at certain stores and retail establishments to consumers, with \$0.03 (three cents) to be used by the state and \$0.02 (two cents) to be used by the county, with the county revenue only allowed to be used exclusively for the purchase and distribution of reusable bags to the local populace, with priority given to low-income and fixed-income persons; and

WHEREAS, under the New York State Bag Waste Reduction Act, low-income persons who receive public assistance such as the Supplemental Nutritional Assistance Program (SNAP, previously known as Food Stamps) and the Supplemental Nutrition Program for Women, Infants and Children (WIC) are exempted from the paper bag carry-out fee; and

RESOLVED, that in lieu of said fee, of which \$0.02 (or two cents) is required by the state law to be used by a County government to purchase and distribute reusable bags to the community, with priority to low-income and fixed-income populations, this Honorable Body requests that the Erie County Executive explore creating an environmental protection fund and an appropriation in the County's 2020 Budget for environmental initiatives; and be it further

RESOLVED, that certified copies of this resolution be transmitted to the Governor, the local delegation of the New York State Legislature, the County Executive, and any other party deemed necessary and proper.

# A RESOLUTION SUBMITTED BY LEGISLATORS RATH & MILLS

WHEREAS, New York State is considering provisions that would offer driver's licenses to otherwise undocumented immigrants living in the state; and

WHEREAS, over the past ten years, elected officials from Western New York, including Senator Kirsten Gillibrand and Lt. Governor Kathy Hochul, have openly opposed offering driver's licenses to undocumented immigrants; and

WHEREAS, this policy essentially directs every County Clerk to knowingly break federal laws when approving undocumented immigrants' applications; and

WHEREAS, a driver's license could be used by illegal immigrants for "cover" as Lt. Governor Kathy Hochul once said, by providing them a valuable form of identification, allowing them to entirely avoid federal immigration authorities; and

WHEREAS, the privilege to drive in New York is not absolute; and, violation of other sections of state law, completely unrelated to Vehicle and Traffic laws can have an impact on the validity of one's driver's license; and

WHEREAS, New York law currently allows for the revocation of a driver's license if the person identified has broken another law, like failing to pay child support; and

WHEREAS, a person's willingness to avoid following proper immigration procedure calls into question whether they are willing to avoid following other laws, like reporting their income taxes, purchasing proper insurance, or following New York's vehicle and traffic laws; and

WHEREAS, law enforcement would not be permitted to review the records of an undocumented immigrant who is pulled over in a routine traffic stop, but could do background checks on U.S. citizens creating a double standard; and

WHEREAS, it is the opinion of this body that the privilege to drive legally in New York State should be predicated on the driver being in New York State, and the United States of America, legally.

NOW, THEREFORE, BE IT

RESOLVED, this honorable body urges the New York State Legislature and Governor Cuomo to reject the proposal calling for the provision of licenses to undocumented immigrants; and be it further

RESOLVED, that this honorable body urges the Erie County Clerk follow all federal laws and provide driver's licenses to only legal citizens of the United States of America; and be it further

RESOLVED, that certified copies of this resolution be sent to the WNY Delegation to the New York State Senate and Assembly, Governor Andrew Cuomo, and any other party deemed necessary and proper.

MR. BRUSO moved to amend the resolution. MR. JOHNSON seconded.

WHEREAS, the presence of undocumented persons or persons who overstayed their legally-issued US visas is a federal immigration issue that requires the President and Congress to address and appropriately act, and not state or local governments.

NOW, THEREFORE, BE IT

RESOLVED, that due to several of the issues expressed in this resolution, the Erie County Legislature expresses its concerns with, and opposition to the "Green Light" state legislation for the issuance of New York State driver's licenses; and be it further

RESOLVED, that certified copies of this resolution be transmitted to the Governor, local delegation of the New York State Legislature, and any other party deemed necessary and proper.

## Dear Chairwoman Baskin:

In accordance with the obligations of the Erie County Attorney set forth in subsection 3, Section 204 of Article 2 of the Erie County Charter, this legal opinion concerns Local Law Intro No. 7-2-2019 (7-2).

## **Preemption**

Here, both New York State County Law Section 235 and Erie County Charter Section 2205 expressly grant local authority to create advisory boards. Since express authority to enact local legislation on this topic exists, there is no preemption issue to consider.

## Grammar

The stated purpose of 7-2 is to create an Erie County Corrections Specialist Advisory Board. We find the grammar and usage of 7-2 to be sufficient in order to achieve the stated purpose.

# **Ambiguities**

While every hypothetical circumstance or eventuality cannot be addressed in the scope of this opinion, 7-2 does not present any facial ambiguities that would frustrate its implementation and enforcement.

## Conclusion

We find that Local Law Intro. 7-2-2019 is sufficient as to form.
