WHEREAS, the Department of Health issued an RFP in the summer of 2022 and only received one response, First Student; and

WHEREAS, the new rate that First Student proposed to pay is \$112.21 per child per day, an increase over the current rate which is \$84.64; and

WHEREAS, approximately 850 children use this service at any one time and, without transportation service being available, these children would be unable to access critical services.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is hereby authorized to enter into a contract with First Student at an amount not to exceed \$112.21 per child per day; and be it further

RESOLVED, the Clerk of the Legislature shall forward certified copies of this Resolution to the County Executive, the Director of the Division of Budget and Management, the Office of the Comptroller, the County Attorney's Office, and Dr. Gale R. Burstein, the Commissioner of Health.
