WHEREAS, pursuant to proceedings heretofore had and taken in accordance with the provisions of Article 5-A of the County Law, including approving orders of the State Comptroller, County Sewer District No. 3 (the "Sewer District") of the County of Erie, New York (the "County"), has heretofore been established; and

WHEREAS, this County Legislature (the "Legislature") has heretofore duly directed that there be prepared a report and estimate of cost by the County Engineers (Erie County Department of Environment and Planning) relating to a proposed increase and improvement of the facilities of the Sewer District (the "Report"), which Report has been approved by the Board of Managers of the Sewer District on April 6, 2022, and filed with the Legislature pursuant to Section 268 of the County Law; and

WHEREAS, the Report describes a proposed increase and improvement of the facilities of the Sewer District, consisting of improvements to the Southtowns Advanced Wastewater Treatment Facility, existing pumping stations, and the sanitary sewer collection system, all as more fully described in the Report; and

WHEREAS, the total maximum estimated cost of the aforesaid increase and improvement of the facilities of the Sewer District is \$100,000,000, which will be apportioned in accordance with applicable flat charges and charges based on units, assessed value and footage specified in the Sewer District's Benefit and User Charge formulas, as such formulas currently exist and as the same may be amended from time to time; and

WHEREAS, pursuant to applicable provisions of Section 268 of the County Law, as amended by Chapter 397 of the Laws of 1995, the consent of the State Comptroller is required prior to the expenditure of funds for such increase and improvement because the estimated \$111.17 cost thereof to the Typical Property (as defined in the County Law) exceeds the applicable threshold for Average Estimated Cost for County Districts on similar types of expenditures, which was computed by the State Comptroller to be \$11.00 for calendar year 2022; and

WHEREAS, it is now desired to call a public hearing to consider such increase and improvement in accordance with the provisions of Section 254 of the County Law.

PLEASE TAKE NOTICE that a meeting of the County Legislature (the "Legislature") of the County of Erie, New York (the "County"), shall be held at the County Hall, 92 Franklin Street, 4th Floor, Buffalo, New York, in the County, on the 17<sup>th</sup> day of October, 2022, at 2:00 o'clock P.M., Prevailing Time, for the purpose of conducting a public hearing upon a proposed increase and improvement of facilities of Erie County Sewer District No. 3 in the County (the "Sewer District").

The proposed increase and improvement of such facilities consist of improvements to the Southtowns Advanced Wastewater Treatment Facility, existing pumping stations, and the sanitary sewer collection system; all as more fully described in the report and estimate of cost prepared by the County Engineers (Erie County Department of Environment and Planning) which has been filed with the County Legislature and which has been approved by the Board of Managers of the Sewer District on April 6, 2022 (the "Report").

The maximum estimated cost of such increase and improvement of facilities is \$100,000,000, which will be apportioned in accordance with applicable flat charges and charges based on units, assessed value and footage specified in the Sewer District's Benefit and User Charge formulas, as such formulas currently exist and as such may be amended from time to time.

The expenditures for such increase and improvement of facilities will not cause additional costs for property owners in the District for hook-up fees, and the annual cost of such expenditures to the Typical Property (as defined in the County Law) is estimated to be \$111.17 for the District. The Legislature has heretofore caused to be prepared and filed for public inspection with the Clerk of the Legislature a detailed explanation of how such costs were computed, as incorporated in the Report. WHEREAS, 485 enrollees far exceed the 110 Licensed Practical Nurse positions trained under the former Health Professional Opportunity Grant ("HPOG") program by 126% and far

surpassed the anticipated 250 ECHC enrollees for 2022, demonstrating the tremendous success of, and exceptional demand for, the ECHC program; and

WHEREAS, significant demand remains for additional healthcare staffing here in Erie County and across the United States; and

WHEREAS, SUNY Erie Community College and Erie County Medical Center have developed an innovative program that will further expand the ECHC program, and provide a faster and more efficient education-to-employment pipeline in our healthcare system; and

WHEREAS, Erie County hospitals, skilled nursing facilities, and other healthcare employers report a significant shortage of trained employees, contributing to hospital crowding and a lack of available beds; and

WHEREAS, further support of the ECHC program can bolster and expand the number of high-quality employees in high-demand, frontline healthcare positions across Erie County; and

WHEREAS, Erie County recently received \$16,050,531 in unbudgeted revenue for prioryear Gaming Facilities Aid owed to the State of New York and select municipalities which provides adequate funding to effectuate a replenishment of the vital ECHC program.

RE: Opposition to New Overtime Rules Being Imposed on Farmers (INTRO. 16-1)

# A RESOLUTION TO BE SUBMITTED BY LEGISLATORS LORIGO, GREENE, TODARO, & MILLS

WHEREAS, farmers are critical components of our regional economy and are necessary to ensure supermarkets and food pantries remain stocked with food; and

WHEREAS, from the outset of the COVID-19 pandemic, Western New York farmers have stepped up and ensured their operations continued and were responsible for donating thousands of pounds of food to local food banks at a time of significant need; and

WHEREAS, the farming industry faces a tremendous number of problems outside of their control including changes the weather, fluctuations in consumer demand, obtaining and retaining skilled labor, climate change, land management policies, foreign market competition, livestock and crop disease, and natural disasters; and

WHEREAS, in addition to the practical issues related to growing and selling food products, farmers in New York have to contend with wavering levels of government interference and regulations including changes in wages and overtime threshold; and

WHEREAS, the 2019 Farm Laborers Fair Practice Act, gave farmworkers a right to overtime after sixty (60) hours of work each week. Further, the law created the Farm Labor Wage Board and provided it with the ability to arbitrarily adjust the farm laborer overtime threshold at any time; and

WHEREAS, farms are reliant on migratory work forces during the short growing season here in New York. Workers are here for only a few months in the spring and summer. This shortened

season means fewer potential hours for farmworkers over the course of the year. Many of these workers reside in New York only on a seasonal basis. With fewer hours during our growing period there is little to tie them to our state or interest them in returning each year; and

WHEREAS, recently, the Farm Labor Wage Board voted 2-1 to lower the overtime threshold and recommend a forty (40) hour overtime rule for farmworkers, the decision went against a significant portion of testimony presented during their hearings over the past few years; and

WHEREAS, farming, unlike many other labor-intensive industries, cannot measure worker output simply by time on-the-clock in a predictable and manageable way. Crops can ripen practically overnight or a shift in weather can necessitate more hours in one week at the expense of time in the next. Imposing strict overtime rules on the entirety of the farming industry will harm our local growers, almost all of whom are locally owned; and

WHEREAS, this decision will make it even more difficult for local area farmers to remain profitable during our short growing season and could cause a cut to pay earned by farm laborers, who will be provided with fewer hours as opposed to overtime; and

WHEREAS, if farms are left to deal with these drastic labor cost increases, many of them may decide to move elsewhere. Additionally, the migrant workforce that comes to New York to work as many hours as possible will choose to work in neighboring states that do not share the same overtime rules in order to avoid the reduction in hours this rule will result in.

### NOW, THEREFORE, BE IT

RESOLVED, that this honorable body hereby calls on Governor Kathy Hochul and Labor Commissioner Roberta Reardon to reject the Farm Labor Wage Board ruling and work to support New York State farmers and farmworkers with the reasonable overtime rules currently in place; and be it further

RESOLVED, that this honorable body hereby supports farmers and migrant workers who do not want their hours reduced and urges Governor Kathy Hochul, if the Farm Labor Board's decision is allowed to remain, to increase the Farm Workforce Retention Tax Credit and implement a new farm overtime tax credit; and be it further

RESOLVED, that a certified copy of this resolution in opposition to further cuts to the farmworker overtime threshold is to be submitted to the NYS Department of Labor's open comment period for review by the Commissioner of the Department of Labor in making her determination; and be it further

RESOLVED, that certified copies of this resolution be sent to the Western New York Delegation to the New York State Senate and Assembly, Governor Kathy Hochul's office, the Department of Labor Commissioner Roberta Reardon, and any other party deemed necessary and proper.
