RE: Calling on NYSDEC to Investigate the Sheridan Park Crematory's Operations & Engage with Local Residents (INTRO. 17-1)

A RESOLUTION TO BE SUBMITTED BY LEGISLATORS HARDWICK & CHIMERA

WHEREAS, on September 9, 2020, local residents and at least one Town of Tonawanda government official observed and photographed thick, black smoke that emanated for one hour from the Sheridan Park Crematory at Amigone Funeral Home on Sheridan Drive in the Town of Tonawanda; and

WHEREAS, amidst public and local scrutiny, the crematory reopened in 2018 with new equipment that was supposed to prevent odors, soot and noise from emanating into the air, as the crematory is located mere feet away from a residential neighborhood; and

WHEREAS, a spokesperson for the New York State Department of Environmental Conservation ("DEC") has stated that "DEC's investigation into the cause of the smoke is ongoing. Additional information will be provided when it is available"; and

WHEREAS, the Chief Executive Officer of Amigone Funeral Homes, declined to answer questions about the incident when asked by a media outlet; and

WHEREAS, a full and transparent DEC investigation is necessary, and should include opportunities for neighboring residents to comment and provide input before the crematory is allowed to resume operations.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature requests the New York State Department of Environmental Conservation conduct or continue a thorough investigation into the September 9, 2020 incident at Sheridan Park Crematory that includes opportunities for neighboring residents to provide written or oral comments to DEC investigators; and be it further

RESOLVED, that this Honorable Body urges the DEC to prohibit the re-commencement of operations at the Crematory until public input is provided and the investigation is concluded; and be it further

WHEREAS, there are effects and consequences from these situations for the individual(s) who are being investigated, the first responders, the local government and the community as a whole; and

WHEREAS, to help reduce the risk of such incidents occurring in the future, it is necessary to understand the critical role that 911 call takers and dispatchers play in taking 911 calls from the public, and then disseminating information to and dispatching first responders including police, fire, and emergency medical services to help appropriately handle the situation, and if necessary, to de-escalate an incident in which a person may be mentally ill, physically ill, or intoxicated by drugs or alcohol.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature requests the Erie County Commissioners of Central Police Services and Mental Health and the Erie County Sheriff attend a forthcoming meeting of the Legislature's Public Safety Committee to discuss the protocols and measures associated with 911 calls into the County's Public Safety Campus and how call-takers address the calls and then transfer calls to relevant city, town, village, county and state law enforcement dispatchers for action; and be it further RESOLVED, that this Honorable Body expresses its concerns and intention to hold a hearing in the Public Safety Committee to discuss the nexus between 911 calls and how first responders are dispatched, to understand how persons that are mentally ill, physically ill, or intoxicated by drugs or alcohol can be best handled by first responders without the use of force by police officers being necessary; and be it further

A RESOLUTION TO BE SUBMITTED BY CHAIR BASKIN, LEGISLATORS MEYERS, HARDWICK, JOHNSON, CHIMERA, VINAL & GILMOUR

WHEREAS, Erie County has received \$160.3 million in federal funding under the Coronavirus Aid, Relief, and Economic Security (CARES) Act, for use in responding to the COVID-19 crisis; and

WHEREAS, according to the Poloncarz Administration's latest update reporting spending through September 1, 2020, \$62.5 million has been spent by the County, and \$67.7 million has been committed to be spent, including funds for schools, child care and day care, and eviction/foreclosure assistance; and

WHEREAS, there are looming concerns as the country enters the Autumn about a resurgence of COVID-19, in conjunction with influenza, and the return to schools and colleges of students; and

WHEREAS, during the COVID pandemic, there has been grave concerns about racial and socioeconomic equity, as communities, neighborhoods and persons of low income, and of color have been disproportionately negatively-affected by COVID, including deaths, injuries and lacking access to testing and health care resources; and

WHEREAS, Erie County should consider racial equity in the dissemination of personal protective equipment (PPE) to assist persons during the pandemic and get masks and other protective measures where they are needed the most; and

WHEREAS, the County should utilize additional CARES Act funds to purchase additional PPE and masks, as well as testing supplies and materials and distributing those items across our community, working in conjunction with primary care physicians and family medicine practitioners to educate and provide PPE throughout our community, including hard-hit communities with disproportionate health disparities and susceptibility to the Coronavirus; and

WHEREAS, in June 2020, the County assisted licensed local barber shops and hair salons to re-open their businesses by providing face shields for barbers and stylists' use as they returned to work in Phase Two of Gov. Cuomo's plan to reopen New York; and

WHEREAS, the Governor has allowed Erie County to resume public gatherings and some community-based groups such as block clubs, faith-based institutions, youth programs, and social service groups need PPE in order to hold their group meetings and activities.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature expresses its support for the County's continued allocation of CARES Act funding to provide essential needs and support to the community, and urges the County Administration to make spending commitments and procurements of personal protective equipment, masks, testing supplies and materials, and to work with primary

RESOLVED, that this Honorable Body calls for the establishment of an Erie County community organization PPE resource center for community groups and faith institutions to apply, be vetted, and be supplied with face masks, hand sanitizer, and COVID resources; and be it further

RESOLVED, that the same process should provide primary care physicians who service communities with impoverished residents with high rates of pre-existing health conditions with testing supplies and basic medical equipment; and be it further

RESOLUTION

Legislature of Erie County, amending the Erie County Sales and Use Tax Resolution which imposes taxes on sales and uses of tangible personal property and on certain services, and on occupancy of hotel rooms, admission charges and club dues, pursuant to Article 29 of the Tax Law of the State of New York, to continue the imposition of the additional 1% rate of tax and the additional ³/₄% rate of tax, pursuant to Article 29 of the New York Tax Law.

Be it enacted by the Legislature of the County of Erie, as follows:

Section 1. The first sentence of section two of the Erie County Sales and Use Tax Resolution, being a resolution adopted by the Board of Supervisors of the County of Erie as Item 8 of Meeting Number 31, held July 27, 1965, Supervisors Proceedings, page 666, as amended, is amended to read as follows:

SECTION 2. Imposition of sales tax. On and after March first, nineteen hundred eightynine, there is hereby imposed and there shall be paid a tax of three percent upon, and for the period commencing March first, nineteen hundred eighty-nine and ending November thirtieth, two thousand [twenty,] <u>twenty-three</u>, there is hereby imposed and there shall be paid an additional tax of one percent upon:

Section 2. Subdivisions (h) and (i) of section three of the Erie County Sales and Use Tax Resolution, being a resolution adopted by the Board of Supervisors of the County of Erie as Item 8 of Meeting Number 31, held July 27, 1965, Supervisors Proceedings, page 666, as amended, are amended to read as follows:

(h) With respect to the additional tax of 1 percent imposed for the period commencing March 1, 1989, and ending November 30, two thousand [twenty] <u>twenty-three</u>, the provisions of subdivisions (a), (b), (c), (d), (e), (f) and (g) of this section apply, except that for the purposes of this subdivision, all references in said subdivisions (a), (b), (d) and (e) to an effective date shall be read as referring to March 1, 1989, all references in said subdivision (a) to the date four months prior to the effective date shall be read as referring to November 1, 1988, and the reference in subdivision (b) to the date immediately preceding the effective date shall be read as referring to February 28, 1989.

Nothing herein shall be deemed to exempt from tax at the rate in effect prior to March 1, 1989, any transaction which may not be subject to the additional tax imposed effective on that date.

(i) The taxes imposed under subdivisions (a), (c) and (d) of Section 2 shall be paid at the rate of 3 percent upon all sales made and services rendered on or after December first, two thousand [twenty] <u>twenty-three</u>. With respect to the tax rate of 3 percent effective December first, two thousand [twenty] <u>twenty-three</u>, the provisions of subdivisions (b), (c), (d), (e) and (f) of this section apply, except that for the purposes of this subdivision, all references in said subdivisions (b), (c), (d) and (e) to an effective date shall be read as referring to December first, two thousand [twenty] <u>twenty-three</u>, and the reference in subdivision (b) to the date immediately preceding the effective date shall be read as referring to November thirtieth, two thousand [twenty] <u>twenty-three</u>. Nothing herein shall be deemed to exempt from tax at the rate in effect prior to December first, two thousand [twenty] <u>twenty-three</u>, any transaction which may not be subject to the lowered tax rate in effect on that date.

Section 3. Section four of the Erie County Sales and Use Tax Resolution, being a resolution adopted by the Board of Supervisors of the County of Erie as Item 8 of Meeting Number 31, held July 27, 1965, Supervisors Proceedings, page 666, as amended, is amended to read as follows:

SECTION 4. Imposition of compensating use tax.

(a) Except to the extent that property or services have already been or will be subject to the sales tax under this resolution, there is hereby imposed on every person a use tax for the use within this taxing jurisdiction on and after March first, nineteen hundred eighty-nine, except as otherwise exempted under this enactment, (A) of any tangible personal property purchased at retail, (B) of any tangible personal property (other than computer software used by the author or other creator) manufactured, processed or assembled by the user, (i) if items of the same kind of tangible personal property are offered for sale by him in the regular course of business, or (ii) if items are used as such or incorporated into a structure, building or real property, by a contractor, subcontractor or repairman in erecting structures or buildings, or building on, or otherwise adding to, altering, improving, maintaining, servicing or repairing real property, property or land, as the terms real property, property or land are defined in the real property tax law, if items of the same kind are not offered for sale as such by such contractor, subcontractor or repairman or other user in the regular course of business, (C) of any of the services described in paragraphs (1), (7), and (8) of subdivision (c) of section 2, (D) of any tangible personal property, however acquired, where not acquired for the purposes of resale, upon which any of the services described under paragraphs (2), (3) and (7) of subdivision (c) of section 2 have been performed, (E) of any telephone answering service described in subdivision (b) of section 2, and (F) of any computer software written or otherwise created by the user if the user offers software of a similar kind for sale as such or as a component part of other property in the regular course of business.

(b) For purposes of clause (A) of subdivision (a) of this section, the tax shall be at the rate of four percent, and on and after December first, two thousand [twenty] <u>twenty-three</u>, the tax shall be at the rate of three percent, of the consideration given or contracted to be given for such property, or for the use of such property, including any charges for shipping or delivery as described in paragraph three of subdivision (b) of section one, but excluding any credit for tangible personal property accepted in part payment and intended for resale.

(c) For purposes of subclause (i) of clause (B) of subdivision (a) of this section, the tax shall be at the rate of four percent, and on and after December first, two thousand [twenty] <u>twenty-three</u>, the tax shall be at the rate of three percent, of the price at which items of the same kind of tangible personal property are offered for sale by the user, and the mere storage, keeping, retention or withdrawal from storage of tangible personal property by the person who manufactured, processed or assembled such property shall not be deemed a taxable use by him.

(d) For purposes of subclause (ii) of clause (B) of subdivision (a) of this section, the tax shall be at the rate of four percent, and on and after December first, two thousand [twenty] <u>twenty-three</u>, the tax shall be at the rate of three percent, of the consideration given or contracted to be given for the tangible personal property manufactured, processed or assembled into the tangible personal property the use of which is subject to tax, including any charges for shipping or delivery as described in paragraph three of subdivision (b) of section one.

(e) Notwithstanding the foregoing provisions of this section, for purposes of clause (B) of subdivision (a) of this section, there shall be no tax on any portion of such price which represents the value added by the user to tangible personal property which he fabricates and installs to the specifications of an addition or capital improvement to real property, property or land, as the terms real property, property or land are defined in the real property tax law, over and above the prevailing normal purchase price prior to such fabrication of such tangible personal property which a manufacturer, producer or assembler would charge an unrelated contractor who similarly fabricated and installed such tangible personal property to the specifications of an addition or capital improvement to such real property or land.

(f) For purposes of clauses (C), (D) and (E) of subdivision (a) of this section, the tax shall be at the rate of four percent, and on and after December first, two thousand [twenty] <u>twenty-three</u>, the tax shall be at the rate of three percent, of the consideration given or contracted to be given for the service, including the consideration for any tangible personal property transferred in conjunction with the performance of the service and also including any charges for shipping and delivery of the property so transferred and of the tangible personal property upon which the service was performed as such charges are described in paragraph three of subdivision (b) of section one.

(g) For purposes of clause (F) of subdivision (a) of this section, the tax shall be at the rate of four percent, and on and after December first, two thousand [twenty] <u>twenty-three</u>, the tax shall be at the rate of three percent, of the consideration given or contracted to be given for the tangible personal property which constitutes the blank medium, such as disks or tapes, used in conjunction with the software, or for the use of such property, and the mere storage, keeping, retention or withdrawal from storage of computer software described in such clause (F) by its author or creator shall not be deemed a taxable use by such person.

Section 4. Section four-A of the Erie County Sales and Use Tax Resolution, being a resolution adopted by the Board of Supervisors of the County of Erie as Item 8 of Meeting Number 31, held July 27, 1965, Supervisors Proceedings, page 666, as amended, is amended to read as follows:

SECTION 4-A. Imposition of additional rate of sales and compensating use taxes.

In addition to the sales and compensating use taxes imposed by sections 2 and 4 of this resolution, there is hereby imposed and there shall be paid an additional three-quarters of one percent rate of such sales and compensating use taxes, for the period beginning December 1, 2009 and ending November 30, [twenty] twenty-three. Such additional taxes shall be identical to the taxes imposed by such sections 2 and 4 and shall be administered and collected in the same manner as such taxes. All of the provisions of this resolution relating or applicable to the administration and collection of the taxes imposed by such sections 2 and 4 shall apply to the additional taxes imposed by this section, including the applicable transitional provisions, limitations, special provisions, exemptions, exclusions, refunds and credits as are set forth in this resolution, with the same force and effect as if those provisions had been incorporated in full into this section and had expressly referred to the additional taxes imposed by this section; provided that net collections from such additional rate shall be set aside for county purposes as provided in subdivision (f) of section 14 of this resolution.

Section 5. Subdivisions (D) and (E) of clause (1) of section 11 of the Erie County Sales and Use Tax Resolution, being a resolution adopted by the Board of Supervisors of the County of Erie as Item 8 of Meeting Number 31, held July 27, 1965, Supervisors Proceedings, page 666, as amended, are amended to read as follows:

(D) With respect to the additional tax of one percent imposed by section 4 of this resolution for the period beginning March first, nineteen hundred eighty-nine, and ending November thirtieth, two thousand [twenty] <u>twenty-three</u>, in respect to the use of property used by the purchaser in this County prior to March first, nineteen hundred eighty-nine.

(E) With respect to the additional tax of three-quarters of one percent imposed by section 4-A of this resolution, for the period beginning December 1, 2009 and ending November 30, [twenty] twenty-three, in respect to the use of property used by the purchaser in this county prior to January 15, 2006.

Section 6. Subdivision (f) of section 14 of the Erie County Sales and Use Tax Resolution, being a resolution adopted by the Board of Supervisors of the County of Erie as Item 8 of Meeting Number 31, held July 27, 1965, Supervisors Proceedings, page 666, as amended, is amended to read as follows:

(f) Net collections from the additional three-quarters of one percent rate of taxes imposed during the period commencing December 1, 2009 and ending November 30, two thousand [twenty] <u>twenty-three</u>, by section 4-A of this resolution received by the county shall be used by the county solely for county purposes and shall not be subject to any revenue distribution agreement entered into pursuant to the authority of subdivision (c) of section 1262 of the Tax Law.

Section 7. Subdivision (g) of section 14 of the Erie County Sales and Use Tax Resolution, being a resolution adopted by the Board of Supervisors of the County of Erie as Item 8 of Meeting Number 31, held July 27, 1965, Supervisors Proceedings, page 666, as amended, is amended to read as follows:

(g) The County shall allocate each calendar year the first twelve million five hundred thousand dollars (\$12,500,000) of the net collections from the additional one percent rate of sales and compensating use taxes imposed during the period commencing December 1, [2017] 2020, and ending November 30, [2020] 2023, by sections 2 and 4 of this resolution to the cities of the County and the area in the County outside the cities and such net collections shall be applied or distributed in the same manner and proportion as the net collections for such cities and area are applied or distributed under the revenue distribution agreement entered into pursuant to the authority of subdivision (c) of section 1262 of the Tax Law in effect on January 1, 2006, and shall be subject to all provisions of such agreement governing the net collections for such cities and area, and the County shall retain the remainder of net collections from such additional one percent rate which shall be used by the County for any County purpose and such remainder shall not be subject to any revenue distribution agreement entered into pursuant to the authority of subdivision (c) of section 1262 of the Tax Law.

Section 9. This enactment shall take effect December first, two thousand twenty.
