**RESOLUTION NO. 170** 

RE: Naming New Sled Hill at Como Lake Park in Honor of Frank Maddock (INTRO. 18-1)

### A RESOLUTION SUBMITTED BY LEGISLATOR BRUSO

WHEREAS, Como Lake Park, named after the Lake Como tourist resort in Italy, originally was established by the Village of Lancaster in 1923 and was acquired by Erie County in 1926 as the result of a special village election; and

WHEREAS, the proverbial center of the park is the lake which once was the jewel of Como Park, and which is fed by Cayuga Creek; and

WHEREAS, the lake has been full of silt and sediment for years, leading to very little water in the lake; and

WHEREAS, one of the foremost advocates, if not the greatest advocate for improvements at Como Lake Park, including to the dam, the dredging of the lake, and other park improvements, is Depew resident Frank Maddock; and

WHEREAS, Frank Maddock has been a long-standing civic activist, government watchdog, and community volunteer for decades, serving the Lancaster and Depew communities; and

WHEREAS, born in Pittsburgh, but a long-time resident of Lancaster, Mr. Maddock has been a long-standing presence at local government meetings and community gatherings, providing critical commentary and advice to successive government officials and leaders; and

WHEREAS, in part due to his dogged activism and advocacy, in 2017 and 2018, the County replaced damaged lower-level gates in the lake dam, drained the lake in 2018 to conduct sediment testing, and began dredging of the lake in August 2019; and

WHEREAS, the silt that is being removed during the dredging is being used to surface and grade a new sledding hill in Como Lake Park for public recreation in the winter months.

### NOW, THEREFORE, BE IT

RESOLVED, that the new sledding hill in Como Lake Park shall henceforth be known as the "Frank Maddock Sled Hill", and be marked appropriately with signage; and be it further

RESOLVED, that the Department of Parks, Recreation and Forestry is authorized to install signage to identify the new Frank Maddock Sled Hill at Como Lake Park; and be it further

RESOLVED, that certified copies of this resolution be sent to the County Executive's Office; the County Attorney; the Commissioner of Parks, Recreation and Forestry and the Commissioner of the Department of Environment and Planning.

RE: Protecting the Users of Erie County Parks from Lead (INTRO. 18-2)

## A RESOLUTION SUBMITTED BY LEGISLATORS BASKIN, BRUSO, HARDWICK, MEYERS, JOHNSON & CHIMERA

WHEREAS, on July 24, 2019, the Office of the Erie County Comptroller sent a letter to the County Executive stating that "an independent laboratory has confirmed the existence of lead paint on playground equipment in multiple county parks"; and

WHEREAS, the Comptroller's Office recommended that action be taken to address this alleged lead threat; and

WHEREAS, on July 25, 2019, the Commissioner of Health responded to the Comptroller in a letter stating that she immediately directed action by a lead program sanitarian to inspect all playground equipment as well as other habitable structures in the County's parks system, with inspections occurring on July 24<sup>th</sup> and 25<sup>th</sup>, and stating that any items found contaminated with lead will be slated for removal; and

WHEREAS, the Health Commissioner noted that her department has "not discovered any incidences or lead poisoning related to lead exposure from any county facility, including our parks system"; and

WHEREAS, this Honorable Body supports immediate measures to protect the health and safety of all users of our parks and facilities, including especially children.

## NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature expresses its support for, and requests that the Erie County Departments of Health and Parks, Recreation and Forestry work together with any other necessary County agencies or units to immediately identify any lead hazards in County-owned and

operated parks and other facilities, and to then remediate and/or remove any lead hazards in parks, such as playground equipment; and be it further

RESOLVED, that certified copies of this resolution be transmitted to the County Executive, and the Departments of Health, Parks, Recreation and Forestry, Public Works, and the Comptroller's Office.

RE: Opposition to Proposed State-Mandated Replacement Fee on License Plates (INTRO. 18-4)

## A RESOLUTION SUBMITTED BY LEGISLATOR BRUSO

WHEREAS, for many years, through no fault of their own, many New Yorkers have experienced problems with their vehicle license plates, in which the paint and numbers have been peeling away, making many license plates illegible and threatening to subject those drivers with law enforcement sanctions or action; and

WHEREAS, those bad license plates were designed or printed poorly by the State, leading to the peeling of the license plates, in many instances, within months of their use, and this has been a problem for many years; and WHEREAS, on August 19, 2019, the Governor's office announced that the State will remove older blue and white license plates from use across the state, and will mandate their replacement with new license plates starting in April 2020; and

WHEREAS, the State Department of Motor Vehicles, the Governor's office and the Governor, at an appearance in Niagara County on August 20<sup>th</sup> each said that the State is effectuating this mandated change because the older and often peeling license plates are difficult to read for EZ Pass, cashless tolls, police license plate readers and red-light cameras; and

WHEREAS, as part of the roll-out of the new license plates, the State Department of Motor Vehicles will impose a \$25 license plate replacement fee to the cost of the vehicle registration, as well as impose a \$20 fee if a motorist desires to retain their existing license plate number; and

WHEREAS, this measure which will be imposed on an estimated 3 million drivers who have the blue and white license plates, will generate an estimated \$75 million in revenue for the State, just from the new \$25 fee alone; and

WHEREAS, the Cuomo administration is characterizing this measure as a "fun" thing by initiating a contest in which New Yorkers can vote on a replacement license plate design featuring the Statue of Liberty, Niagara Falls, the New York City skyline, and the new Mario Cuomo Bridge over the Hudson River; and

WHEREAS, bipartisan members of the State Legislature have already expressed concern and opposition to the fee and the manner in which the State is announcing this action which is yet again, another State mandate and fee imposed on residents.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature expresses its opposition to this new Stateimposed, State-mandated \$25 fee for a new license plate and urges the Governor to not impose any new fee for a State-mandated change targeted at license plates that are legible and usable; and be it further

RESOLVED, that this Honorable Body urges the State Department of Motor Vehicles to offer drivers, free of charge, replacement license plates for defective, peeling license plates that are hard to read through no fault of the driver; and be it further

RESOLVED, that certified copies of this resolution be transmitted to the Governor, the State Commissioner of Motor Vehicles, the local delegation of the State Legislature, and the Erie County Clerk.

MR. BRUSO moved to amend the resolution by including Et Al Sponsorship and for content. MR. LORIGO seconded.

RE: Expressing Outrage and Opposition to Racist Flyers Disseminated in our Community (INTRO. 18-5)

## A RESOLUTION SUBMITTED BY LEGISLATORS MEYERS, HARDWICK, JOHNSON, BRUSO, BASKIN & CHIMERA

WHEREAS, in the past two years there has been a noticeable and troubling development in which racist flyers and literature have been dropped in the yards, doors, mailboxes and vehicles of persons in Niagara and Erie Counties; and

WHEREAS, in the most recent instances, in March 2019, a local hate group with a PO Box in Lockport distributed white supremacist leaflets around the Parkside community in Buffalo with the banner "Racial Nationalist Manifesto"; and

WHEREAS, in April 2019, officials from Lewiston-Porter Central School District said the district was "the target of a vile, defamatory and racist flyer" mailed from Buffalo which had the words "Aryan Revival" and included swastikas and the phrases: "Welcome to Racist Lewiston" and "spring membership drive" and disparaged African-Americans; and

WHEREAS, that mailing followed a May 2017 incident in which flyers appeared at homes in Lewiston that said, "The Aryan Resistance is proud to endorse Board of Education candidates," listing the names of two individuals who subsequently disavowed the printing and the group; and

WHEREAS, in May 2019, for the second time in recent weeks, an offensive flyer containing swastikas and other racist content was found in Lewiston, glued to an outer wall of the Lewiston Public Library; and

WHEREAS, in April 2019, an Indian-American activist and researcher in Amherst received a flyer in his mailbox stating "Take your BROWN ARMY and LEAVE OUR TOWN"; and

WHEREAS, in July 2019, a number of homes and businesses in the Town of Tonawanda, City of Tonawanda and City of North Tonawanda had flyers posted on doors, potentially as an attempted recruitment effort by Racial Nationalist Party of America, Aryan Renaissance Society and the KKK, inviting residents to an event on August 31 in Indiana; and

WHEREAS, Tonawanda leaders said this is the fifth known door to door canvassing in the area; and

WHEREAS, in August 2019, flyers from a white nationalist organization calling itself the Racial Nationalist Party of America were discovered in driveways and in front of homes in Cheektowaga; and

WHEREAS, on August 19, 2019, the Cheektowaga Police Department announced that it had identified the man who admitted dropping the leaflets and had issued him a summons for littering but could not file criminal charges, with the man saying he is going to continue to produce or disseminate such hate-filled literature; and

WHEREAS, it is essential that this Honorable Body go on record as deploring these hateful, racist groups and the vile messages that they communicate in our community.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature hereby expresses its concern, and opposition to racism, bigotry and hatred of any kind, including the unwanted flyers and leaflets disseminated in our community recently; and be it further

RESOLVED, that this Honorable Body condemns the hate-filled intent and messages expressed by white supremacists and groups such as the Racial Nationalist Party of America, Aryan Renaissance Society, the KKK, just to name a few, and urges all members of the community to stand together against racism and bigotry and to take note of the many wonderful achievements and contributions that persons of all faiths, creeds, ethnicities and races have made in our area.

MR. BRUSO moved to amend the resolution by including Et Al Sponsorship. MR. LORIGO seconded.

**RESOLUTION NO. 174** 

RE: Requesting New York State Fund State-Mandated Early Voting Costs for EC (INTRO. 18-6)

### A RESOLUTION SUBMITTED BY LEGISLATORS BRUSO & HARDWICK

WHEREAS, New York was among the worst 10 states for turnout in both the 2016 and 2018 elections, continuing a long trend of lower-than-average voter participation; and

WHEREAS, prior to this year, New York State was only one of twelve states not to have early voting; and

WHEREAS, both houses of the New York State Legislature approved early voting legislation on January 14, 2019; and

WHEREAS, Governor Andrew Cuomo commended the State Legislature for taking "quick action" on the issue and noted "Early voting will be transformative for the system...at a time when the federal government is doing everything it can to disenfranchise voters, we are taking action to make it easier for New Yorkers to participate in the democratic process and crack down on corporate influences in our elections"; and

WHEREAS, at the time of passage, the New York State Association of Counties noted that county governments do not have the money to pay for the costs associated with in-person early voting and asked the Governor and Legislature to add funding in the 2019-2020 state budget; and

WHEREAS, the election reforms require officials to establish 9 days of early voting that ends two days before the election and includes two full weekends and which requires counties paying for elections staff and elections inspectors to establish early voting; and

WHEREAS, according to the original State funding formula, counties will receive \$15,000 for each early voting poll site, plus additional funding that would be distributed based on voter enrollment; and

WHEREAS, counties are required to have one polling site for every 50,000 registered voters; and

WHEREAS, according to a plan put forward by the Erie County Board of Elections to implement early voting in Erie County, the county would have ten early voting sites in the city of Buffalo and twenty-seven outside the city; and

WHEREAS, universal voting allows all thirty-seven sites to print any ballot so voters can go to the early voting site that is most convenient for them during the early voting period of October 26-November 3, 2019; and

WHEREAS, according to the original State funding formula, Erie County would be eligible for nearly \$1.9 million in State grant funding for early voting; and

WHEREAS, the State has approved reimbursing Erie County \$1.1 million for early voting costs, and the Erie County Board of Elections has stated that the State has authorized additional grant funding of \$874,000 but the New York State Division of the Budget has not yet signed-off on that second grant; and

WHEREAS, on August 22, 2019, the State Board of Elections notified counties that the State Division of the Budget was not releasing full funding to county governments for early voting and had not yet approved the full funding for early voting and for more early voting locations (such as the Erie County Board of Elections' plan for 37 early voting sites); and

WHEREAS, the Erie County Board of Elections estimates that the cost for early voting in Erie County will be approximately \$3 million, which exceeds the State funding; and

WHEREAS, the failure of the State Division of the Budget to authorize the second grant, and the State's overall failure to reimburse Erie County for the full cost of the State-mandated early voting would result in hardship for Erie County taxpayers if the County is forced to make up the funding difference.

## NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature respectfully requests that the New York State Division of the Budget release the second grant funding of \$874,000 for early voting for Erie County; and be it further

RESOLVED, that this Honorable Body asks the Governor and the State Division of the Budget to approve the Erie County Board of Elections' early voting plan and appropriate State funds to fully reimburse Erie County for the costs of the State-mandated early voting and to support the intention of maximizing voter turnout and engagement with the 37 early voting sites in our county; and be it further

RESOLVED, that certified copies of this resolution be transmitted to the Governor, the local delegation of the New York State Legislature, to the State Budget Director, and to the Erie County Commissioners of Elections.

MR. BRUSO moved to amend the resolution by including Et Al Sponsorship. MR. LORIGO seconded.

## A RESOLUTION TO BE SUBMITTED BY LEGISLATOR BASKIN

WHEREAS, the development, expansion and promotion of tourist travel to Erie County are of great benefit to the citizens of Erie County; and

WHEREAS, tourism spending in Erie County is reflected in bed and sales tax collections, as well as spurring a positive economic impact on amateur and professional sporting events, shopping, arts and culture and the hospitality industry; and

WHEREAS, this positive impact helps hold down property taxes and spurs economic growth and job creation; and

WHEREAS, in 1977, the New York State Legislature enacted the New York State Tourism Promotion Act to enable counties in the state to draw down funds to support their marketing and advertising campaigns; and

WHEREAS, the Tourism Promotion Act authorizes the state's Department of Economic Development to operate a program of matching state funds for non-profit tourism promotion agencies designated by county legislative bodies as agencies that are authorized to apply for and receive grants for recognized media advertising programs; and

WHEREAS, Visit Buffalo Niagara (VBN) – formerly known as the Buffalo Niagara Convention and Visitors Bureau – has done a commendable job bringing together a diverse array of non-profit organizations, attractions, retail businesses and members of the hospitality industry to work collaboratively for the benefit of our entire region.

### NOW, THEREFORE, BE IT

RESOLVED, that Visit Buffalo Niagara (VBN), having served as Erie County's tourism promotion agency since 1974, is hereby re-designated as such for 2019-2020; and be it further

RESOLVED, that this Honorable Body requests that Visit Buffalo Niagara submit the appropriate application to the New York State Department of Economic Development for state matching funds to assist VBN to finance its tourism marketing, media relations and advertising campaigns as set outlined in the New York State Tourism Promotion Act; and be it further

RESOLVED, that officials of Visit Buffalo Niagara are hereby requested to appear at a future meeting of the Legislature's Community Enrichment Committee to discuss the status of the aforementioned state matching fund grants and other matters relating to the promotion of tourist visitation in Erie County and the Buffalo Niagara Region; and be it further

RESOLVED, that certified copies of this resolution be sent to the Commissioner of the New York State Department of Economic Development, Patrick Kaler and Karen Fashana of Visit Buffalo Niagara, the tourism committees of both the New York State Assembly and Senate, County Executive Mark Poloncarz, Thomas Hersey Jr., of the Department of Environment and Planning, and all other deemed necessary and proper.

RE: Urging the Governor to Waive State-Authorized Fee Associated with License Plate Replacement & Support for State Legislation to Permanently Waive Associated Fees (INTRO. 18-8)

## A RESOLUTION TO BE SUBMITTED BY LEGISLATORS LORIGO, RATH, DIXON & MILLS

WHEREAS, Governor Cuomo's administration recently announced plans to redesign New York State license plates; and

WHEREAS, Governor Cuomo announced the plan indicating that cashless tolling, red light camera technology is incapable of scanning some existing license plates, an assertion that has been shown to be unfounded as current New York State license plates are scanned by said technology without error; and

WHEREAS, due to its close proximity to Canada, numerous Canadian motorists frequently cross the international border into Erie and Niagara Counties, passing cashless tolling sites without a mechanism in place to collect tolls from said motorists; and

WHEREAS, these aforementioned occurrences are inherently unfair to New York State motorists who are expected and required to pay when passing cashless tolling sites; and

WHEREAS, New York State motorists should not carry the burden of refunding the state for its implementation of an inefficient cashless tolling system; and

WHEREAS, Governor Cuomo could exercise his executive authority to set the plate replacement fee at a cost between \$0 and \$25 dollars, provided for in Vehicle and Traffic Law § 401(3) which states, "An additional fee, not to exceed twenty-five dollars, shall be paid to the commissioner whenever a set of reflectorized number plates is issued for any vehicle..."; and

WHEREAS, Senate Bill S6663 has been recently proposed to require the Department of Motor Vehicles commissioner to waive the \$25 fee for any license plate mandated for replacement by the state due to a design change.

WHEREAS, in exchange for funding and the lease of state owned property and equipment, Tesla promised to create at least 1,460 high-tech jobs, 2,000 additional jobs relating to the sale and installation of the company's solar panels, and 1,440 support jobs in New York State; and

WHEREAS, five years have passed since the funding was initially provided to Tesla. Since that time the promises for jobs have been slashed by state officials and the quality of jobs created has been watered down to the point where any new job would qualify; and WHEREAS, requests by media to examine the operations of the plant have been referred to as a dog and pony show, where smoke and mirrors are used to cover up the actual activity, or lack thereof, being conducted by Tesla; and

WHEREAS, repeated requests for a tour from local elected officials have been denied; and

WHEREAS, this honorable body finds the lack of transparency and accountability over the situation at Tesla disturbing. Any other entity that lends funding to a corporation with the expectation of a specific return would have commenced legal proceedings against Tesla by now. There seems to be no knowledge as to where the state funding was spent or what the equipment owned by New York State is currently doing; and

WHEREAS, the residents of New York deserve answers and clarity into what their investment bought; and

WHEREAS, a 2016 report from State Comptroller DiNapoli's office, auditing the NYS Excelsior Jobs Program, found that economic development staff routinely lowered the number of jobs required in contracts before companies fell short of meeting the initial targets; and

WHEREAS, it is a finding of this body that Tesla has consistently failed to make good on its promises regarding the operations at Riverbend; and

WHEREAS, it is a further finding of this body that New York State officials have routinely lowered stated targets for employment at the Riverbend site; and

WHEREAS, the residents of New York State have not gotten what they have paid for, and it is up to their elected representatives to ensure waste of taxpayer resources does not continue; and

WHEREAS, media reports in recent weeks indicate that Comptroller DiNapoli is auditing high-tech companies that operate in New York and part of that audit is to focus on the Tesla plant here in Erie County. New York's taxpayers deserve to know if there is an on-going audit and what the details of that process are.

NOW, THEREFORE, BE IT

RESOLVED, that this honorable body hereby calls for New York State Comptroller DiNapoli to perform a full audit of the operations being conducted by Tesla at the Riverbend plant; and be it further

RESOLVED, that if the indications are correct, and the already on-going audit of high-tech industry will include Tesla, this honorable body hereby urges Comptroller DiNapoli to make Tesla and SolarCity the focus of the audit and to specifically include the information as requested in this Resolution; and be it further

funding; an accounting of the fixtures and equipment located inside the Riverbend factory whether owned by Tesla, New York State, or any other third party; the production rate of products coming out of the Riverbend factory since the start of SolarCity's operations through to the present; any information regarding any sale or lease of any floor-space inside the Riverbend factory to any thirdparty, including a full accounting of any payment for said floor space made to either New York State or Tesla; and the status of job creation by SolarCity/Tesla since 2014, including the number of jobs created, the types of jobs created, the salaries for those types of jobs, and a comparison between what the state has received and what the initial expectations were; and be it further

WHEREAS the law requires that beginning the tenth day prior to any election and ending on and including the second day prior to election all persons duly qualified and registered to vote shall be permitted to vote; and

WHEREAS on June 6, 2019 the Commissioners of the New York State Board Elections have approved electronic poll book vendors; and

WHEREAS the purpose of a poll book is to provide voter registration lists for each poll site and allows Election Inspectors to provide voters with correct ballots; and

WHEREAS to carry out the nine days of Early Voting in New York State beginning on October 26, 2019 and running through November 3, 2019 electronic poll books are needed for Erie County's early voting sites; and

WHEREAS New York State has provided funding to Erie County in the amount of \$1,074,106.06 to purchase electronic poll books and ancillary equipment from New York State approved vendors through the Electronic Poll Book Capital Grant Project; and

WHEREAS the Erie County Board of Elections (ECBOE) must enter into a contract with the New York State Board of Elections in order to purchase electronic tablets, operating system software for electronic poll books, training for operating system software, and ancillary devices to successfully conduct early voting; and

WHEREAS, the purchase of such equipment and services are eligible for one-hundred percent (100%) reimbursement from the State of New York up to the amount of \$ 1,074,106.06.

#### NOW, THEREFORE, BE IT

RESOLVED, that authorization is granted for the Board of Elections to enter into an agreement with the NYS Board of Elections in an amount not to exceed \$1,074,106.06; and be it further

RESOLVED, that the ECBOE will submit necessary paperwork for State reimbursement for 100% of the purchase price of eligible equipment and services; and be it further

RESOLVED, that the Erie County legislature approves that the ECBOE execute all necessary contracts with approved vendors for electronic poll books, training, and any ancillary equipment necessary to conduct Early Voting in Erie County; and be it further

RESOLVED, that authorization is hereby granted to the Division of Budget and Management to create a new grant and budget and make the following adjustments to the 2019 Budget of the ECBOE:
