Each local government unit or direct contract provider receiving such funding shall have flexibility in allocating such funding to support salary increases to particular job titles to best address the needs of its direct care staff, direct support professionals and clinical staff. Each local government unit or direct contract provider receiving such funding shall also submit a written certification, in such form and at such time as each commissioner shall prescribe, attesting to how such funding will be or was used for purposes eligible under this section. Further, providers shall submit a resolution from their governing body to the appropriate commissioner, attesting that the funding received will be used solely to support salary and salary-related fringe benefit increases for direct care staff, direct support professionals and clinical staff, pursuant to paragraph (i) of this subdivision. 2. INTRO. 17-7 (2020)

BASKIN, JOHNSON, MEYERS, CHIMERA & VINAL

WHEREAS, solitary confinement is the practice of isolating detainees in closed cells for 23-24 hours a day, virtually free of human contact, and with limited access to recreation or being outside of an enclosed space for periods of time ranging from days to weeks, months or years in sum; and

WHEREAS, in New York State, long-term solitary confinement units are often referred to as Special Housing Units and according to the New York Campaign for Alternatives to Isolated Confinement (NYCAIC), there are approximately 4,000 prisoners in New York State prisons and jails in solitary confinement units on any given day; and

WHEREAS, the New York State Department of Corrections and Community Supervision has reported a current "keep-lock" number of 479 prisoners kept in isolation for 23 hours per day and in 2018, the latest reported public year, there were 38,249 instances of prisoners kept in isolated confinement (including prisoners sent to isolation repeatedly), showing the State's use of isolation is significant; and

WHEREAS, solitary confinement cells generally measure from 6 x 9 to 8 x 10 feet, and some have bars, but more often they have solid metal doors, with meals generally being transmitted through slots in these doors, as do any communications with prison staff and in Special Housing Units, prisoners are denied access to communal religious worship and educational programming; and

WHEREAS, within these cells, prisoners live lives of enforced idleness, required to stay in the cell for 23 hours per day or longer, and denied the opportunity to work or attend prison programming, and sometimes banned from having televisions, radios, art supplies, and reading materials; and

WHEREAS, data shows that suicide attempts and deaths of prisoners while incarcerated in solitary confinement are much higher than those of prisoners in the general population or the public; and

WHEREAS, according to NYCAIC, between 2015-2019, the rate of suicide by persons in solitary confinement was more than five times the rate for the rest of the New York prison population and in 2019, at least one third of all suicides occurred in solitary confinement and the rate of suicides in solitary confinement in state prisons was ten times the national prison suicide rate; and

WHEREAS, from January 2015-April 2019, 43% of all suicide attempts occurred in a Special Housing Unit; and

WHEREAS, many prisoners in new York State correctional facilities engage in self-inflicted injuries that are classified as less serious than suicide attempts, and according to NYCAIC, between January 2015-April 2019, the rate of such injuries for those in solitary confinement and in disciplinary residential mental health units was more than seven times greater than the rate in the remainder of the prison population; and

WHEREAS, NYCAIC supports sweeping reforms of New York State's use of solitary confinement and other forms of extreme isolation in state prisons and local jails; and

WHEREAS, to help address these problems and issues, Assemblyman Jeffrion Aubry has repeatedly introduced legislation in the New York State Assembly (A.2500) and Senator Luis Sepúlveda has introduced companion legislation in the New York State Senate (S.1623) called the "Humane Alternatives to Long-Term Solitary Confinement" Act (the HALT Solitary Confinement Act); and

WHEREAS, the HALT Solitary Confinement Act would limit the time an inmate can spend in segregated confinement, end the segregated confinement of vulnerable people, restrict the criteria that can result I such confinement, improve conditions of confinement, and create more human and effective alternatives to such confinement; and

WHEREAS, the HALT Solitary Confinement Act would provide a humane and more effective way of handling prisoners who pose a concrete threat to the safety of others, separating them from the general population but not isolating them, placing them in Residential Rehabilitation Units, separate from other housing units, where they would receive therapeutic and rehabilitative

programming to address the issues causing their problematic behavior, and would be out of their cells and in contact with other people many house each day, in therapy and recreation.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature expresses its support for New York State Assembly Bill A.2500 and Senate Bill S.1623 to reduce the amount of time that prisoners can spend in solitary confinement/segregated confinement in order to promote alternative therapeutic and rehabilitative confinement options, urges the New York State Legislature to expeditiously approve said legislation which can help reduce or avert suicides, deaths and adverse mental health effects and urges the Governor to publicly signal his support for, and sign the bill into law when approved by the State Legislature; and be it further

RESOLVED, that certified copies of this resolution be sent to Governor Andrew Cuomo, the Western New York delegation to the New York State Senate and Assembly, Erie County Sheriff Timothy Howard, and the New York Campaign for Alternatives to Isolated Confinement. (5-1) Legislator Rath voted in the negative.

3. COMM. 17E-16 (2020)

COUNTY EXECUTIVE

WHEREAS, the existing jail management system original to the 1984 facility is outdated, has experienced maintenance issues leading to extended downtime for sections of the Erie County Correctional Facility at times, and therefore requires improvement and upgrades; and

WHEREAS, Black Creek Integrated Systems Corporation is considered a sole source vendor, having the ability to seamlessly integrate a new state-of-the-art, proprietary jail management system upgrade with the facility's existing electronic Watchtour and Sallyport NY inmate management system; and

WHEREAS, no other product provides substantially equivalent or similar benefits and considering the benefits received, the cost of the upgrades is deemed reasonable; and

WHEREAS, the County Executive is requesting authorization to enter into a Contract with Black Creek Integrated Systems Corporation for the design, furnishing of equipment, and installation of security upgrades for the Erie County Correctional Facility – Jail Management System Upgrades project; and

WHEREAS, in order to fund the project completely, it is necessary for the Sheriff's Office to transfer \$250,000 from their telephone revenue account, which will not have any impact on their 2020 Budget, into the 2020 Capital Project A.20059 – 2020 Improvements to the Holding Center and Correctional Facility, Fund 410, Funds Center 122; and

WHEREAS, the purchase complies with COMM. 6E-24, 2013, which states that telephone revenue "shall be dedicated to the general operation of the Holding Center and Correctional Facility"; and

WHEREAS, the Sheriff and the County Executive agree the aforementioned items are necessary for the operation of the Erie County Correctional Facility.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is authorized to enter into a Contract with Black Creek Integrated Systems Corporation for the design, furnishing of equipment, and installation of security upgrades for the Erie County Correctional Facility – Jail Management System Upgrades project for an amount not to exceed \$1,960,238, including a contingency; and be it further

RESOLVED, that the Erie County Sheriff's Office and the Division of Budget and Management are authorized to transfer Telephone Revenue funds into an existing capital project in the Department of Public Works in order to fully fund the jail management system upgrades, as follows:

WHEREAS, among the many groups, organizations, sectors and parts of our country, society and community that have been negatively affected by the COVID-19 pandemic are local small businesses, including retail businesses, restaurants, bars and self-employed individuals who run their own business, often as solo operations; and

WHEREAS, Erie County has positively stepped up during the pandemic, providing tens of millions of dollars of federal CARES Act funding to support local governments, procure, purchase and distribute personal protective equipment (PPE), support schools and child care needs, and assist renters and homeowners facing possible eviction or loss of their homes to foreclosure; and

Niagara Realtors Association, Buffalo-Niagara World Trade Center and multiple businesses and employers; and
