WHEREAS, NYS has taken a stand to make the most of our food by mandating large generators of food scraps to redirect wholesome edible food to those in need and food scraps to organics recycling facilities where they will be recycled into a product beneficial to our environment; and WHEREAS, Erie County and its partners, Northeast Waste Management Officials Association (NEWMOA), LEANPATH, and State University of New York (SUNY) Erie Culinary, are developing a food reduction project focused on reducing food waste through tracking, measuring, and planning; and

WHEREAS, this project will facilitate the characterization of food waste sources and quantities for the Local Solid Waste Management Plans which are submitted to New York State Department of Environmental Conservation (NYSDEC). It will also help SUNY Erie implement the food waste reduction goals outlined as part of the comprehensive SUNY System "Ensuring a Greener Future" Initiative; and

WHEREAS, New York State Department of Environmental Conservation (NYSDEC) provides competitive funding for local government to better consolidate and share services; and

WHEREAS, research over the last two decades in the evolving fields of neuroscience, public health, and epigenetics reveals that trauma and adverse childhood experiences cause changes in the neurology and biology of the human body that, in turn, influence the person's physical and mental health and overall wellbeing over their lifetime and can be passed down from parent to child, and that the burden of this growing public health crisis has implications for the County's education, juvenile justice, criminal justice, public health, public safety, labor, and commerce systems; and

WHEREAS, adverse childhood experiences are those that occur during childhood, including physical, emotional or sexual abuse, physical and emotional neglect, household dysfunction, including substance abuse, untreated mental illness or incarceration of a household member, domestic violence, or separation or divorce involving household members, that can have a profound effect on a child's developing brain, body, and spirit and can result in poor health during the person's adulthood; and

WHEREAS, children and adults affected by adverse and traumatic events are more likely to:

- perform poorly in school and other academic pursuits;
- become chronically unemployed or underemployed as adults;
- become dependent on and addicted to tobacco, alcohol, prescription medications, illicit drugs, and other substances;
- become directly engaged with law enforcement and the criminal justice system;
- suffer from significant mental illness including depression, psychosis, and severe anxiety leading to suicides and attempted suicides that otherwise would not have occurred;
- suffer from serious physical health problems with poor long-term outcomes that otherwise would not have occurred;
- struggle despite their sincere efforts, to provide a stable and nurturing environment for their current and future children, resulting in increased likelihood of intergenerational trauma and intergenerational poverty;
- face a life expectancy shortened by as many as 20 years when compared to average life expectancy for adults who did not experience severe trauma as children

and

WHEREAS, the adverse effects of the COVID-19 pandemic and on-going civil/social unrest continue to exacerbate the negative impacts of trauma on mental and physical health and wellbeing of children, families, adults and the workforce, especially immigrants as well as Black, Indigenous, and people of color; and

WHEREAS, nearly 33% of residents across the Buffalo Niagara region live in or near poverty, 25 out of every 1,000 children/youth are believed to be suffering from abuse and maltreatment, and In Erie County there has been over 150 completed suicides and 94 confirmed opioid-related deaths in the last year; and

WHEREAS, trauma-informed care is a culture change process that when adopted into workplaces, communities, schools and government programs, can aid in preventing retraumatization and promoting resilience in children, families and adults; and

WHEREAS, trauma-informed care recognizes the impact of working with individuals and families who have experienced trauma on the workforce, such as vicarious trauma, secondary traumatic stress and compassion fatigue; and

WHEREAS, every group, business, public or nonprofit agency, and tribe in Erie County has a role to play in raising awareness of the importance of supporting the health and well-being of children and families, and investing in trauma-informed services and systems for people throughout the course of life is a vital strategy to improve outcomes, prevent physical, emotional, behavioral, cognitive, spiritual, neurobiological and relational issues for people impacted by trauma, and to build a more prosperous and sustainable County.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature recognizes the importance, effectiveness, and need for trauma-informed care among existing programs and agencies in the County, and encourages all officers, agencies, and employees of the County whose responsibilities include working with vulnerable children and adults to:

- provide services which are trauma-sensitive and trauma-informed, and when appropriate, in a trauma-specific manner

RE: Requesting Potential Transfer of Unitilized CARES Act Funds to the "Back to Business" Small Business Assistance Program (INTRO. 20-1)

A RESOLUTION TO BE SUBMITTED BY LEGISLATOR VINAL

WHEREAS, the Coronavirus pandemic has had a significant adverse effect on tens of thousands, if not hundreds of thousands of Erie County residents and businesses; and

WHEREAS, in response, Erie County has created several CARES Act, federally-funded initiatives designed to assist small businesses, day care/child care/schools, local governments (With PPE purchases), and renters and homeowners facing eviction or foreclosure due to an inability to pay their rent or mortgage; and

WHEREAS, we have learned that the dollar value of applications for the County's small business assistance program, "Back to Business" have exceeded the \$20 million allocated for the program, as local workers remain unemployed or underemployed and businesses have been shuttered or received fewer customers during the pandemic; and

WHEREAS, we have been told anecdotally, that applications for the Live Well Eire CARES Act Rental and Mortgage Assistance program and the childcare/daycare program have been more limited than expected, both in number of applicants and the dollar value of support requested; and

WHEREAS, part of the success of the high number of applicants to the Back to Business program is due to the advertising of the program; and

WHEREAS, it appears that the same level of advertising has not been conducted for the Rental and Mortgage Assistance program and the childcare/daycare program; and

WHEREAS, due to the overwhelming number of applications for the Back to Business program, consideration should be made for transferring some of the unused CARES Act funding from the Rental and Mortgage Assistance program, as well as the local government and child care/day care programs to the Back to Business program administrator, 43North, so they can consider more applications and aware more than \$20 million to eligible entities; and

WHEREAS, this Honorable Body believes that the County should, and can further assist small businesses and their employees during these trying times.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature requests the County administration to increase the County's advertising for the Rental and Mortgage Assistance program and the childcare/daycare program to help encourage more applicants and awarded funds; and be it further

RESOLVED, that this action will help to clarify whether the lack of applications for both programs is not due to the lack of awareness, but rather, to the satisfaction of need; and be it further

RESOLVED, that this Honorable Body requests a status report from the County Administration explaining each of the CARES Act-funded programs, the number of applicants, and funds awarded to-date, including any unallocated funding which may be available for reappropriation; and be it further

RESOLVED, that the Erie County Legislature expresses our support for the reallocation of a portion of the County's unused CARES Act federal funding allocated to the County's day care/child care, local governments, and renters and homeowners assistance programs to the Back to Business program, in order to consider more applicants and assist more businesses and employees during the COVID-19 pandemic; and be it further

A RESOLUTION TO BE SUBMITTED BY LEGISLATORS LORIGO, RATH, TODARO & MILLS

WHEREAS, trust in government is essential for effective and efficient policy making in good times and in bad. Right now, the government is demanding residents wear masks, slow or shutter their businesses, avoid social contact, and take additional extraordinary measures to reduce the spread of COVID-19. It is difficult for residents to maintain their faith in government that these measures are effective and necessary to save lives when the government is picking and choosing whether or not to share relevant information, such as presence and location of COVID-19 infection; and

WHEREAS, Erie County's Health Department has been secretive when it comes to details of infections at nursing homes in Erie County despite the fact that having access to more information regarding COVID-19 helps residents to be safer and more diligent about preventing the spread of COVID-19, as the Health Department has shown with contact tracing; and

WHEREAS, informing the public helps to both maintain public trust and limit the spread of COVID-19. Publicizing information on nursing home infections holds the nursing home operators accountable for their facility, provides residents peace of mind about loved ones residing at nursing homes, and alerts the public to what could be a potential risk of infection to the community thereby allowing residents to take the proper precautions; and

WHEREAS, the Erie County Health Department has hidden behind the Health Insurance Portability and Accountability Act (HIPAA) to defend their lack of transparency; and

WHEREAS, Many New York counties, including other Western New York Counties, have been far more transparent and have provided the public with the name of the facility and the number of infected residents. It is unacceptable that Erie County maintain a heightened level of secrecy when it comes to information related to COVID clusters in nursing homes; and

WHEREAS, releasing nonspecific information is not a HIPAA violation; and

WHEREAS, the New York State Department of Health acknowledged to the Buffalo News on October 29th that the Erie County Health Department is allowed to release information "provided that notification does not contain personally identifiable or protected health information".

of individuals at the nursing home that are infected, the number of total nursing home residents, and the suspected source of the outbreak; and be it further

RESOLVED, that certified copies of this resolution be sent to the Commissioner of the Erie County Health Department, the Erie County Executive Mark Poloncarz, and any other party deemed necessary and proper.
