WHEREAS, the Erie County Sewer Districts also face regulatory requirements that necessitate detailed engineering evaluation and study; and

WHEREAS, it is not practical to issue proposals for each and every small engineering project; and WHEREAS, it is further recognized that there is the need to have engineering assistance on standby for time critical projects; and

WHEREAS, the Division of Sewerage Management issued a request for proposals for engineering assistance on a term contract basis and received eighteen (18) timely responses from engineering firms; and

WHEREAS, in accordance with Section 26.08 of the Erie County Administrative Code, an evaluation committee scored all responses using a consistent rating matrix; and

WHEREAS, the top ten (10) ranked firms submitting proposals have been recommended by the Division of Sewerage Management to perform the requested services.

WHEREAS, 410 Hartford Road, in the Town of Amherst, is known as "Shaarey Zedek Apartments" an affordable housing apartment building for senior citizens that was established in 1999; and

WHEREAS, until 2020, the property was enrolled in a payment in lieu of taxes (PILOT) program granted by the Town of Amherst Industrial Development Agency; and

WHEREAS, in 2020, the PILOT expired and the property applied for a property tax exemption under New York State Real Property Tax Law "RPTL" Section 244(1), which provides exemptions for properties owned by non-profit corporations that provide affordable housing to at least 90% of its residents; and

WHEREAS, the property currently has an exemption under RPTL 244(1); and

WHEREAS, the 2020 and 2021 property taxes for the County, Town of Amherst and Sweet Home Central School District were billed for the full amount, due to the omittance of applying the proper property tax exemption on this parcel; and

WHEREAS, the property owner made payments in 2020 and 2021 for the taxes they were required to pay, including sewer district and water district charges; and

WHEREAS, in 2020 and 2021, as well as every year of Shaarey Zedek Apartments operation, the property was exclusive rented to senior citizens (aged 55+) and rents were limited to 80% of the area median income, which falls within RPTL 422(1)'s definition of low-income housing; and

WHEREAS, in addition to the arrears owed on this property from 2020 and 2021, the County's Department of Real Property Tax Services had levied interest and penalties on the unpaid taxes, as per the Erie County Tax Act; and

WHEREAS, as of November 14, 2022, the arrears, interest and penalties total \$118,673.19; and

WHEREAS, because of the omission of applying the proper real property tax exemption and the property owner making timely and good faith efforts to pay the appropriate amount of taxes in 2020, 2021 and 2022 as if the RPTL 422 exemption had been applied, the property owner is seeking authorization by the Erie County Legislature to waive the arrears, interest and penalties.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature hereby authorizes the waiving of all arrears, outstanding interest, and penalties for the parcel at 410 Hartford Road, Amherst, NY 14226 for the 2020 and 2021 fiscal years; and be it further
