WHEREAS, the Erie County Sheriff's Office and administrators at SUNY Buffalo State (Buff State) Continuing Professional Studies Office have partnered to offer hospitality and culinary training programs at the Erie County Correctional Facility; and

WHEREAS, the program will be funded and manned by Buff State personnel and will provide interested and eligible individuals an opportunity to train in the hospitality and culinary arts; and

WHEREAS, Buff State will conduct different sessions within the term of the agreement; and

WHEREAS, Buff State shall reimburse the Erie County Sheriff's Office for all manpower costs associated with the administration of the program; and

WHEREAS, the agreement will commence on February 6, 2023; and

WHEREAS, this will have a positive impact on the 2023 county budget.

WHEREAS, the ECSO is not creating a new Deputy Sheriff position, rather it will designate a current sworn employee to the collaboration; and

WHEREAS, the MOU shall remain in effect for no longer than twelve months from the date of its execution; and

WHEREAS, the MOU may be terminated, without cause, by either party upon thirty days of written notice.

NOW, THEREFORE, BE IT

RESOLVED, the Erie County Sheriff's Office and the County Executive are authorized to enter into an agreement with Hope of Buffalo Inc. (D.B.A. Peaceprints of WNY), 660 Smith Street, Buffalo, New York, 14120, to extend the current agreement for a term of no longer than twelve months; and be it further

RESOLVED, the MOU may be terminated, without cause, by either party upon thirty days of written notice; and be it further

WHEREAS, the New York State Division of Homeland Security and Emergency Services (NYSDHSES) has awarded \$75,000.00 to the Erie County Sheriff's Office in funding, which is specifically allocated to agencies with SWAT Teams; and

WHEREAS, the Erie County Sheriff's Office SWAT Team has achieved the highest possible FEMA rating and is routinely called by area law enforcement agencies to assist in various high-risk and volatile situations such as barricaded gunman, hostage rescue, active shooter, high-risk apprehension, and technical rescue incidents. These funds will allow the Sheriff's Office to maintain a professionally trained and equipped SWAT Team to support the Sheriff's efforts in counterterrorism and domestic violent extremism missions. Furthermore, the proposed training and equipment will aid in maintaining the New York State Division of Criminal Justice Service SWAT Team Standards; and

WHEREAS, at the time of the grant application, the Erie County Sheriff's Office must submit a specific list of training modules and the NYSDHSES-approved consultants; and

WHEREAS, the NYSDHSES must approve the training vendors before the awarding of the grant; and

WHEREAS, the NYSDHSES approved training and vendors for this grant is D-CO, Leaders and Training LLC; and

WHEREAS, authorization is required from the Erie County Legislature for the County Executive to accept \$75,000.00 in federal resources to provide funds for equipment and training to protect the residents of Erie County and the State of New York from terrorism, domestic violent extremism, and other events requiring a highly trained and operationally proficient SWAT Team; and

WHEREAS, there will be no impact on County tax dollars.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Sheriff's Office is authorized to utilize the New York State Division of Homeland Security and Emergency Services approved vendor, D-CO, Leaders and Training LLC, 26 Pinecrest Plaza, Southern Pines, North Carolina, for the described training not to exceed the \$37,500.00 provided by the grant; and be it further

WHEREAS, electric-based heating and cooling has lower operating and maintenance costs; and

WHEREAS, authorization is required to accept the various funding sources for the installation of new HVAC systems throughout the County which will make the improvements cost efficient.

WHEREAS, the County and Town wish to execute an intermunicipal agreement ("IMA") formalizing the agreement; and

WHEREAS, the cost of the remediation was \$11,513.60 which is available from the fund source hereinafter noted.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is hereby authorized to execute an inter-municipal agreement with the Town of West Seneca, subject to the County Attorney's approval as to form and content, regarding the remediation of the stormwater drainage problem on Suburban Court and the County's agreement to reimburse the Town for the cost of said remediation; and be it further

(Adopted) December 15, 2022.

WHEREAS, the County Legislature of the County of Erie, New York (herein called the "County Legislature" and the "County", respectively), on behalf of the Erie County Sewer District No. 3 in the County (the "District") and pursuant to proceedings heretofore had and taken in accordance with the provisions of Article 5-A of the County Law, including approving orders of the State Comptroller, has established the District; and

WHEREAS, the Board of Managers of the District has duly directed that there be prepared a map, plan and report and estimate of cost (the "Report" and the "Estimate" respectively and, collectively, the "Report and Estimate") by the County Engineers (i.e., the Erie County Department of Environment and Planning) relating to a proposed increase and improvement of the facilities of the District, which Report and Estimate have been approved by the Board of Managers of the District on April 6, 2022, and subsequent thereto the Report and Estimate were filed with the County Legislature pursuant to Section 268 of the County Law; and

WHEREAS, the Report and Estimate describe a proposed increase and improvement of the facilities of the District, generally consisting of improvements to the Southtowns Advanced Wastewater Treatment Facility, existing pumping stations, and the sanitary sewer collection system; as more fully described in the Report and Estimate (collectively, "Improvements" or the "Project"); and

WHEREAS, such Project will generally consist of substantial improvements to the Southtowns Advanced Wastewater Treatment Facility, such work being currently anticipated to include, but not necessarily be limited to, disinfection and effluent pumping improvements, ORF and outfall modifications, bioclarifier and aeration/UNOX system improvements including the rehabilitation of existing tanks, solids handling improvements, electrical improvements, equipment replacements and upgrades to backup power generator(s), IT infrastructure and HVAC system improvements, as well as other upgrades that are identified in the additional facility needs evaluation and as more fully identified in (or contemplated by) the Report, with the foregoing to include all necessary site work, equipment, apparatus and other improvements and costs incidental thereto and in connection with the financing thereof; and

WHEREAS, the maximum estimated cost of the Project is \$100,000,000,and unless paid for from other sources or charges, such cost will be apportioned among the benefitted real properties in the District in accordance with charges based on usage and/or special assessments based on units, assessed value and/or footage, as these or other applicable cost apportionment standards may be specified in the District's Benefit and User Charge formulas (as those currently exist or as they may be amended from time to time in accordance with the County's sewer rents local law and the rules and procedures adopted by the Board of Managers of the District); and

WHEREAS, pursuant to the County Law the consent of the State Comptroller is required prior to the construction and development of the Project in the District because the cost thereof to the Typical Property (as defined in the County Law) is estimated to exceed the Average Estimated Cost to the Typical Property for similar types of projects, as computed by the State Comptroller, with such cost being estimated to be \$111.17; and

WHEREAS, the County Legislature has given due consideration to the impact that the Project may have on the environment and, on the basis of such consideration, the County Legislature found that no substantial adverse environmental impact will be caused thereby; and

WHEREAS, the County Legislature and the County have complied in every respect with all applicable federal, state and local laws and regulations regarding environmental matters, including compliance with the New York State Environmental Quality Review Act, comprising Article 8 of the Environmental Conservation Law and, in connection therewith, duly issued a negative declaration and/or other applicable documentation concerning the project, which has been filed in the office of the County Clerk; and

WHEREAS, the County Legislature adopted Resolution No. 137-2022 on September 22, 2022, calling a meeting of the County Legislature for the purpose of holding a public hearing on the proposed Project in accordance with the Report and Estimate (the "Public Hearing"); and

WHEREAS, such Resolution No. 137-2022 authorized and directed the Clerk of the County Legislature to publish the notice of the Public Hearing; and

WHEREAS, the Public Hearing was duly held at County Hall, in Buffalo, New York, on October 17, 2022, at 2:00 o'clock P.M., Prevailing Time; and

WHEREAS, notice of the Public Hearing was duly published and filed in the manner provided by law and proof thereof was submitted to the County Legislature;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY LEGISLATURE OF THE COUNTY OF ERIE, NEW YORK, AS FOLLOWS:

Section 1. Upon the evidence given at the Public Hearing, it is hereby found and determined that it is in the public interest to proceed with the Project and its proposed plan of financing, all as more fully described in the preambles hereto, and the Project is hereby authorized in concept (subject to the County's obtaining the required approval of the New York State Comptroller) at a maximum estimated cost of \$100,000,000.

Section 2. It is hereby found and determined that the parcels and lots of the District shall be benefited by the Project.

Section 3. It is hereby found and determined that the maximum estimated cost of the Project is \$100,000,000, and unless paid for from other sources or charges, such cost to be to be apportioned among the benefitted real properties in the District in accordance with charges based on usage and/or special assessments based on units, assessed value and/or footage, as these or other applicable cost apportionment standards may be specified in the District's Benefit and User Charge formulas (as those currently exist or as they may be amended from time to time in accordance with the County's sewer rents local law and the rules and procedures adopted by the Board of Managers of the District).

Section 4. It is hereby found and determined that the cost of the Project shall be financed by the issuance of serial bonds of the County (to be issued pursuant to one or more bond resolutions that are to be adopted by the Legislature in the future) in an amount not to exceed \$100,000,000, and with the balance of the cost of the Project to be annually apportioned within the District as described previously herein.

Section 5. It is hereby found and determined that this resolution shall constitute the declaration (or reaffirmation) of the County's "official intent" to reimburse (to the extent permitted) expenditures toward the Project with the proceeds of bonds, notes or other obligations, as required by United States Treasury Regulations Section 1.150-2.

Section 6. It is hereby found and determined that the County Legislature has directed that the attached application for approval be prepared and submitted to the New York State Comptroller's office, believes the contents of the application to be accurate, has determined that the Project (and its proposed plan of financing) for which approval is being sought is in the public interest and will not constitute an undue burden on the properties which will bear the cost thereof, and if the cost of the proposed improvements is to be assessed in whole or in part against a benefited area, that all real property to be so assessed will be benefited by the proposed improvements and that no benefited property has been excluded. The Legislature understands that the attached application has been presented and approved in substantially complete and final form, but nevertheless authorizes and approves, in advance, such non-material modifications, amendments or revisions as may, in the opinion of the County Attorney and the County's bond counsel, be deemed appropriate.

Section 7. It is hereby directed that within ten (10) days after adoption of this Resolution, the Clerk of the County Legislature shall record with the Clerk of the County a copy of this Resolution, certified by the Clerk of the County Legislature.

<u>Section 8</u>. It is hereby directed that this resolution shall take effect immediately.
