# A RESOLUTION TO BE SUBMITTED BY LEGISLATORS LORIGO, RATH, TODARO & MILLS

WHEREAS, the 2019 New York State Budget included significant changes to the state's pretrial discovery procedures; and

WHEREAS, Bail/Criminal Justice Reform legislation substantially changed the discovery process to require an expedited timeline for prosecutors to provide evidence from crime scenes, including police reports, radio communications, body camera footage, dash-cam video, photographs, and witness names and contact information related to the prosecution, to defense attorneys within 15 days after a defendant's arraignment; and

WHEREAS, provisions of the 2019 legislation protects law enforcement personnel from the disclosure of name and contact information to guard against them and their families from threats and possible intimidation; and

WHEREAS, the 2019 legislation does not extend this protection to first responders responding to a crime scene; and

WHEREAS, State Senate bill S7280 and Assembly Bill A9107 would amend current criminal procedure law to shield first responders, including ambulance services, firefighters, emergency medical technicians, from having their personal information shared during discovery; and

WHEREAS, many volunteer firefighter and first responder organizations face recruitment challenges, and the potential threat of a first responder or their family being targeted by a defendant or other group could deter volunteer recruitment, thus the proposed Senate and Assembly bills will help shield and support our community's first responders.

NOW, THEREFORE, BE IT

RESOLVED, this Honorable Body is in support of proposed New York State Senate bill S7280 and Assembly Bill A9107 to shield first responders from having their personal and identifying information shared during the discovery process; and be it further

RESOLVED, that certified copies of this resolution be sent to the Western New York delegation of the NYS Senate and Assembly, Governor Andrew Cuomo, Senate Majority Leader Andrea Stewart-Cousins, Assembly Speaker Carl Heastie, and any other party deemed necessary and proper.

RE: Support for Full & Proper Enforcement of Ruthie's Law

(INTRO. 4-2)

# A RESOLUTION TO BE SUBMITTED BY LEGISLATORS LORIGO, MILLS, TODARO & RATH

WHEREAS, Ruthie's Law was proposed by County Executive Mark C. Poloncarz, drafted by County Attorney Michael Siragusa, and unanimously approved by the Erie County Legislature in 2017; and

WHEREAS, Ruthie's Law was filed with the Secretary of State on July 11, 2017; and on that date, became law in the County of Erie; and

WHEREAS, this law was drafted in response to a terrible incident where Ruth Murray, a resident in a local nursing home, was injured during an altercation with another resident. As a direct result of her injuries she passed away. In the time between the initial injury and Ruthie's death, her nursing home downplayed the severity of her injury to Ruthie's family. Ultimately, this delay robbed Ruthies' family of their ability to seek alternative care for Ruthie and to be there for her in her moment of need; and

WHEREAS, upon signing the bill into law, the County Executive stated "I can't think of a better thing government can do. At its core, Government has a responsibility to protect its citizens"; and

WHEREAS, it is the stated purpose of Ruthie's Law to ..."ensure a reasonable level of care and accountability..." is placed on nursing homes in our community to protect the health and wellbeing of its residents. Further, the law imposes additional requirements to forward information to the people who place their loved ones in the care of the nursing home; and

WHEREAS, to increase the level of care and transparency, the law requires facilities operating within Erie County provide the Commissioner of the Department of Senior Services with semi-annual reports of incidents at their facility, disclose to potential patients their most recent Nursing Home Performance Quality Measure data, and notify a patient's "Designated Representative" if there is an incident that leads to a "reportable injury" of the patient within two-hours of discovering the injury; and

WHEREAS, in the thirty-one (31) months since the filing of this law around half of the nursing facilities operating in Erie County are in compliance with its terms; and

WHEREAS, Ruthie's Law provides that a failure to properly report incidents can lead to fines of up to \$1,000 for the first violation , and an additional \$2,000 for each subsequent violation in a given year; and

WHEREAS, Section 5(a) of Ruthie's Law directs the Department of Senior Services to enforce the provisions of the law on behalf of Erie County; and

WHEREAS, Section 4 of the Law provides the Commissioner of the Department of Senior Services the ability to subpoena the books and records required under this law from any non-compliant nursing home; and

WHEREAS, the law further charges the County Attorney, who assisted in the drafting of the law, with the requirement to pursue a judgment against any facility that fails to pay the fees and fines lawfully levied under this law; and

WHEREAS, it is a finding of this body that as of February 7, 2020, there are still eighteen (18) of thirty-five (35) nursing facilities not in compliance; and

WHEREAS, it is a further finding of this body that that the neither the Commissioner of Senior Services nor the County Attorney have taken any action to enforce the law; and

WHEREAS, it is the stated opinion of the Commissioner of the Department of Senior Services that, based upon the opinion of counsel for a nursing home association, that the law is unenforceable as it is preempted by state law; and

WHEREAS, it is the belief of this honorably body that the Legislature passes laws with the intent that they be properly enforced by the Administration; and

WHEREAS, it is the belief of the current County Attorney that they will do everything within their legal ability to support laws passed by this body. In fact, the County Attorney has stated in public meetings held at the Legislature that he will defend the rights of County and the directive of the Legislature to the fullest extent of the law; and

WHEREAS, the threat of a lawsuit from the party regulated under the Law is not a sufficient cause to suspend enforcement. Erie County needs to push on with enforcement to protect some of our most vulnerable residents. If need be, have the New York State court system be the ultimate arbiter.

NOW, THEREFORE, BE IT

RESOLVED, that this Honorable Body hereby expresses its full support for the enforcement of Ruthie's Law and directs Commissioner Shenk to utilize all enforcement mechanisms explicitly provided to his office pursuant to the Law; and be it further

RESOLVED, that this honorable body hereby further directs the County Attorney to take any necessary action to support the interests of County of Erie in the enforcement of Ruthie's Law; and be it further

RESOLVED, that certified copies of this resolution be sent to County Executive Mark Poloncarz, County Attorney Michael Siragusa, Commissioner of the Department of Senior Services David Shenk, and any other party deemed necessary and proper.

WHEREAS, the Commissioner of Senior Services has stated to media outlets and to the Legislature that representatives of the nursing homes, as well as an association representing them, have told him that the law is not enforceable and is allegedly pre-empted by State law, and those individuals have also stated as such directly to media outlets; and

Add the Following Whereas Clauses:

WHEREAS, the Legislature's Health and Human Services Committee has held two committee discussions directly with Commissioner David Shenk to question him about the nursing homes that have not complied with the law and submitted reports, as well as his efforts to compel compliance and conduct enforcement of the law; and

WHEREAS, Commissioner Shenk testified at a committee meeting on February 13, 2020 that he issued "final notice" letters to nursing homes that have not submitted the required reports, and also testified that effective February 28, 2020 he will be issuing fines to nursing homes that do not follow the law.
