Extending Protections for Human

Trafficking Shelters, Their Employees, and Clients (INTRO. 7-1)

A RESOLUTION TO BE SUBMITTED BY LEGISLATOR BASKIN

WHEREAS, on January 17, 2019, this Honorable Body proclaimed January 2019 as "Slavery & Human Trafficking Prevention & Awareness Month" in Erie County; and

WHEREAS, at that same legislative session, this Honorable Body approved Intro. 2-2, a resolution concerning "Confidential and Anonymous Listing of Human Trafficking Shelters in Erie County", in which we memorialized support for state or local action to help safeguard human trafficking shelters, their employees and clients; and

WHEREAS, the Domestic Violence Prevention Act was signed into law as Chapter 838 of the Laws of 1987 and was enacted to enhance the delivery of services to victims of domestic violence and their families throughout New York State and states: "in order to maintain the safest atmosphere possible for victims of domestic violence, the street address of any residential program for victims of domestic violence shall be confidential and may be disclosed only to persons designated by the rules and regulations of the NYS Office of Children and Family Services. A victim may give the post office box or the office address of the program in which he or she is temporarily residing"; and

WHEREAS, various state human trafficking laws provide for "trafficking shelters" defined as confidential locations which provide emergency housing for victims of human trafficking; and

WHEREAS, there remains a need to help safeguard and support these shelters for victims of human trafficking in much the same way as we protect and provide resources to domestic violence shelters; and

WHEREAS, members of the local delegation to the New York State Legislature are currently exploring state legislation to amend New York State's domestic violence and social services laws and statutes to provide explicit protections for, and confer special legal status on human trafficking shelters, their clients and employees, to help protect the persons sheltering and working therein, including prohibitions on identifying the employees, their personal information, and the agencies and addresses of said shelters and establishing stronger criminal or civil penalties on those who trespass or act against human trafficking shelters.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature expresses its strong support for additional measures in New York State law to provide confidentiality for human trafficking shelters, their employees and clients, including measures to establish penalties for offenders who trespass or engage in prohibited activity against the occupants, buildings or tenants; and be it further

2020 Census (INTRO. 7-3)

A RESOLUTION TO BE SUBMITTED BY LEGISLATORS BRUSO, MEYERS, HARDWICK & MILLER-WILLIAMS

WHEREAS, the US Bureau of the Census is preparing for the 2020 decennial census, which has critical implications for New York State and Erie County; and

WHEREAS, decennial Census counts help the federal government distribute more than \$400 billion in funds annually for infrastructure, programs, and services, as well as determine representation in the US House of Representatives; and

WHEREAS, the decennial census helps communities plan for future needs and deal with population-based programs; and

WHEREAS, decennial population counts affect state and federal congressional representation and redistricting; and

WHEREAS, New York State and county governments are committed to ensuring that every resident in the state is counted in the 2020 Census; and

WHEREAS, last year, every county in New York State participated in the US Bureau of the Census' Local Update of Census Addresses (LUCA) Program, including Erie County, which is the only opportunity for states and municipalities to review and comment on the U.S. Census Bureau's residential address list for their jurisdiction prior to the 2020 Census; and

WHEREAS, according to the County Executive, Erie County's 2018 work on the LUCA program "identified more than 3,000 addresses" which the Census Bureau did not know about; and

WHEREAS, every person who is not counted in the Census represents a loss of \$2,600 per year in federal funding for Erie County for every year over a ten year period until the next Census is held, which means a loss of \$26,000 in federal funding over ten years if just one person is missed in the Census; and

WHEREAS, as he stated in his 2019 State of the County Address, if "two people lived at each of these addresses, and the Census Bureau did not count anyone at each address, the county would lose at least \$15,600,000 annually or \$156 million over 10 years" in federal aid; and

WHEREAS, the State has created the bipartisan New York State Complete Count Commission to inform and help direct the State's efforts in the upcoming 2020 Census and recommend ways to ensure a full and complete count for the 2020 Census, including the so-called "hard-to-count population" which includes children under five years of age, people who live in dense urban settings and in very rural locations, people of color and people who live in poverty; and

WHEREAS, the adopted 2019-2020 State Budget includes \$20 million in funding for the complete count process; and

WHEREAS, now the State of New York as well as others such as the New York State Association of Counties and locally, the Peter and Elizabeth C. Tower Foundation, the Health Foundation for Western and Central New York, the Community Foundation for Greater Buffalo, and the Western New York Women's Foundation, are formally encouraging counties and other regional and community entities to create "Full Count" committees and work with the State to help ensure a full and complete 2020 Census count of all residents in our state and our county; and

WHEREAS, in his State of the County Address for 2019, Erie County Executive Mark Poloncarz announced that "to ensure everyone is counted, I will sign an Executive Order empaneling a Complete Count Committee to coordinate an accurate census and promote and create awareness of the census in all our communities, including the Seneca and Tuscarora nations and communities where English is not the native language."

NOW, THEREFORE, BE IT

RESOLVED, the Erie County Legislature calls on the New York State Legislature and the Governor to allocate resources and funding to counties, municipalities, and regional planning commissions as incentives and seed funding to create "Full or Complete Count" committees to work in conjunction with the State's Complete Count Commission to ensure that the US Bureau of the Census conducts a full and accurate county of all New Yorkers in 2020; and be it further

RESOLVED, that this Honorable Body shows its support for a full and complete count of all residents of this state and this county in the 2020 Census and urges the US Bureau of the Census and the US Department of Commerce to fulfill their constitutional responsibilities to conduct a fair, transparent and full count of all persons; and be it further

RESOLVED, this this Honorable Body expresses its support for the County Executive's executive order creating a Complete or Full Count Committee in Erie County to assist with the important work of the 2020 Census and pledges our assistance to said committee; and be it further

RE: Support for Safety Cameras on

School Buses (INTRO. 7-4)

A RESOLUTION TO BE SUBMITTED BY LEGISLATORS SAVAGE, BRUSO, HARDWICK, BASKIN & MILLER-WILLIAMS

WHEREAS, the safety and well-being of our children, whether at home, at play, or at school is critically important to all of us; and

WHEREAS, a major risk area is when school children are boarding or exiting school buses and crossing streets when the bus is stopped and its red stop lights are activated; and

WHEREAS, motorists are legally required to stop when confronted by a stopped school bus with flashing lights, but an estimated 50,000 motorists each year in New York state ignore the safety regulation; and

WHEREAS, under current law, a ticket for a motorist who illegally passes a stopped school bus displaying a red visual signal can be issued only by a police officer who witnesses the violation; and

WHEREAS, one measure proven to help protect children while on school buses or boarding or exiting school buses is the use of technology including surveillance cameras on stop-arms on buses in order to deter or help with citations or fines on those scofflaws who break the law and drive past stopped school buses with their red stop lights activated; and

WHEREAS, sixteen states already have statutes allowing the technology; and

WHEREAS, in the 2019-2020 state budget, a traffic safety package allows for the stop-arm cameras to be used; and

WHEREAS, on March 19, 2019, the State Assembly approved Assembly Bill A.4950A by a vote of 146-0, thus demonstrating the unanimous support of this non-partisan bill; and

WHEREAS, the State Senate has a companion bill, Senate Bill S.4524, introduced by State Senator Timothy Kennedy, pending in that body for action in this legislative session; and

WHEREAS, the bill provides for additional enforcement options by authorizing a demonstration program to allow local governments to impose liability on the owners of motor vehicles for the failure of the drivers to comply with the law and allowing for the use of mobile cameras mounted on school buses, as well as stationary cameras, with the cost to be borne solely by the municipalities but the revenue can be collected by the localities; and

WHEREAS, violators caught on camera would face automatic fines of \$250 but would not receive points on their driver's license or be penalized by their insurance company.

NOW, THEREFORE, BE IT

RE: Supporting the "Safe Staffing for

Quality Care Act" (INTRO. 7-5)

A RESOLUTION TO BE SUBMITTED BY LEGISLATORS MEYERS & MILLER-WILLIAMS

WHEREAS, nearly every year since 2009, legislation has been introduced in the New York State Assembly and Senate called the "Safe Staffing for Quality Care Act" or a derivation thereof, amending the State's Public Health Law to require all acute care facilities and nursing homes to meet standards for appropriate staffing ratios of nursing and unlicensed direct care staff; and

WHEREAS, this legislation would establish hospital nurse-to-patient ratios based on peerreviewed academic research and evidence-based recommendations, in order to promote quality of care, and reduce patient injury, illness and death; and

WHEREAS, research has shown that safe nurse staffing also reduces avoidable, adverse patient outcomes, with evidence that hospitals with lower nurse staffing levels have higher rates of

pneumonia, shock, cardiac arrest, urinary tract infections and upper gastrointestinal bleeds; all leading to higher costs and mortality from hospital-acquired complications; and

WHEREAS, research has shown that safe nurse staffing in nursing homes has a positive impact on facility processes and on resident outcomes, with evidence that as nurse turnover increases in nursing homes, the quality of resident care declines, resulting in more frequent use of restraints, urinary catheterization, and psychoactive drugs; increased risk of contractures, pressure ulcers and more survey deficiencies; and

WHEREAS, research has shown that increased staffing levels do not diminish the profitability of facilities, and while workforce costs may rise, but that increase is mitigated by overall savings from improved patient outcomes and avoided adverse events and this helps reduce medical malpractice and other penalties resulting from avoidable occurrences and poor patient satisfaction; and

WHEREAS, establishing staffing standards for nursing and unlicensed direct care staff in hospitals and nursing homes will help ensure that these facilities operate in a manner that guarantees the safety of patients and the delivery of quality health care services; and

WHEREAS, we have witnessed events in local nursing homes, for instance, as reported in The Buffalo News in 2018, in which understaffing is a common problem in many of the worst-rated nursing homes in Western New York in which residents in these facilities often must wait long periods to be taken to the bathroom, have their diapers changed or receive assistance in being fed; and

WHEREAS, Assembly Bill A.2954 and Senate Bill S.01032, both of which have sponsors from our Erie County state delegation, have been introduced in the current legislative session to establish safe staffing and help promote quality care.

NOW, THEREFORE, BE IT
