WHEREAS, due to the magnitude of the COVID-19 outbreak, and the public declarations by the President, Governor and County Executive requesting or ordering social distancing and limiting public or workplace gatherings, it is necessary to amend the Legislature's Rules of Order to allow, as necessary, for all legislators to participate remotely in a legislative session or committee via video or audio conferencing through the Chair of the Legislature issuing such a meeting notice.

RESOLVED, that due to the COVID-19 emergency, the Erie County Legislature amends its Rules of Order, Section 2.03 to add the following: "During the State of Emergency involving COVID-19, and pursuant to a written letter submitted by the Chair of the Legislature directing so, the Legislature may convene and meet in legislative sessions or committees via video or audio conferencing, so long as the public may watch/listen to such sessions or committees."

Buffalo & EC Industrial Land

Development Corp. (COMM. 8E-6)

WHEREAS, the Buffalo and Erie County Industrial Land Development Corporation (ILDC) owns 150 acres of land on the former Bethlehem Steel site that it wishes to develop into a state-of-art manufacturing center; and

WHEREAS, the ILDC site is within the bounds of Erie County Sewer District (ECSD) No. 6; and

WHEREAS, the ILDC has proposed submitting a grant application to the United States Economic Development Administration to fund infrastructure improvements that would support redevelopment of this portion of the former Bethlehem Steel site; and

WHEREAS, specifically the ILDC has proposed approximately 4,000 linear feet of sanitary sewer infrastructure improvements to extend public sanitary sewer service further onto the former Bethlehem Steel site (hereinafter referred to as the "sewer improvements"); and

WHEREAS, as the entity responsible for owning and maintaining the sewer improvements contemplated as part of the ILDC's proposal, the County of Erie / ECSD No. 6 must be a coapplicant on the ILDC's grant submission; and

WHEREAS, the ILDC has committed to fund any local cost share required should a grant be awarded by the United States Economic Development Administration for the proposed sewer improvements.

NOW, THEREFORE, BE IT

RESOLVED, that the Deputy Commissioner of the Erie County Division of Sewerage Management is authorized to sign documents allowing for the County of Erie / ECSD No. 6 to be a co-applicant on the ILDC's grant application; and be it further

RESOLVED, that the Deputy Commissioner of the Erie County Division of Sewerage Management is also authorized to sign a memorandum of understanding with the ILDC for the proposed sewer improvements to be included as part of the ILDC's grant submission; and be it further

RESOLVED, that should a United States Economic Development Administration grant be awarded, the Division of Sewerage Management is authorized to administer engineering and construction phases services for the sewer improvements; and be it further

RESOLVED, that any local cost share required by the United States Economic Development Administration Grant Program for the sewer improvements will be provided by the ILDC; and be it further

RESOLVED, that the Clerk of the Legislature be authorized and directed to send a certified copy of this resolution to the County Executive, the County Comptroller, the Director of the Division of Budget and Management, Kristen Walder, Assistant County Attorney, Joseph Fiegl, P.E., Deputy Commissioner of the Department of Environment and Planning, and the ILDC.
