WHEREAS, as a requirement of the HALT Act, the Sheriff's Office needs to provide out-ofcell trauma-informed therapeutic programming to promote personal development and address the underlying causes of problematic behavior among incarcerated populations, and

WHEREAS, Peaceprints of Western New York (PPWNY) has adopted the "Houses of Healing" curriculum, which is a powerful 13-session social emotional learning (SEL) curriculum created specifically to address incarcerated individual rehabilitation. The centerpiece of the program is the book, *Houses of Healing: A Prisoners Guide to Inner Power and Freedom*, designed to offer skillful guidance and equip prisoners with the tools to effectively manage difficult emotions, take stock of and heal the unresolved trauma that often plays a role in propelling criminal behavior, take responsibility for offending behavior and change life-long patterns of violence and addiction; and

WHEREAS, PPWNY will employ and assign a qualified programming coordinator to work at both facilities; and

WHEREAS, the Sheriff's Office will fund year one of the program with Telephone Revenue Funds; and

WHEREAS, the cost of the program coordinator is \$25,001.00; and

WHEREAS, the Sheriff's Office and PPWNY will enter into an agreement that will end March 31, 2025, and will not exceed \$25,001.00 for a program coordinator, and

WHEREAS, the Sheriff and the County Executive agree the position mentioned above and agreement is necessary for the operation of the Erie County Holding Center and the Erie County

Correctional Facility; and

WHEREAS, the expenditure for a HALT Act program coordinator complies with COMM. 6E-24, 2013, which states that Telephone Revenue "shall be dedicated to the general operation of the Holding Center and Correctional Facility"; and

WHEREAS, as of January 26, 2024, the Telephone Revenue account has a balance of \$1,126,465.00; and

WHEREAS, this resolution transfers \$25,001.00 from the Telephone Revenue account and will not impact the 2024 County Budget.

WHEREAS, the Buffalo & Erie County Downtown Library last had its' roof constructed in 1999; and

WHEREAS, the typical lifespan for a roof of this type is approximately 20 years and is therefore beyond its useful life; and

WHEREAS, in conjunction with, as well as funded by, the Buffalo Sewer Authority, the County commissioned a Feasibility Study to examine the Downtown Library to determine if the roof could support the additional load of a vegetative roofing system where the study confirmed that the eastern portion of the roof at the facility is a good application for a vegetative roof system; and

WHEREAS, the County has applied for a state grant through the Green Infrastructure Grant Program (GIGP) that, if awarded, would cover up to 90% of the cost to add a vegetative roofing system to the eastern 70% of the roof; and

WHEREAS, the Library's roof is showing signs of deterioration and will be replaced regardless of an award from the Green Infrastructure Grant applied for; and

WHEREAS, the County solicited RFPs for an Architectural and Engineering firm the Department of Public Works standard consultant selection process to design a traditional roof replacement with the option to design a vegetative roofing system pending award of the GIGP funding; and

WHEREAS, the County selected Watts Architectural through a qualifications based selection process to design the traditional roof at a cost of \$182,550 and the vegetative roof at a cost of \$102,170; and

WHEREAS, unforeseen circumstances can require changes to the design and the County requests a design contingency fund to be approved in the amount of \$25,000; and

WHEREAS, the County Executive is requesting authorization to enter into an Agreement with Watts Architectural to provide professional A/E Design services for both components of the project including roof replacement as well as design for the vegetative roof, of the Buffalo & Erie County Downtown Library Roof Repair project in an amount not to exceed \$309,720.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature hereby authorizes the County Executive to enter into an Agreement with Watts Architectural to provide professional Design services for the Buffalo & Erie County Downtown Library Roof project in an amount not to exceed \$309,720; and be it further

COUNTY EXECUTIVE

WHEREAS, \$8,000,000 in American Rescue Plan Revenue Loss Funding was appropriated towards the 25 Delaware Exterior Façade Project as part of the American Rescue Plan Omnibus Spending Package – the "RENEW Plan" (COMM. 13E-15 (2021)); and

WHEREAS, \$4,000,000 in funding was appropriated towards the 25 Delaware Exterior Façade Project as part of the 2021 Year-End Budget Balancing Amendments and Designations (COMM. 8E-1 (2022)); and

WHEREAS, unanticipated expenses beyond what was budgeted were realized upon phasing the 25 Delaware Exterior Façade Project rendering the project underfunded and unable to immediately proceed due to budgetary constraints; and

WHEREAS, the American Rescue Plan Revenue Loss Funding requires money to be obligated by the end of the year which can be best accomplished by transferring the funding to the Rath Microgrid System Project; and

WHEREAS, the County of Erie wishes to identify the most effective means to reduce energy consumption while also providing reliable power to critical facilities; and

WHEREAS, pursuant to that goal, a Request for Proposal was issued to provide architectural and engineering services for a microgrid system at the Rath Building and such proposals were received; and

WHEREAS, your Honorable Body previously authorized the Department of Public Works to execute a zero-dollar contract between the County of Erie and Palm Energy, LLC to begin evaluating and propose a microgrid system on county-owned buildings per COMM. 13E-15 (2022); and

WHEREAS, the first step towards beginning the Energy Performance Contract ("EPC") process was to conduct a site investigation to determine the feasibility and savings from a microgrid system; and

WHEREAS, the Rath building was found to be a suitable candidate for installing a microgrid system; and

WHEREAS, the Rath Building's generator as well as main electrical switchgear are original to the building and therefore have exceeded their useful lifespan with replacement parts becoming increasingly difficult to source; and

WHEREAS, this project includes replacement of the main electrical infrastructure for the building as well as the providing whole building backup generation power by installation of the proposed microgrid system renovation; and

WHEREAS, this project also includes improvements of the 4th floor roof as the microgrid system equipment will be located on the roof above the 4th floor; and

WHEREAS, improvements to the roof will be under warranty for 20 years from the date of completion; and

WHEREAS, all federal, state and utility incentives received by the County in direct result of projects included within the EPC will be returned into A.20007 – Energy Conservation Implementation Measures; and

WHEREAS, the savings from the EPC will cover the cost of the project, not to exceed an amount of \$11,659,896; and

WHEREAS, funding in the amount of \$9,500,000 authorized for the façade exterior at 25 Delaware Avenue will be reallocated to a new capital project account to pay for this project.

NOW, THEREFORE, BE IT

RE: Adoption of Personnel Policies for Managerial and Confidential Employees Exempted from the

Fair Labor Standards Act

(INTRO. 5-3)

A RESOLUTION TO BE SUBMITTED BY LEGISLATOR GILMOUR

WHEREAS, Erie County has not adopted policies for its non-unionized managerial or confidential employees that are commensurate with those established in collective bargaining agreements for its unionized employees; and

WHEREAS, the establishment of clear, written policies for non-unionized managerial or confidential employees would foster a more transparent and consistent workplace for these employees; and

WHEREAS, Erie County has given its managerial and confidential employees most of the benefits awarded to employees in the CSEA Erie County Unit 6700 bargaining unit ("CSEA"); and

WHEREAS, CSEA primarily represents white-collar hourly workers in County service; and

WHEREAS, the process the County has used to change policies for managerial and confidential employees is through one-off legislative resolutions, sometimes as clauses in resolutions on topics unrelated to managerial and confidential employees; and

WHEREAS, in the 2023 adopted budget, the Erie County Legislature declared certain managerial and confidential employees as exempt from the Fair Labor Standards Act requirements for overtime under the Executive Exemption; and

WHEREAS, in the 2024 adopted budget, the Erie County Legislature reaffirmed certain other managerial and confidential employees as exempt under the Professional Exemption; and

WHEREAS, Erie County must pay an exempt employee their full predetermined salary amount "free and clear" for any week in which the employee performs any work without regard to the number of days or hours worked; and

WHEREAS, the CSEA collective bargaining agreement, which is negotiated for hourly employees, is not an appropriate document to base policies for salaried employees; and

WHEREAS, the Personnel Commissioner is the official responsible for administering the compensation and benefit package for all employees, including managerial and confidential salaried employees; and

WHEREAS, the Personnel Commissioner drafted policies for FLSA-exempt employees and invited the Office of each independently elected official to comment and provide feedback on the draft policy; and

WHEREAS, the Personnel Commissioner has incorporated the feedback he received from elected officials and believes this Policy has the support of all the independently elected officials.

NOW, THEREFORE, BE IT

RESOLVED, the attached document, "Personnel Policies for Managerial and Confidential Employees Exempted from the Fair Labor Standards Act," is hereby adopted effective June 29, 2024; and be it further

RESOLVED, any legislative resolution regarding policies for managerial and confidential employees contrary to the adopted Policy is null and void effective June 29, 2024 for FLSA-exempt managerial and confidential employees; and be it further

RESOLVED, FLSA-exempt employees shall receive one hundred percent (100%) of their annual Paid Time Off Leave allocation granted in Article 6 of the adopted Policy on June 29, 2024; and be it further

RESOLVED, FLSA-exempt employees may choose to either (a) cash out the vacation leave credits at their June 29, 2024, rate of pay, or (b) to retain these credits in separate vacation and personal leave banks that they are unable to access while in a FLSA-exempt position without the permission of the Commissioner of Personnel; and be it further

RESOLVED, the Personnel Department is directed to transfer time accrued in the catastrophic sick bank of FLSA-exempt employees into their sick banks; and be it further

RESOLVED, that certified copies of this resolution shall be forwarded to the County Executive, Comptroller, District Attorney, Clerk, Sheriff, Personnel Commissioner, and Division of Budget and Management.

WHEREAS, an external audit will allow for an independent, full-service, professional audit agency to build upon the internal audits that have been conducted and provide expert recommendations to ensure our residents' County tax dollars are protected to the highest degree.

NOW, THEREFORE, BE IT

RESOLVED, request the County Clerk issue a request for proposals ("RFP") to solicit responses for a external forensic audit of the County Clerk's office, including both the Registrar Division and the Auto Bureau Division; and

RESOLVED, the RFP shall include a goal of identifying best practices for a universal accounting system, including software, to address the issues raised by the multiple software program approach that has plagued Erie County tax dollars over the past 10+ years; and

RESOLVED, that the Erie County Comptroller be consulted on the process, including but not limited to a seat on the RFP scoring committee, participation as a subject in any interviews conducted by the external audit team, and the ability to review the external audit prior to its finalization; and

RESOLVED, the Erie County Clerk shall work with the Division of Budget and Management to identify funding in its budget to fund an external forensic audit, and if there are insufficient funds within its own budget, work with this honorable body to provide the additional funds needed to ensure a full forensic, external audit is fully funded; and

RESOLVED, the Clerk of the Legislature is directed to send copies of this resolution to the Erie County Clerk, the Erie County Comptroller, the Erie County Executive, the Budget Director, the New York State Comptroller, and any other parties deemed necessary.

Emergency Housing (INTRO. 5-7)

A RESOLUTION TO BE SUBMITTED BY LEGISLATOR BASKIN

WHEREAS, New York State has emergency assistance funds that are earmarked for people and families facing evictions following emergency situations. Unfortunately, restrictions to these funds prevents many people from accessing them and as a result, they go unused; and

WHEREAS, currently legislation has been introduced in the New York State Senate, Bill 2023-S8622, that increases the income ceiling to qualify for assistance; removes the requirement that applicants repay the funds and demonstrate an ability to pay their rent in the future; and shortens the waiting period for residents who need to apply for additional assistance in the future; and

WHEREAS, in Erie County, we've seen firsthand the impact these barriers have had on our residents in need of emergency housing, as it has overwhelmed our shelter system and required our Department of Social Services to contract with housing providers that are farther away from the social support system and schools of our families in the emergency housing program; and

WHEREAS, this bill will provide stability for families facing unexpected hardships; relieve pressure from an overwhelmed shelter system; provide funding to landlords whose tenants are experiencing an emergency situation; save New York State an estimated \$13,000 per household by keeping more families out of the shelter system; and bring the administration of these programs in line with the more modern criteria for New York State's other housing assistance programs like HEAP; and
