WHEREAS, this agreement, is in the amount of \$902,000, which provides for the County of Erie's required local share commitment of \$45,100 and acceptance of federal revenue in the amount of \$721,600 and State Marchiselli revenue in the amount of \$135,300 for the design engineering and Right of Way incidentals phases of the Project; and

WHEREAS, after the Federal Aid RFQ process, the firm of Bergmann Associates, was selected as having the necessary expertise, experience, and manpower to provide the County of Erie with design engineering services for the rehabilitation of the above noted segment of Abbott Road; and

WHEREAS, the Department desires to enter into an Engineering Design Services agreement with Bergmann Associates for \$830,600 and establish a project contingency of \$71,400 with the project total not to exceed \$902,000; and

WHEREAS, there are sufficient funds for the project in Fund 420, Funds Center 123, B.23005 – 2023 Federal Aid – Road Design.

NOW, THEREFORE, BE IT

WHEREAS, the Department of Senior Services wishes to reduce long-term care costs by providing services to reduce or delay placement in long-term care facilities; and

WHEREAS, providing home care is a cost-effective manner to provide service and expand it's offering to more at-risk older adults in the community; and

WHEREAS, the Department of Senior Services, through an RFP process selected thirteen Home Care agencies: Allcare Family Services, Inc.; All Metro Home Care Services of New York, d/b/a All Metro Health Care; America Homecare Inc; Caring Enterprises, Inc., d/b/a Health Force; Ciambella Home Care Inc., d/b/a First Light Home Care; Community Care Companions, Inc., d/b/a Community Care HHS; Crane Home Care, Inc.; GoodCare Home Health Services, Inc.; Good

Samaritan Home Health Agency, Inc.; Harmonia Collaborative Care, Inc.; Homemakers of Western New York, Inc., d/b/a Caregivers; Independent Nursing Care, LLC; and Willcare, Inc., d/b/a WILLCARE, to provide services to eligible clients of the Department; and

WHEREAS, the contracts with the thirteen Home Care agencies for a 3-year period will begin April 1, 2024 through March 31, 2027, which at the sole discretion of the County may be extended beyond the initial term for up to two, one-year periods, at prices and conditions agreed upon by the County and Agency; and

WHEREAS, existing aggregate budgetary appropriations totaling \$2,860,149 are available in various Department grants' (163III-E2024, 163III-EARP2124, 163EISEP2425, 163UNMETNEED2425, 163CSE2425) via Home Care services account (516026) to pay for these services; and

WHEREAS, amounts for subsequent contract years are to be determined by appropriations available in each of those year's County budgets.

WHEREAS, TAP/CMAQ/CRP funding supports bicycle, pedestrian, multi-use path and transportation-related projects and programs that support the goals of New York's nation-leading Climate Leadership and Community Protection Act (CLCPA); and

WHEREAS, the Town of Amherst is eligible as a Local Government to apply for these funds; and

WHEREAS, a recently conducted Traffic Impact Study for the Boulevard Central District identified that the intersection of N. Bailey Avenue and Maple Road has approaches operating at poor levels of service and will degrade further with planned redevelopment in the area; and

WHEREAS, a reconfiguration project at N. Bailey Avenue and Maple Road has the ability to reduce vehicle emissions and traffic congestion at this intersection; and

WHEREAS, N. Bailey Avenue is a Town of Amherst-owned right-of-way; and

WHEREAS, a project of this scope, magnitude and expected benefits line up with a CMAQ-specific application; and

WHEREAS, TAP/CMAQ/CRP funding is made available to New York State through the Federal Highway Administration (FHWA) and administered by NYSDOT, with NYSDOT providing up to 80 percent of the total eligible project costs with a minimum 20 percent match provided by the project sponsor; and

WHEREAS, the Town of Amherst is committed towards providing a minimum 20 percent match either using future capital improvement funding or use of transportation mitigation fees collected within the Boulevard Central District, or a combination thereof.
