COUNTY EXECUTIVE

WHEREAS, pursuant to proceedings heretofore had and taken in accordance with the provisions of Article 5-A of the County Law, including approving orders of the State Comptroller, County Sewer District No. 3 (the "Sewer District") of the County of Erie, New York (the "County"), has heretofore been established; and

WHEREAS, this County Legislature (the "Legislature") has heretofore duly directed that there be prepared a report and estimate of cost by the County Engineers (Erie County Department of

Environment and Planning) relating to a proposed increase and improvement of the facilities of the Sewer District (the "Report"), which Report has been approved by the Board of Managers of the Sewer District on April 17, 2024, and filed with the Legislature pursuant to Section 268 of the County Law; and

WHEREAS, the Report describes a proposed increase and improvement of the facilities of the Sewer District, consisting of improvements to the Southtowns Advanced Wastewater Treatment Facility, existing pumping stations, and the sanitary sewer collection system, all as more fully described in the Report; and

WHEREAS, the total maximum estimated cost of the aforesaid increase and improvement of the facilities of the Sewer District is \$215,000,000, which will be apportioned in accordance with applicable flat charges and charges based on units, assessed value and footage specified in the Sewer District's Benefit and User Charge formulas, as such formulas currently exist and as the same may be amended from time to time; and

WHEREAS, pursuant to applicable provisions of Section 268 of the County Law, as amended by Chapter 397 of the Laws of 1995, the consent of the State Comptroller is required prior to the expenditure of funds for such increase and improvement because the estimated \$221.00 cost thereof to the Typical Property (as defined in the County Law) exceeds the applicable threshold for Average Estimated Cost for County Districts on similar types of expenditures, which was computed by the State Comptroller to be \$63.00 for calendar year 2024; and

WHEREAS, it is now desired to call a public hearing to consider such increase and improvement in accordance with the provisions of Section 254 of the County Law.

NOW, THEREFORE, BE IT RESOLVED, BY THE COUNTY LEGISLATURE OF THE COUNTY OF ERIE, NEW YORK, AS FOLLOWS:

Section 1. A meeting of the Legislature shall be held at the County Hall, 92 Franklin Street, 4th Floor, Buffalo, New York, in the County, on the 9th day of September, 2024, at 2:00 o'clock P.M., Prevailing Time, for the purpose of conducting a public hearing upon the aforesaid proposed increase and improvement of facilities of the Sewer District in the County, and for such other action on the part of the Legislature in relation thereto as may be required by law or proper in the premises.

Section 2. The notice of such public hearing shall be in substantially the following form, to-wit:

NOTICE OF PUBLIC HEARING

PLEASE TAKE NOTICE that a meeting of the County Legislature (the "Legislature") of the County of Erie, New York (the "County"), shall be held at the County Hall, 92 Franklin Street, 4th Floor, Buffalo, New York, in the County, on the 9th day of September, 2024, at 2:00 o'clock P.M., Prevailing Time, for the purpose of conducting a public hearing upon a proposed increase and improvement of facilities of Erie County Sewer District No. 3 in the County (the "Sewer District").

The proposed increase and improvement of such facilities consist of improvements to the Southtowns Advanced Wastewater Treatment Facility, existing pumping stations, and the sanitary sewer collection system; all as more fully described in the report and estimate of cost prepared by the County Engineers (Erie County Department of Environment and Planning) which has been filed with the County Legislature and which has been approved by the Board of Managers of the Sewer District on April 17, 2024 (the "Report").

The maximum estimated cost of such increase and improvement of facilities is \$215,000,000, which will be apportioned in accordance with applicable flat charges and charges based on units, assessed value and footage specified in the Sewer District's Benefit and User Charge formulas, as such formulas currently exist and as such may be amended from time to time.

The expenditures for such increase and improvement of facilities will not cause additional costs for property owners in the District for hook-up fees, and the annual cost of such expenditures to the Typical Property (as defined in the County Law) is estimated to be \$221 for the District. The Legislature has heretofore caused to be prepared and filed for public inspection with the Clerk of the Legislature a detailed explanation of how such costs were computed, as incorporated in the Report.

WHEREAS, Assembly Bill A08395 and Senate Bill S07763 would list the synthetic drug Xylazine to a depressant designated as a controlled substance, as the drug, which is commonly used as a large animal tranquilizer, is used by drug dealers as a highly addictive cutting agent, which is added to other illicit substances such as fentanyl and heroin, and due to its high depressant effect on the central nervous system, Xylazine can cause increased withdrawal symptoms, skin sores, necrosis, and death; and

WHEREAS, Assembly Bill A08397 and Senate Bill S07805, would amend the current law to allow the families of loved ones who have died from an overdose to apply for financial compensation through the New York State Office of Victims Services (OVS) crime victim assistance funding, by expanding eligibility for funding to any fatal overdose that resulted from a drug sale categorized as reckless or criminally negligent, so families could make claim for crime-related expenses such as medical bills, counseling, funeral expenses, relocation costs, or loss of earnings; and

WHEREAS, the passage of these three bills, coupled with the continued front-line work of the Erie County Department of Health and our partnering community agencies, could help in turning around the impact of opioid overdose deaths on our friends and families. RESOLVED, that the Erie County Legislature supports the passage of the following three State bills, Chelsey's Law (Assembly Bill A08384 and Senate Bill S077900, listing Xylazine as a controlled substance (Assembly Bill A08395 and Senate Bill S077630, and expanding crime victim assistance funding (Assembly Bill A08397 and Senate Bill S07805); and be it further

WHEREAS, in furtherance of its governmental functions to protect air and water resources, protect the tax base, and preserve soil and water resources, the County desires to support the viability of the agricultural industry by offering grant funding to agribusinesses for damages incurred during the November Lake Effect Storm; and

WHEREAS, the mission of the Erie County Soil and Water Conservation District is to protect and promote the health, safety, and general welfare of the present and future generations of Erie County residents through the conservation of soil, water, air, plant, and animal resources; and

WHEREAS, Erie County Soil and Water Conservation District is the County's designated public benefit corporation for agricultural, soil, and water resource management and assistance; and

WHEREAS, funding was allocated for the November 2022 Lake Effect Storm Damage Fund Program in the 2022 Year-End Budget Balancing Amendments and Designations resolution, Comm. 8E.-1 (2023) approved on April 23, 2023; and

WHEREAS, the Legislature subsequently authorized via resolution Comm. 14E-25 (2023), approved on July 20, 2023 an agreement with Erie County Soil and Water Conservation District to administer the November 2022 Lake Effect Storm Damage Fund Program; and

WHEREAS, on July 10, 2024, Erie County experienced another significant storm event which led to significant damage to Erie County's farming businesses; and

WHEREAS, Erie County desires to assist the agribusinesses impacted by the July 10, 2024 storm event; and

WHEREAS, Erie County desires to amend the budgetary usage of the funds and guidelines to add storm damage incurred on July 10, 2024 to provide funding assistance for agribusinesses impacted by the event.
