RESOLUTION NO. 50

LOCAL LAW TO BE ENACTED BY THE ERIE COUNTY LEGISLATURE IN THE COUNTY OF ERIE LOCAL LAW INTRO.- NO. 3-2-2025 LOCAL LAW- NO. - 2025

A LOCAL LAW requiring meetings of the Erie County Boards and Advisory Committees to provide access to information to the public.

BE IT ENACTED BY THE ERIE COUNTY LEGISLATURE AS FOLLOWS:

SECTION 1. Title

This law shall be entitled and known as "The Meetings Transparency Act"

SECTION 2. Legislative Intent

The Erie County Legislature recognizes that taxpayers should have easy access to details discussed and acted upon at public meetings. The Erie County Legislature prepares an agenda, which it posts before legislative sessions, records videos of meetings available for replay, and posts the minutes of meetings for review. Boards should use available technology to increase access to similar discussions and actions of commissions and boards empaneled by the County.

SECTION 3. Definitions

BOARD: Any government board, commission, council, committee, advisory committee, panel, or similar group created pursuant to the Erie County Charter, Code, or Local Law.

SECTION 4. Meeting Minutes

Boards shall keep written minutes summarizing all official actions, discussions, public comments, and votes at each meeting. Draft minutes shall be made available to the public within 10 business days after each meeting.

The minutes shall be officially approved at the board's next public meeting, and a final version shall be posted publicly online within five business days after approval. The minutes must also be submitted to the Clerk of the Legislature to be included in the official record.

SECTION 5. Notice and Agendas

Boards shall give public notice at least seven calendar days before any regular meeting by prominently posting the date, time, location, and agenda on the general Erie County website and the website of the Erie County Legislature.

For special or emergency meetings, notice should be provided as soon as is practicable.

Meeting agendas shall include a list of topics to be discussed, a list of invited speakers, and an indication of whether any votes or official actions are anticipated.

SECTION 6. Broadcast and Recording of Meetings

To the extent feasible and otherwise required by law, boards should also provide a live stream of meetings for public viewing. Erie County is required to make appropriate accommodations for each board to make this possible. If a live stream is not possible, meetings should, at minimum, be video recorded, and the recording should be posted on the general Erie County website.

SECTION 7. Public Access to Records

Boards shall maintain information to be posted on Erie County's website, which will provide access to board member information, past meeting minutes, agendas, recordings, reports, resolutions, and other official documents.

Upon public request, boards shall provide copies or electronic access to such records promptly as allowed by public record laws.

SECTION 8. Public Comment

Boards should provide reasonable opportunities for public comment at each meeting.

Any restrictions on public comment shall be viewpoint-neutral and clearly stated in the board's policies.

SECTION 9. Directory of Boards

Erie County shall compile and maintain a directory of all Boards and Advisory Committees as defined in Section 3 of this Law on Erie County's website. The directory shall contain hyperlinks to a webpage on Erie County's website for each specific board or committee and provide the relevant information about that board or committee as required by this Local Law.

SECTION 10. Compliance

Originating governmental bodies shall establish procedures to monitor and ensure compliance with this law.

SECTION 11. Severability

If any part of this chapter or the application thereof to any person or circumstance be adjudged invalid by any court or competent jurisdiction, such judgment shall be confined in its operation to the part or provision or application directly involved in the controversy in which such judgment shall have been rendered and shall not affect or impair the validity of the remained of this chapter or the application thereof to other persons or circumstances. The County of Erie hereby declares that it would have passed this chapter or the remainder thereof had such invalid application or invalid provision been apparent.

SECTION 12. Effective Date

This Local Law shall take effect immediately following its filing with the Office of the Secretary of State.

WHEREAS, pursuant to proceedings heretofore had and taken in accordance with the provisions of Article 5-A of the County Law, including approving orders of the State Comptroller, County Sewer District No. 1 (the "Sewer District") of the County of Erie, New York (the "County"), has heretofore been established; and

WHEREAS, this County Legislature (the "Legislature") has heretofore duly directed that there be prepared a report and estimate of cost by the County Engineers (Erie County Department of Environment and Planning) relating to a proposed increase and improvement of the facilities of the Sewer District (the "Report"), which Report has been approved by the Board of Managers of the Sewer District on October 11, 2024, and filed with the Legislature pursuant to Section 268 of the County Law; and

WHEREAS, the Report describes a proposed increase and improvement of the facilities of the Sewer District, consisting of improvements to the existing pumping stations and the sanitary sewer collection system of the Sewer District, all as more fully described in the Report; and

WHEREAS, the total maximum estimated cost of the aforesaid increase and improvement of the facilities of the Sewer District is \$22,100,000, which includes the expenditure of \$6,200,000 from the Sewer District's reserve fund and the issuance of serial bonds in the aggregate principal amount not to exceed \$15,900,000, such amount to be offset by any State, Federal, and/or local funds received, which will be apportioned in accordance with applicable flat charges and charges based on units, assessed value and footage specified in the Sewer District's Benefit and User Charge formulas, as such formulas currently exist and as the same may be amended from time to time; and

WHEREAS, pursuant to applicable provisions of Section 268 of the County Law, as amended by Chapter 397 of the Laws of 1995, the consent of the State Comptroller is not required prior to the expenditure of funds for such increase and improvement because the estimated \$48.08 cost thereof to the Typical Property (as defined in the County Law) does not exceed the applicable threshold for Average Estimated Cost for County Districts on similar types of expenditures, which was computed by the State Comptroller to be \$63.00 for calendar year 2024; and

WHEREAS, the County Legislature has given due consideration to the impact that the Project may have on the environment and, on the basis of such consideration, the County Legislature found that no substantial adverse environmental impact will be caused thereby; and

WHEREAS, the County Legislature and the County have complied in every respect with all applicable federal, state and local laws and regulations regarding environmental matters, including compliance with the New York State Environmental Quality Review Act, comprising Article 8 of the Environmental Conservation Law and, in connection therewith, duly issued a negative declaration and/or other applicable documentation concerning the project, which has been filed in the office of the County Clerk; and

WHEREAS, the County Legislature adopted a Resolution pursuant to Legislative Comm. 19E-21 (2024) on November 21, 2024, calling a meeting of the County Legislature for the purpose of holding a public hearing on the proposed Project in accordance with the Report and Estimate (the "Public Hearing"); and

WHEREAS, such Resolution adopted pursuant to Legislative Comm. 19E-21 (2024) authorized and directed the Clerk of the County Legislature to publish the notice of the Public Hearing; and

WHEREAS, the Public Hearing was duly held at County Hall, in Buffalo, New York, on December 16, 2024, at 2:00 o'clock P.M., Prevailing Time; and

WHEREAS, notice of the Public Hearing was duly published in the manner provided by law;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY LEGISLATURE OF THE COUNTY OF ERIE, NEW YORK, AS FOLLOWS:

- Section 1. Upon the evidence given at the Public Hearing, it is hereby found and determined that it is in the public interest to proceed with the Project and its proposed plan of financing, all as more fully described in the preambles hereto, and the Project is hereby authorized.
- Section 2. It is hereby found and determined that all of the parcels and lots of the District shall be benefited by the Project.
- Section 3. It is hereby found and determined that the maximum estimated cost of the Project is \$22,100,000, which includes the expenditure of \$6,200,000 from the Sewer District's reserve fund and the issuance of serial bonds in the aggregate principal amount not to exceed \$15,900,000, and unless paid for from other sources or charges, such cost to be to be apportioned among the benefitted real properties in the District in accordance with charges based on usage and/or special assessments based on units, assessed value and/or footage, as these or other applicable cost apportionment standards may be specified in the District's Benefit and User Charge formulas (as those currently exist or as they may be amended from time to time in accordance with the County's sewer rents local law and the rules and procedures adopted by the Board of Managers of the District).
- Section 4. It is hereby found and determined that the cost of the Project shall be financed by the issuance of serial bonds of the County (to be issued pursuant to one or more bond resolutions that are to be adopted by the Legislature in the future) at a maximum estimated cost of \$22,100,000, which includes the expenditure of \$6,200,000 from the Sewer District's reserve fund and the issuance of serial bonds in the aggregate principal amount not to exceed \$15,900,000.
- Section 5. It is hereby found and determined that this resolution shall constitute the declaration (or reaffirmation) of the County's "official intent" to reimburse (to the extent permitted) expenditures toward the Project with the proceeds of bonds, notes or other obligations, as required by United States Treasury Regulations Section 1.150-2.
- Section 6. It is hereby found and determined that the County Legislature has directed that the Project (and its proposed plan of financing) for which approval is being sought is in the public

interest and will not constitute an undue burden on the properties which will bear the cost thereof, and if the cost of the proposed improvements is to be assessed in whole or in part against a benefited area, that all real property to be so assessed will be benefited by the proposed improvements and that no benefited property has been excluded.

Section 7. It is hereby directed that within ten (10) days after adoption of this Resolution, the Clerk of the County Legislature shall record with the Clerk of the County a copy of this Resolution, certified by the Clerk of the County Legislature.

Section 8. It is hereby directed that this resolution shall take effect immediately. (6-0)

WHEREAS, the total maximum estimated cost of the aforesaid increase and improvement of the facilities of the Sewer District is \$8,600,000, which includes the expenditure of \$2,700,000 from the Sewer District's reserve fund and the issuance of serial bonds in the aggregate principal amount not to exceed \$5,900,000, such amount to be offset by any State, Federal, and/or local funds received , which will be apportioned in accordance with applicable flat charges and charges based on units, assessed value and footage specified in the Sewer District's Benefit and User Charge formulas, as such formulas currently exist and as the same may be amended from time to time; and

WHEREAS, notice of the Public Hearing was duly published in the manner provided by law;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY LEGISLATURE OF THE COUNTY OF ERIE, NEW YORK, AS FOLLOWS:

Section 1. Upon the evidence given at the Public Hearing, it is hereby found and determined that it is in the public interest to proceed with the Project and its proposed plan of financing, all as more fully described in the preambles hereto, and the Project is hereby authorized in concept.

Section 2. It is hereby found and determined that the parcels and lots of the District shall be benefited by the Project.

Section 3. It is hereby found and determined that the maximum estimated cost of the Project is \$8,600,000 and the plan of financing includes the expenditure of \$2,700,000 from the Sewer District's reserve fund and the issuance of serial bonds in the aggregate principal amount not to exceed \$5,900,000, and unless paid for from other sources or charges, such cost to be to be apportioned among the benefitted real properties in the District in accordance with charges based on usage and/or special assessments based on units, assessed value and/or footage, as these or other applicable cost apportionment standards may be specified in the District's Benefit and User Charge formulas (as those currently exist or as they may be amended from time to time in accordance with the County's sewer rents local law and the rules and procedures adopted by the Board of Managers of the District).

Section 4. It is hereby found and determined that the cost of the Project shall be financed by the issuance of serial bonds of the County (to be issued pursuant to one or more bond resolutions that are to be adopted by the Legislature in the future) at a maximum estimated cost of \$8,600,000. The plan of financing also includes the expenditure of \$2,700,000 from the Sewer District's reserve fund.

Section 5. It is hereby found and determined that this resolution shall constitute the declaration (or reaffirmation) of the County's "official intent" to reimburse (to the extent permitted) expenditures toward the Project with the proceeds of bonds, notes or other obligations, as required by United States Treasury Regulations Section 1.150-2.

Section 6. It is hereby found and determined that the County Legislature has directed that the Project (and its proposed plan of financing) for which approval is being sought is in the public interest and will not constitute an undue burden on the properties which will bear the cost thereof, and if the cost of the proposed improvements is to be assessed in whole or in part against a benefited area, that all real property to be so assessed will be benefited by the proposed improvements and that no benefited property has been excluded.

Section 7. It is hereby directed that within ten (10) days after adoption of this Resolution, the Clerk of the County Legislature shall record with the Clerk of the County a copy of this Resolution, certified by the Clerk of the County Legislature.

Section 8. It is hereby directed that this resolution shall take effect immediately. (6-0)

6. COMM 5E-18 (2025)

COUNTY EXECUTIVE

WHEREAS, Erie County has a Household Hazardous Waste (HHW) Collection Program to provide residents with a safe, effective, and cost-free opportunity to dispose of household generated hazardous waste; and

WHEREAS, every year, Erie County hosts periodic HHW events to properly dispose of chemicals that pose a health and safety hazard and might otherwise contaminate our water, land, or air; and

WHEREAS, beginning in June of 2020, the HHW Voucher program has provided service to over 1,000 Erie County residents on an annual basis; and

WHEREAS, these two services combined service approximately 2,000 households per year; and

WHEREAS, Erie County would realize a fiscal benefit from partial, up to fifty percent, State reimbursement for expenses associated with the collection and disposal of HHW; and
