RESOLUTION NO. 71 RE: Opposing Wind Turbines in Lake Erie's

Waters

WHEREAS, Erie County, New York lies along the shore of Lake Erie, the 12th largest lake in the world; and

WHEREAS, Lake Erie is the shallowest, warmest and most biologically productive of the five Great Lakes; and

WHEREAS, more fish are produced each year for human consumption from Lake Erie than the total from the other four Great Lakes combined; and

WHEREAS, Lake Erie is fed by a drainage basin that is 22,720 square miles and is an important source of drinking water for approximately 11 million people; and

WHEREAS, Lake Erie is the source of water for Niagara Falls, a tourist attraction known for its natural beauty and a major source of hydroelectric power, supplying one-quarter of the power used in New York State and Ontario; and

WHEREAS, Erie County understands the importance of Lake Erie to health, tourism, industry, recreation and quality of life; and

WHEREAS, the installation of windmills on Lake Erie could negatively impact the quality of life for residents in Erie County; and

WHEREAS, the Erie County legislature is concerned that New York State and/or a body created under the auspices of the State might allow private and/or public entities build or direct to be placed wind turbines in the water of Lake Erie; and

WHEREAS, the Erie County Legislature is concerned about the impact of such structures on human and wildlife habitats that depend on Lake Erie; and

WHEREAS, the New York State Energy and Development Authority (NYSERDA) conducted a study, which was completed in 2022, which concluded "Great Lakes wind is technically feasible and potentially economically feasible in some locations of the Great Lakes, however some major gaps in the available data were identified that contribute to high uncertainty"; and

WHEREAS, understanding the deep concern about installing wind turbines in the Great Lakes in the midst of this "high uncertainty," United States H.R. 426, the "Lakes Before Turbines Act," has been introduced to protect our environment and local economies from ill- advised wind energy projects on the Great Lakes.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature opposes the installation of offshore wind turbines in the waters of Lake Erie and requests that a moratorium be imposed on any such projects; and be it further

RESOLVED, that the Erie County Legislature supports the passage and implementation of H.R. 426, the "Lakes Before Turbines Act"; and be it further

RESOLVED, that a copy of this resolution be transmitted to the Governor of New York State, the local delegations of the New York State Senate and Assembly, the local delegation of the United States House of Representatives, and the two United States Senators from the State of New York.

WHEREAS, failure to extend the imposition of the additional 1% and .75% sales and compensating use tax will result in an estimated annual shortfall of more than \$390 million in the Erie County budget, and

WHEREAS, Assembly Bill No. A.7753 and Senate Bill No. S.5247, now pending before the New York State Legislature, would authorize an extension of the additional 1% and .75% sales and compensating use tax, from December 1, 2025 to November 30, 2027;

NOW, THEREFORE, BE IT RESOLVED, THAT A HOME RULE REQUEST IS MADE TO THE NEW YORK STATE LEGISLATURE AS FOLLOWS:

TO THE LEGISLATURE:

Pursuant to Article IX of the Constitution, the County of Erie requests the enactment of Assembly Bill No. A.7753 entitled "AN ACT to amend the tax law, in relation to the imposition of additional rates of sales and compensating use taxes by Erie County"

It is hereby declared that a necessity exists for the enactment of such legislation, and that the facts establishing such necessity are as follows:

The local government does not have power to enact such legislation by local law.

Other facts as set forth in the following explanation establish such necessity.

Failure to authorize the extended imposition of the additional 1% and .75% sales and compensating use tax will result in an estimated annual shortfall of more than \$390 million in the Erie County budget, the cessation of services essential to the people of Erie County and jeopardize any sharing of net collections therefrom with Erie County's cities, towns and villages.

Such request is made by the local legislative body of such local government, at least twothirds of the total membership thereof having voted in favor of such request.
