ERIE COUNTY COVID-19 UPDATE

As of May 20 (morning), there were:

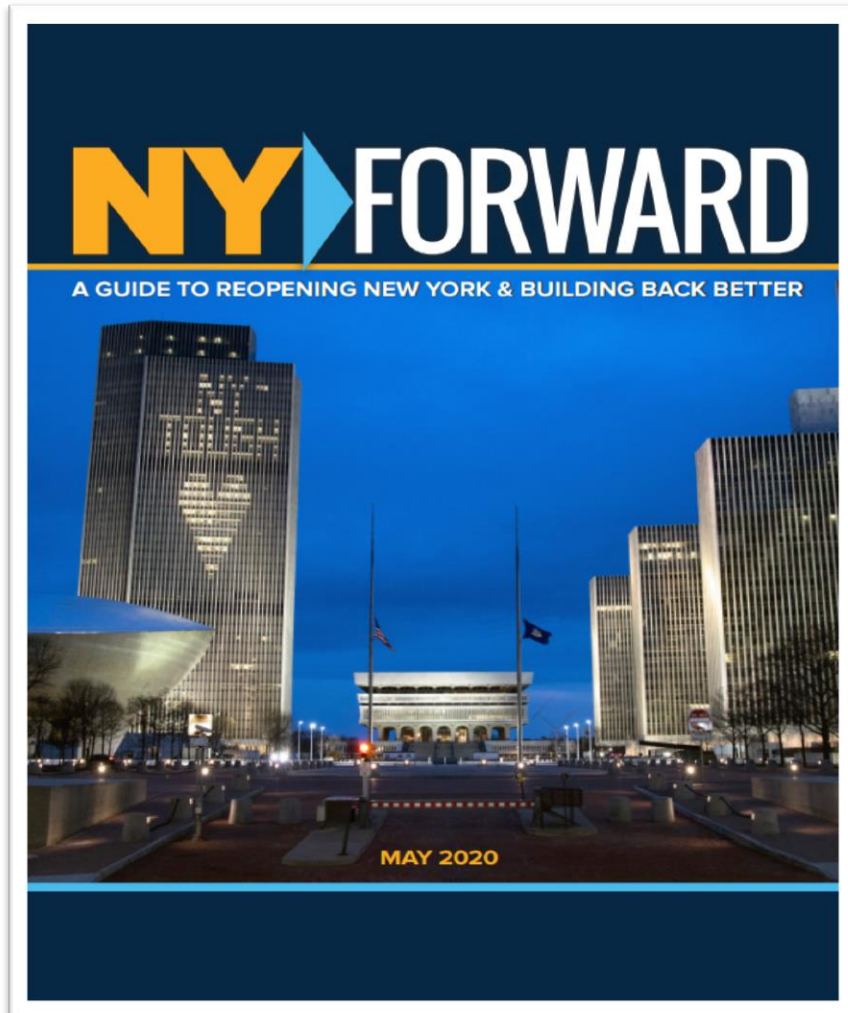
- 5,054 total positive cases (32,873 persons)
- 455 people have died.
 - These were all lab-confirmed cases.
 - There are NO presumed positive cases.
- On May 18, there were 182 individuals admitted to Erie County hospitals for Covid-19. 45 were in the ICU and 33 had an airway assist.

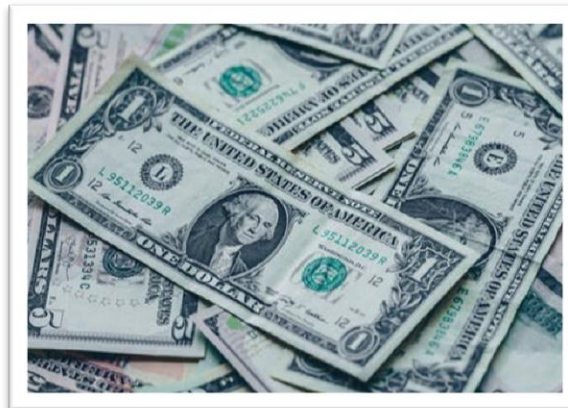

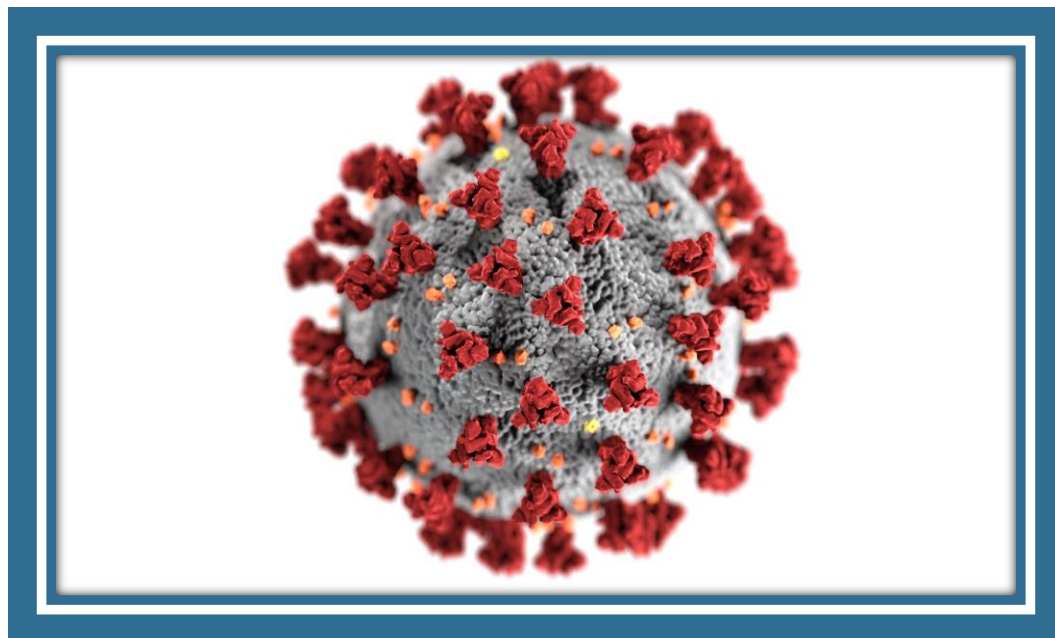
