Privilege of the Floor – <u>Robert Scheib, 51 Brooklyn Street</u>, has made several visits to board beginning in 1995-2001 on the issue of the tire pile on Route 5 behind Antique World. Mr. Scheib presented new board member Councilman Chaffee with a packet of copies outlining the history of the tire pile. He requested an update on the issue and questioned if the sewer project in Clarence Center will have an effect on this problem. He also questioned the Akron Airport status especially the issues of the construction of a cross-wind runway and a no fly zone over the school. Supervisor Summe responded to both questions: Super Fund moneys will be necessary for cleanup of the tire pile and the airport issues are now with the FAA for review with our consultants.

Approval of Bills -Councilwoman Glor reported that she had reviewed the Abstract from Batch #222 & 223 from the 12/22/03 meeting with the previously UN-audited vouchers and found everything in order. She presented Abstract Batch #225, 227 & 228. Vouchers on this abstract numbered for 2003-2825-2823,2834-2875, 2004-1-15 totaling \$210,018.26 and were presented for payment approval by Councilwoman Glor, seconded by Councilman Finger to approve payment.
