Newstead Town Board Meeting- February 13, 2006

A Public Hearing was called to order by the Newstead Town Board on Monday, February 13, 2006 at the Newstead Town Hall at 7:30PM.

The Supervisor called the Public Hearing on the increase and improvement to Water District #10- Phase 2 to order. Town of Newstead Engineer Andrew Casolini stated that this project was in the Master Plan and construction will begin this summer. The cost will be similar to Phase 1 and public informational meetings regarding installation will be held April-May 2006.

The Deputy Clerk read the proof of publication. Comments:

- Phillip Kenline, 8238 Greenbush Rd., questioned the charge on his tax bill for the new water district. One is a fixed fee, the other is a fee based on one's total assessment. The fees are payable over 30 years.
- Russell Rosenberg, 7982 Greenbush Rd, questioned whether the second fee was based on just one's home or all parcels owned.
- Peter Henley, 6263 Scotland Rd questioned whether it was cost effective to install at Scotland Road. Andrew replied that we will build until the money runs out.

A motion was made by Councilman George, seconded by Councilman Finger closing the public hearing on Water District #10- Phase 2 increase and improvement.

The regular meeting was called to order at 8:00PM.

Roll Call was taken with all board members present.

Don Folger led the pledge to the flag.

A motion was made by Councilman George, seconded by Councilman Finger to appoint Brian Murray to the vacant Councilman seat for the remainder of 2006.

Work Session: Supervisor Cummings reported that at the work session held on January 30th and February 6th the following issues were discussed: Archives, water district #10 issues, water district #1 & #3 switch over to ECWA, water service at the Rapids Rd substation, the shared facilities project, Lateral restriction policy, Local Law #1 of 2006, highway issues, re-zoning of Rt. 5, Capitalization Policy, Village police services, Wendel services contract, 1% Sales tax, acceptance of partial payments resolution, Global signal expansion, Historical Society comments and unfinished items: Akron Airport funding of hanger, job descriptions for all employees, terms and conditions, library elevator issues.

Communications – The Town Clerk presented the following:

A letter from APA Nursery School expressing their interest in the use of the lower level of the Newstead Library as a new home for their nursery school program.

Certification from the Association of Towns that the Town of Newstead is a member in good standing for the year 2006.

A letter from resident Judith Miller of 13588 Stage Rd regarding her dog being hit while crossing Crittenden Rd. She would like the speed limit on each side of the bridge lowered to 35 mph and a warning "Crossing" sign placed on each side of the bridge.

The monthly report from Amherst Central Alarm offices was received reporting the January 2006 calls for Akron Fire Co. - 39 and Newstead Fire Co. - 13.

A letter from NYS Trooper Captain Mark A. Koss regarding the Troopers needs for the proposed 4-bay garage to be constructed for the village and trooper cars and storage.

A letter of response from the NYS DOT on the SEQR/ site plan review on Water District #10-Phase 2.

A letter from Erie County Comptroller Mark Poloncarz to all tax collectors in Erie County notifying the collectors that his office will be conducting on-site field audits during the collection period in late February thru early March.

A letter from Assemblyman Paul Tokasz reporting the distribution estimates for Erie County municipalities that will be sharing in the \$12.5 million additional sales tax distribution.

A motion was made by Councilman George, seconded by Councilman Finger to receive and file correspondence as presented.

Privilege of the Floor – Doug Ceisner, 100 East Avenue commented as follows: (1) Can agendas for Town Board Meetings be published in the Buffalo News. (2)Why does the Newstead Fire Company Community Calendar have only one Board Meeting scheduled each month? These issues will be looked into by the Supervisor. (3) The ditch on his property at South Newstead & Main is plugged up; can the Ditching Committee do something? Supervisor Cummings advised him to put this request in writing. (4)Unsafe buildings – Dr. Hoover's is still in litigation, but there are a few more standing. The Building Administrator will provide an updated report for the next meeting. (5) What is the cost of the Shared Facilities Project, and he believes the site next to St. Theresa's is a terrible one. Councilman George replied that a Feasibility Study is underway. (6) Instead of Town trucks hauling millings out of the Village, we should stockpile them. (7)The last Supervisor said we were no longer a friendly town, but a business town, (8) He is happy that the Board decided not to license Plumbers. (9) Price of an average legal notice – less than \$100.

Peter Henley, 13760 Indian Falls Road, North East Caissons, Inc. reported this property is available and feels it has everything for the Shared Public Works Facility and stated he would forward information to Councilman George.

A motion was made by Councilman Decker, seconded by Councilman Finger approving the 2005 year end budget transfers per a memo from Bookkeeper Kathy Strobele dated 2/2/06.
