Minutes from the previous regular meeting held on March 9, 2009 were presented for approval. A motion was made by Councilman Finger, seconded by Councilwoman Esposito to approve as presented.

Communications – The Deputy Town Clerk presented the following:

A letter was received from Time Warner Cable notifying the town that the Time Warner Cable franchise is now a separate entity from Time Warner Inc. and is now being publicly traded.

A copy of a letter sent to Governor Paterson was received from the NYS Association of County Clerks committing their support to the Town Clerk's in their efforts to have Part NN, Sections 26 thru 28 of the Governors budget stricken from the bill in both the Senate and the Assembly.

A letter from John Braunscheidel, 7619 Scotland Road, requesting use of soccer fields at the Newstead Town Park for the Empire United Soccer Academy, formerly Buffalo United Soccer Club, for Monday and Wednesday from 6:00-8:00PM starting April 6-July 8, 2009.

A motion was made by Councilman George, seconded by Councilman Finger to receive and file correspondence as presented.

Support of Town Clerks & Highway Superintendant elected position:

A motion was made by Councilmen Rooney, seconded by Councilwoman Esposito opposing Part N N Sections 26 thru 28 of S.56/A.156, Public Protection and General Government Article VII of the NYS Governors Bill, which would enable changing the Town Clerk's and Highway Superintendents positions from elected to appointed positions by a permissive referendum as opposed to the current mandatory voters referendum and requesting the support of the Senate and Assembly to have these sections of the Governors budget pulled out prior to a vote on the budget.
