A regular meeting was called to order by the Newstead Town Board on Monday, April 25, 2011 at 8:07pm at the Newstead Town Hall.

Roll Call was taken with all board members present.

Councilman Rooney led the pledge to the flag.

Minutes from the previous regular meeting held on April 11, 2011 were presented for approval. A motion was made by Councilman Baran, seconded by Councilman Mayrose to approve as presented. Carried Unanimously

Communications – The Town Clerk presented the following correspondence:

A copy of the on-line survey results from the Akron Bugle regarding community comments on the future use of the Limerick Hall.

A letter from Erie-Niagara Tobacco Free Coalition encouraging the town to adopt a tobacco-free policy for the municipality and all its buildings and parks.

A letter of resignation was received from Recreation Board member Melissa Sanford.

A motion was made by Councilman Mayrose, seconded by Councilman Rooney to accept and file the presented correspondence. Carried Unanimously

The Supervisor thanked the Akron Bugle for running the Limerick Hall survey.

Work Session: The Supervisor reported that at work session held last the following items were discussed: a meeting with Assessor Becky Baker on several issues, water districts issues, building projects updates, planning issues, murder creek project, airport issues, HVAC contracts & costs, limerick hall, and any other issues brought before the board.

Privilege of the Floor – <u>Dale Cheavacci – 113 John St.</u> – questioned the status of the airport. Supervisor Cummings explained that we have to wait until May 5th for any SEQR/agency comments. The board will then discuss making an official SEQR declaration. It then goes back to the ZBA for their decision on the variance. Any future site plans submitted go to Planning Board and then Town Board for final approvals. Dale suggested the Board take a look at drainage this week with all the rain we have had.
