## **Newstead Town Board Meeting- June 13, 2005**

A Public Hearing was called to order by the Newstead Town Board on Monday, June 13, 2005 at the Newstead Town Hall at 7:40PM.

The public hearing was called to order by the Supervisor on the qualified abandonment of Wahl Road.

The Deputy Town Clerk read the proof of publication.

The Highway Superintendent Dale Kruschke explained the reasons for this proposal. There are no Permanent residents on Wahl Road. The qualified abandonment means there is still a slight use of the road, but not enough to warrant maintenance expenditure. Wahl Road can still be accessed, and will still be owned by the Town of Newstead. A fence must be erected, but not locked.

Comments: George Pannella, 7311 Milesstrip Rd, Orchard Park, questioned if he would be blocked and not be able to use road and his property. He will still be able to use the road to access his property.

Caesar Tronilone, Hamburg, NY (relative of Paycon) would like the road partially kept open. His family donated the road to Town of Newstead 75 years ago and would like to reclaim, would like Billo Road re-opened which was abandoned on request of the Paycon Family in 1994. He thought Billo Road in Alden was abandoned. They now will fight legally to get road back to Paycon Family.

Bruce Pacyon, 8137 Center St., Holland, NY feels that Billo Rd was totally abandoned in Alden .

Town Attorney Nathan Neill stated that NYS Law is either total abandonment or qualified abandonment. We can not abandon only a portion of the road.

Supervisor Summe states that the DEC and LaFarge needs access. The Town of Newstead is not taking side of corporation, just following New York State Law.

There being no other comments, a motion was made by Councilman Finger, seconded by Councilman Decker to close the public hearing on the qualified abandonment of Wahl Rd.

The Supervisor called to order the public hearing on Local Law No. 2 of 2005 regarding fences, walls and decorative markers at 8:15pm.

The Deputy Town Clerk read the proof of publication.

The Supervisor explained the reasons for this proposal.

Comments: Justin Rooney, 32 Bloomingdale Ave, Akron, NY, questioned the meaning of decorative markers. It was explained as a "fancy post"

There being no other comments, a motion was made by Councilman George, seconded by Councilman Finger to close the public hearing on the proposed Local Law No. 2 of 2005.

A regular meeting of the Newstead Town Board was called to order at 8:20pm.

Roll Call was taken with all board members present except Councilman Chaffee who is out of town.

Gracie Brucker led the pledge to the flag.

Minutes from the previous regular board meeting held on May 23, 2005 were presented for approval. A motion was made by Councilman George, seconded by Councilman Decker to approve as presented.

**Communications** – The Deputy Town Clerk presented the following:

A letter from Tom Lonzi, owner of Tom's Pro Bike in Lancaster thanking the town for their assistance and hospitality on Sunday May 15<sup>th</sup> during their 11<sup>th</sup> annual bike ride for Roswell Park. The town park pavilion was opened for the bicyclists to use as a rest stop/bathroom break during their ride. They are all very appreciative of our help.

The May and June water testing report for Water Districts #1 & #3 was received from Mid-state Environmental Labs with all samples passing acceptable limits.

A letter from Assemblywoman Sandra Lee Wirth regarding her petition drive to allow important legislation on dangerous sexual predators and improvements on "Meghan's Law" to be brought to the Assembly floor. We currently have completed 3 full petitions which will be returned to the Assemblywoman within the next two weeks.

A fax transmission from Amherst Central Alarm Office reporting the May calls for Akron Fire Co.-42 and Newstead Fire Co.-33.

A notification from Subsea Oil & Gas Inc. that they have applied for an exploratory gas/oil well drilling permit from the NYS Bureau of Mineral Resources for a site in the Akron Quad.

A notification from the Town of Alabama regarding a public hearing to be held on June 13, 2005 at 7:00pm regarding the proposed Local Law #2 of 2005 amending their Zoning Law to include the definition for Wind Energy Conversion System- Production Model.

A letter from the Labor-Management Healthcare Fund explaining the packages available from their group for employers.

A motion was made by Councilman George, seconded by Councilman Finger to receive and file correspondence as presented.
