# Newstead Town Board Meeting- October 13, 2003

A Public Hearing was called to order by the Newstead Town Board on Monday, October 13, 2003 at the Newstead Town Hall at 7:50 PM.

Roll Call was taken with all board members present except Councilman Cummings who left work session feeling ill.

A Public Hearing on public input for the 2004 Erie County Community Development Block Grants was called to order at 7:50pm.

The Town Clerk read the proof of publication.

The Supervisor explained the background of this grant and its possible uses.

#### Comments:

David Wakeman of Crittenden Road suggested the purchase of a small Public Address system for use during the Memorial Day Parade ceremonies. It is very difficult to hear speakers at the outside ceremony and could be used for other purposes as well, if this purpose falls within the limitations of the grant.

A motion was made by Councilwoman Glor, seconded by Councilman Finger to close the public hearing at 7:55pm.

A Regular Meeting of the Newstead Town Board was convened at 8:00pm with the same members present as above.

David Wakeman led the pledge to the flag.

Minutes from the previous regular board meeting held on September 22, 2003 and the Special Meeting held on September 29, 2003 were presented for approval. A motion was made by Councilman George, seconded by Councilwoman Glor to approve as presented. Carried Unanimously

**Communications** – The Town Clerk presented the following:

A Certificate of Course Completion was received by Assessor Fred Pask for completion of a course on managing electronic records while at his Lake Placid conference.

A fax transmission from Amherst Central Alarm with their report for September 2003 announcing calls for Akron Fire Co.- 34 and Newstead Fire Co.- 20.

A letter from Akron Fire Co. requesting work session time to discuss a future purchase of fire equipment.

A letter from Akron and Newstead Fire Companies requesting provisions be made for both fire companies to have a repeater station on the new proposed cell tower on Rapids Road.

An announcement from the NYS Comptroller's office of a coming seminar on Finding Funds for Public Water & Sewer Projects, to be held October 22, 2003 via teleconference at several sites throughout the state.

The monthly water sampling report from the Village of Akron was completed on October 7, 2003 with all levels being within acceptable ranges.

A quarterly refuse report from BFI for the months of July 1, 2003- September 30, 2003.

A letter from the NYS DEC announcing a Notice of Complete Application on the Texas Brine Pipeline ROW on Crittenden Road.

A motion was made by Councilman George, seconded by Councilman Finger to receive and file correspondence as presented.

**Work Session**: Supervisor Summe reported that work session was held on September 29, 2003 and October 6, 2003 and the following were discussed: White Tail Deer Farm, Airport rezoning, Water District #10, the Senior Center, Schurr Road, drainage issues, the budget, joint town/village items and other topics.

# Privilege of the Floor -

John Burke, 4820 Crittenden, questioned numerous line items in the Tentative 2004 Budget including, but not limited to: The estimated fund balance and what it will be on December 31<sup>st</sup> this year, cultural & recreational grant money guarantees, no change in the Town Clerk's salary, increases in building & grounds fund, increases in unallocated insurance & bonds, Seniors personnel and health care insurance and pension costs for employees. He also questioned if the costs for a sound system were budgeted and where. He stated he would still like to see the board begin to tape record meetings.

A motion was made by Councilwoman Glor, seconded by Councilman Finger to approve several budget transfers as detailed and requested by Bookkeeper Kathleen Strobele.

**Approval of Bills** -Councilwoman Glor reported that she had reviewed the Abstract from Batch #197 & 198 from the 9/22/03 meeting with the previously UN-audited vouchers and found everything in order. She presented Abstract Batch # 203 & 204. Vouchers on this abstract numbered 2452-2465 and 2466-2533 totaling \$105,892.64 and were presented for payment approval by Councilwoman Glor, seconded by Councilman George to approve payment.

**Highway** – September's big metal pick-up was 36.81 tons of metal at \$25.00/ton. The town received a check for \$920.25. 2 salt spreaders were sold to other townships for \$200 a piece. There will be a \$.16 increase in the cost of trucking salt this winter, but we could be saving as much as 42% on other items. The bike path restoration will be completed this week. No trespassing signs were removed from the bike path in the Utley Road area. 5 projects were done with the bulldozer rentals on drainage and ditching. The 2004 mowing contract has been submitted to the state.

**Assessor** – 2004 Update project- data analysis of sales field review will begin shortly. Will be scheduling some open meetings on assessments and how they are figured.
