### Newstead Town Board Meeting- June 12, 2023

A public hearing was called to order by the Newstead Town Board on Monday, November 14, 2022 at 7:26pm at the Newstead Town Hall.

Roll Call was taken with all board members present.

The Supervisor called the first public hearing to order on the proposed 8-Lot major subdivision with no public improvements at 11080 Stage Road at 7:24pm.

The Clerk read proof of publication. The Supervisor explained the proposed subdivision has been approved by the Planning Board and a drainage easement the Town engineer recommended has been obtained. No action will be taken tonight as we are still in the 30-day comment period.

<u>Julie – 11513 Stage Rd</u> – moved to Newstead 15 years ago and things have changed with a dramatic increase in construction. Because of the ongoing construction on the road there is a lot of road debris to the point Ride-For-Roswell won't bring their route onto Stage Road. Adding 8 lots will increase the construction and the equipment and she believes it is dangerous. She is also concerned with the wetlands/swamp behind the lots. Where will the water go and is this a phased project?

<u>Tom Wilson – 11011 Stage Rd</u> – also has concerns about water retention. Will they be doing something to keep the water on that side of the road? Also asking where the entrance will be.

<u>Joel Lattimer – 11340 Stage Rd</u> – is in the construction business and is not against the subdivision. His wife and him walk everyday and is concerned about construction debris and are there more lots in the plan for the future.

<u>Justin McNaughton – 11513 Stage Rd</u> – there is one large house going up near Mr. Schultz's house that has been trucking dirt in for the last 3 years. Stage Road is a stone and oiled road and is easily damaged by construction equipment. Their quality of life has been compromised by a single house and he is concerned as to what 8 more will do.

Kelly Schultz – 11080 Stage Rd – he purchased the property from Lafarge in 2006 and the property came with a mining permit but he chose not to mine it. He has planted 600 trees, put in a beautiful pond and has tried to make his property look good. He has high expectations for the houses built on the lots of the proposed subdivision. A corner of the farthest proposed lot to the east is 100 feet from the wetland and behind all the lots are wetlands and can never be developed. This is a road frontage subdivision only. The proposed lots are 150' x 400' and there are zero plans for the of the property.

<u>Jacob Metzger – 8245 Sheridan Dr</u> – as the houses are being built the Town will have to monitor the work and the Town Engineer and the DEC have already given their approval. All of the water will be diverted towards the wetlands and they will never develop in the wetlands.

There being no further comments, a motion was made by Councilman Jendrowski, seconded by Councilwoman Pope to close the public hearing at 7:57pm. Carried Unanimously

The Supervisor called the second public hearing to order on the proposed 13,255 sq. ft. addition located at 12600 Clarence Center Rd at 7:58pm.

The Clerk read proof of publication. On May 8, 2023 the Planning Board recommended this project for approval and Erie County Highway has also approved it. No action will be taken tonight as we are still in the 30-day comment period.

<u>Anita Davis – 12657 Clarence Ctr Rd</u> – her biggest concern is why the Town would allow them to build closer to Clarence Ctr Rd. Why can't they build behind the existing buildings. Sometimes there is an odor emitted from the furnaces and issues with noises and vibrations. She is fearful things will get worse with the addition.

Councilman Jendrowski replied that this is not the same proposal Niagara Specialty Metals made last year. This is an addition that will be down across from Limerick Hall.

<u>Bob Shabala – Niagara Specialty Metals</u> – the proposed project from last year, which would have come closer to Clarence Center Road was scaled down to just a remodel as the original project just got too big.

<u>Tony Brandl – 6320 Hake Rd</u> – he is concerned that any building put up will deposit water in his yard. Also concerned about the noise.

Bob Shabala spoke that Niagara Specialty Metal shares a drainage plan with I Squared R. All the water goes back to the bike path. There are also ditches and a retention pond.

There being no further comments, a motion was made by Councilman Burke, seconded by Councilwoman Pope to close the public hearing at 8:11pm. Carried Unanimously

The regular meeting of the Town Board was called to order at 8:11pm with the same members present as listed above.

Councilman Dugan led the pledge to the flag.

Minutes from the regular meeting held on May 22, 2023 were presented for approval. A motion was made by Councilman Dugan, seconded by Councilman Burke to approve as presented.

An updated brochure from Erie County Department of Senior Services was received updating the suggested contribution from \$3.00 one-way and \$6.00 round-trip to \$8.00 one-way and \$16.00 round trip.

A request for a beer/wine permit was received from Angela Warren for a party at Skyline Park on July 22, 2023.

A motion was made by Councilman Dugan, seconded by Councilwoman Pope to accept and file the presented correspondence.

**Work Session:** The Supervisor reported that at the previous work session the following items were discussed: water updates, a rezoning application, highway needs and a ditching issue, project updates, building needs and grant updates. An executive session was held from 7:49pm to 9:18pm to discuss personnel, contractual items and possible pending litigation. No action was taken. An executive session was held tonight from 6:57pm to 7:22pm to discuss possible pending litigation with no action taken.

Councilman Jendrowski stated that it seems, in his opinion, that things have gotten better the last few weeks.

<u>Carol Boismenu – 83 Quarry Hill Estates</u> – this year there have been 3 events so far at the Backlot and every one of them has violated the rules and regulations. Asked why they aren't being held responsible for following the rules.

The Supervisor explained that the Town Board develops and amends the policies, but the CEO is the one who enforces them.
