

THE FOLLOWING RESOLUTION WAS OFFERED BY

WHEREAS, the Town Board of the Town of Newstead has previously requested that a speed and traffic study be conducted of the area surrounding the intersection of Cedar Street and Carney Road with the most recent request submitted in 2020; and

WHEREAS, the Town received notice from the New York Department of Transportation dated February 9, 2021 that a 45 MPH speed limit would be established for both Carney Road and Cedar Street (between Swift Mills Road and a point .5 +/- miles north of Lewis Road), a copy of which notice is attached hereto; and

WHEREAS, the former Town Supervisor subsequently sent correspondence to Erie County requesting that the intersection be modified to a four way stop, and a response was received that an all way stop was not warranted; and

WHEREAS, the Town Board has subsequently received requests from residents for an additional speed and traffic study to be conducted due to ongoing accidents at this intersection; and

WHEREAS, the Town Board believes it would be prudent to again seek a speed and traffic study of the area surrounding the intersection of Cedar Street and Carney Road as numerous accidents have occurred there over the past few years.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN BOARD AS FOLLOWS:

1. The Town Board hereby requests that a speed and traffic study be performed of the area surrounding the intersection of Cedar Street and Carney Road in the Town of Newstead based on resident requests.
2. The Town Board directs the Town Clerk to file a TE9 request with Erie County Dept. of Public Works and the New York State Dept. of Transportation to conduct said speed and traffic study.
3. This resolution shall take effect immediately.
