A public hearing was called to order by the Newstead Town Board on May 13, 2024, at 7:26 pm at the Newstead Town Hall.

Roll Call was taken with all board members present.

The Supervisor called the public hearing to order for a proposed site plan from Cory Quinn to place sheds related to a seasonal business, The Haunted Forest at 11167 Main Road.

The Clerk read proof of publication. The Supervisor explained this was recommended by the Planning Board and Erie County had no recommendations.

Cory Quinn, owner of The Haunted Forest was present and explained the wanted to use the sheds for a ticket booth and other things to enhance the experience. Councilman Burke asked the hours of operation and would they be using any amplification. Mr. Quinn said the hours would be from 8pm-1am and yes they will be using amplification but since they are so far back in the woods no one will hear it.
