## MISSION

The Erie County Arts in Public Places (AIPP) Initiative seeks to make art accessible for all Erie County residents and visitors and to support a sense of community connection and civic pride.

The initiative aims to improve quality of life, support local artists, and foster a vibrant artistic environment that reflects the diverse culture and creativity of Erie County residents.

## HISTORY

In 2023, the County Legislature passed Erie County Local Law #4 to further develop the county's financial support of public art. The law created a funding mechanism related to certain capital projects. Specifically, the law requires one percent of the cost of qualifying capital projects to be allocated to a "Public Art Fund". The maximum public art allocation for any capital project is \$10,000. The present balance within the Public Art fund is \$220,722.54; \$84,988.54 remaining from the 2025 appropriation, and a 2026 appropriation of \$135,734.

The fund supports the implementation of public art projects chosen by the Art in Public Places (AIPP) Committee and finalized in the annual Master Public Art Plan.

# 2025 AIPP MAJOR WORKS

## COMPLETED AT ERIE COUNTY HEALTH MALL & BUFFALO CONVENTION CENTER

### Overview

As detailed in the 2025 Master Public Art Plan, Erie County's AIPP Committee released a Call for Art inviting local artists to submit proposals for public art projects at five locations throughout Erie County: Seneca Bluffs Natural Habitat Park, Como Lake Park, Ellicott Creek Park, Erie County Health Mall, and the Buffalo Convention Center. Fifty-eight (58) proposals were received and reviewed by the Selection Committee. In reviewing eligible submissions, the committee considered the artist's professional background and experience with similar projects, the proposed design and its relationship to the site and broader community, as well as maintenance requirements associated with the project.

Three proposals were recommended for implementation, with two of three moving forward upon contract execution. The selected artists, Erie County residents with applicable experience, presented projects that activate and beautify public spaces, engage the community, and reflect Erie County's unique values and culture.




### BUFFALO CONVENTION CENTER MURAL BY CASSANDRA OTT AND CHUCK TINGLEY

**Address:** 153 Franklin Street, Buffalo, NY, 14202

**Title:** Queen City Kaleidoscope

**Public Art Location:** Exterior wall along Pearl Street

**Artist Description:** Our mural design covers the majority of the proposed Buffalo Convention Center wall and is inspired by Buffalo's beloved blue and red. We used these colors as a springboard to create a vision for a colorful corridor down Franklin Avenue. Buffalo is full of murals depicting its namesake bison and legendary wings, but Buffalo is so much more than those icons. The welcoming communities, deep histories and industry along Lake Erie are represented here in a harmonious swell of blues and reds. Elements representative of nature, waves and fingerprints line the sidewalk with a sea of colorful connections that welcome the community and visitors to the region. Highlights of a metallic gold are interspersed throughout the design to represent the sun over Lake Erie and add interest.

**Address:** 1500 Broadway Ave Buffalo NY 14212

**Title:** Cloud of Hope

**Public Art Location:** Exterior wall on the east side of the building.

**Artist Description:** This artwork invites viewers to pause and reflect, offering them a moment of tranquility and inspiration in their everyday lives. It could serve as a gentle reminder of the beauty in nature and the vastness of the world above us, encouraging everyone to look up and dream.

# 2025 AIPP SMALL WORKS ACQUISITION PROGRAM

## Erie County Launches Public Art Collection

### Overview


The Art in Public Places Committee is dedicated to transforming Erie County's public spaces into vibrant, welcoming environments that celebrate the diversity and creativity of the region. In the summer of 2025, the AIPP Committee released a Call for Art to consider the purchase of artwork for display inside various county-owned facilities. These works would comprise Erie County's first Public Art Collection. The Call for Art received over 300 responses, reflecting the extraordinary talent within our region. Through an extensive selection process involving a semi-finalist and finalist round in which works were reviewed online and subsequently in-person, the AIPP Committee acquired 22 pieces from 17 local artists. Works include paintings, collages, photographs, mixed media and sculptural works. Currently on display at the Buffalo Convention Center, the works may be rotated periodically to other county-owned facilities such as libraries, government offices, and community centers.

The Small Works Acquisition Program fosters engagement, sparks dialogue, and creates a sense of belonging while providing local artists with meaningful opportunities to shape the aesthetic and cultural identity of Erie County. The selected artists represent Erie County's creative community, and their contributions ensure that public spaces throughout the county remain dynamic, inspiring, and inclusive.



## 2026 PUBLIC ART PROJECTS

### 2026 Major Works

Upon approval of the 2026 Erie County Art in Public Places Master Plan, the AIPP Committee will release a Call for Artists open exclusively to artists residing in Erie County with an additional focus and priority for artists who are racially and ethnically diverse.

The Call for Artists will invite proposals of public art projects for up to two locations throughout Erie County, offering artists a unique opportunity to showcase their creativity and engage with the community through public art. The Call for Artists will outline eligibility criteria, thematic guidelines, and submission requirements.

This initiative reflects Erie County’s commitment to supporting local artists and enriching public spaces through meaningful, accessible art experiences.

**2026 Major Works** Erie County's AIPP Committee is partnering with **The Buffalo and Erie County Botanical Gardens** and **Erie County's Department of Parks, Recreation & Forestry** to implement public art projects at the following locations:

### BUFFALO AND ERIE COUNTY BOTANICAL GARDENS

**Address:** 2655 South Park Ave. | Buffalo, NY 14218

**Background:** Installing a public art project at this location will further enhance the planned expansion and renovations of the Buffalo and Erie County Botanical Gardens that are currently underway. The purpose of these renovations is to create fully accessible and inclusive spaces while improving comfort and functionality to meet the growing demand for field trips and private events. The proposed public art project will complement these efforts and work to support the Gardens' mission of delivering immersive and memorable visits. At the same time, this collaboration provides a unique opportunity to emphasize the connection between art and nature at one of the County's most visited cultural assets.

# 2026 Major Works CONT.

## ISLE VIEW PARK IN PARTNERSHIP WITH SUBMERSE NY

**Address:** 796 Niagara St. | Tonawanda, NY 14150

**Background:** This location provides a synergistic opportunity between the AIPP Committee, Erie County Department of Environment and Planning, Division of Environmental Compliance Services (ECS), and Erie County Parks, Recreation & Forestry Department. Fueled by a \$10,000 grant from the Submerse NY Initiative, the project will leverage AIPP's proven expertise in sourcing public art alongside ECS's educational outreach focused on environmental challenges related to flooding, watershed dynamics, and seiches along the publicly accessible Shoreline Trail at Isle View Park. Together, these efforts position public art to serve as a catalyst for awareness, resilience, and dialogue, merging creativity with sustainability to inspire a community-wide conversation about our shared environmental future.

Erie County Resiliency Art Committee, comprised of Submerse NY members, is composed of environmental professionals and community stakeholders. The selected theme will serve as a foundation for artists to explore the intersection of art, science, and community resilience. The organizations represented on this committee are:

Selected pieces will be acquired and installed in various county-owned buildings, where they will be accessible to the public and contribute to a welcoming, vibrant, and culturally enriched environment. This initiative supports local artists while enhancing public spaces through diverse and meaningful artistic expression.
