Supervisor Gambino called the regular June meeting to order at 6:30 PM with the Pledge to the Flag led by Councilman Leonard Hochadel. Before beginning the pledge Councilman Hochadel ask for a moment of silence after for long time Sardinia residents Sam Feraldi and Art Buncy who had both recently passed away.

Supervisor Gambino stated that the first item on the agenda was the approval of the minutes from the Regular May meeting held on May 12th. On a motion by Marsh, seconded by Krist, the minutes were approved, as submitted. Carried, 5 ayes, 0 noes.

Supervisor Gambino stated that the next item on the agenda is to approve the payment of the bills. Warrant #6 of 2022, including vouchers #286 through #353, totaling \$334,360.23 of which \$299,463.13 was for the General Fund, \$10,094.44 was for the Highway Fund, \$23,970.67 was for the Fire Protection Fund and \$831.99 was for the Street Lighting Fund. On a motion by Hochadel, seconded by Domster, the Warrant was approved for payment. Carried, 5 ayes, 0 noes.

Departmental Reports were as follows:

Councilman Marsh had nothing to report.

Councilman Domster reported that the Town Wide Garage Sale weekend would be held July 8th, 9th & 10th

Councilman Hochadel reminded everyone the schedule was available for the concerts in the park.

Councilman Krist questioned if there was a property maintenance laws in Sardinia. It was noted that the Code Enforcement Officer handles all of those concerns.

Supervisor Gambino reported that she had a Zoom call regarding the new fitness pad in the park. She noted that the pad has been poured and has to cure for 28 days therefore it is expected that the equipment should be put on the pad the last week of June or first week of July. Supervisor Gambino noted that she has gotten two sponsors for the fitness pad. Horizon Masonry for \$2500.00 and Willey Well Drilling for \$1,000.00. Next Supervisor Gambino reported that she had done a walk through at the pool house and the bathrooms at Manion Park. She noted that there were a few thing to still complete but things were on track for the pool to open around the 20th of June. Next Supervisor Gambino stated that she had given the board members a list with costs for the following new items for the pool:

- 3 Umbrella @ \$458.85 each = \$1,376.55
- 3 Umbrella bases @ \$388.85 each = \$1,166.55
- 2 46" square tables @ \$1,328.85 each = \$2,657.70
- 1 46" square ADA table @ \$1,258.85 each =\$1258.85
- 5 Benches @ \$378.85 each = \$1,894.25
- 3 trash cans with rain bonnets @ \$638.85 each = \$1916.55
- 2 lifeguard chairs @ \$1356.00 each = \$2712.00

Supervisor Gambino stated that Horizon would be covering the cost for umbrellas and bases due to a backorder of the material for the shade structure. On a motion by Marsh, seconded by Hochadel, the Supervisor was given permission to order the items listed above. Carried, 5 ayes, 0 noes. Next Supervisor Gambino stated that she had been given the list of planned Recreation field trips late so they did not get on the agenda for approval. The trips and cost estimates are as follows:

Supervisor Gambino asked if there were any question regarding the trips. There were none. **Therefore** on a motion by Marsh, seconded by Domster, the Recreation trips were approved. Carried, 5 ayes, 0 noes.

Highway Superintendent Hopkins reported that he had received notice regarding the 2022 Chips funding, Pave NY funding and Extreme Winter Recovery funds. Superintendent Hopkins reported that NYS also has funds available in the Pave Our Potholes program. Superintendent Hopkins stated he would need

approval to accept and spend these funds. Therefore on a motion by Gambino, seconded by Hochadel, Superintendent Hopkins was given permission to spend this funding for road repairs. Carried, 5 ayes, 0 noes. Next Superintendent Hopkins stated that he had a number of items to be declared surplus inventory so he can list them on Auctions International. They include 13 tires, a roll of 5/8 cable, a 200 amp breaker box, a wet dry vacuum and the old baseball back stop from veterans park. On a motion by Marsh, seconded by Domster, Superintendent Hopkins was given permission to list the items on Auctions international. Carried, 5 ayes, 0 noes.

Supervisor Gambino stated that the next item on the agenda was a resolution to approve summer recreation and pool staff as well as the appointment of an extra constable. Therefore the following resolution, to be known as Resolution #16 of 2022, was moved for adoption on a motion by Krist, seconded by Domster:
