<u>Old Business:</u> Nancy asked the board if they had read the Comprehensive Plan update document that she emailed to each member. Everyone had except Christine. She was not able to get the pdf to open, the file was too big. It was decided to request a physical copy from the Town Clerk. Becky Burke will pick it up and drop it off to Christine's house as she works during the day and is not able to get to Town Hall during its open hours.

Nancy told the board there were two items that were important related to the Comprehensive Plan Update. She stated at the last meeting October 28th to review the Comprehensive Plan Update with Beverly Gambino, Andrew Reilly and David DiMatteo, Andrew and David suggested zoning codes be drawn up regarding the development of subdivisions. The second item was related to zoning codes for the development of wind energy production. Nancy and Bob stated that there was language drawn up 5 years ago. Bob asked if it would still be current? Nancy said that David DiMatteo, the town lawyer, volunteered to look at it to evaluate if it would meet current standards and laws.

The Planning Board was required to have one and the Town Board would conduct the second one. Nancy asked if everyone could make a meeting on Tuesday, December 7, 2021 at 7 pm or did it need to be a little later, such as 7:30 pm. Christine asked if it could be held at 7:30 pm due to her work schedule.

A Motion was made by Bob Hill, seconded by Christine Eisensmith to approve holding the Public Hearing on the Comprehensive Plan Update be held on Tuesday, December 7, 2021 at 7:30 pm. Vote was 5 Ayes to 0 Nos approving this motion. Please see the Appendix for the Planning Board Resolution.
