

7-11-2025 - REGULAR JULY MEETING

Supervisor Gambino called the Regular July meeting to order at 6:30 PM with the Pledge to the Flag led by Albert Hansen.

Warrant #7 of 2025, including vouchers #323 through #391, totaling \$417,221.14 of which \$48,976.69 was for the General Fund, \$351,223.36 was for the Highway Fund, \$16,100.00 was for the Fire Protection Fund and \$921.09 was for the Streetlighting Fund. On a motion by Hochadel, seconded by Kittleson, the Warrant was approved for payment. Carried, 4 ayes, 0 noes, 1 absent.

Supervisor Gambino stated that there was one set of minutes from the Regular meeting held on June 12th to be approved. **On a motion by Kittleson, seconded by Becker, the minutes were approved as submitted. Carried, 4 ayes, 0 noes, 1 absent.**

Department Reports:

Deputy Miller updated the Board on activities of the ECSO in the Town of Sardinia.

Supervisor Gambino updated the board on the number of seniors signed up for the upcoming senior trips. Supervisor Gambino reported that she was working with the Town Engineer regarding more parking at the park. Supervisor Gambino suggested adding handicap parking signs to the back of shelter 1 and 2. She asked that Councilman Hochadel announce that it's available at the next concert.

Councilman Kittleson reported that she would be meeting with the installer for the playground this coming week. Councilman Kittleson also reminded everyone that it was Town Wide Garage Sale weekend this weekend.

Councilman Becker had nothing to report

Councilman Hochadel complimented the highway department on the road work they did on Meyers Rd. Supervisor Gambino asked how many people attended the concerts. Councilman Hochadel stated there was about 130-140. There was more discussion on parking at the park.

Superintendent Dabolt reported that the new truck he ordered was in. He stated that he has completed about 90% of his planned road work. Lastly he reported that the additional veteran's banners are done and will be put up soon.

Supervisor Gambino stated that the next item on the agenda was a resolution for endorsement from the Town for Camp Seven Hills Girl Scout Camp so they can apply for funding for renovations. **On a motion by Kittleson, seconded by Becker, the following resolution to be known as Resolution #8 of 2025 was moved for adoption.**

Resolution #8 – 2025

APPROVAL AND ENDORSEMENT OF THE APPLICATION OF THE GIRL SCOUTS OF WESTERN NY FOR A GRANT FOR A PARK PROJECT KNOWN AS CAMP SEVEN HILLS

WHEREAS, the Girl Scouts of Western New York is applying to the New York State Office of Parks, Recreation and Historic Preservation (OPRHP) for a grant under Title 9 of the Environmental Protection Act of 1993 for a park project to be located in Sardinia, NY, a site located within the territorial jurisdiction of this Town Board; and

WHEREAS, as a requirement under the rules of this program, said not-for-profit corporation must obtain the "approval/endorsement of the governing body of the municipality in which the project will be located";

NOW, THEREFORE, be it resolved by this July 2025 body that the Town Board of Sardinia hereby does approve and endorse the application of the Girl Scouts of Western New York for a grant under Title 9 of the Environmental Protection Act of 1993 for a park project known as Camp Seven Hills and located within this community.
