

8-14-2025 - REGULAR AUGUST MEETING

Supervisor Gambino called the Regular August meeting to order at 6:30 PM with the Pledge to the Flag led by Gerard Wittington.

Supervisor Gambino stated that there was one set of minutes from the Regular meeting held on July 11th to be approved. **On a motion by Kittleson, seconded by Hochadel, the minutes were approved as submitted. Carried, 5 ayes, 0 noes, 0 absent.**

Warrant #8 of 2025, including vouchers #392 through #473, totaling \$95,503.42 of which \$65,070.66 was for the General Fund, \$27,441.39 was for the Highway Fund, \$1,743.38 was for the Fire Protection Fund and \$1,247.99 was for the Streetlighting Fund. On a motion by Krist, seconded by Becker, the Warrant was approved for payment. Carried, 5 ayes, 0 noes, 0 absent.

Department Reports:

Deputy Miller updated the Board on activities of the ECSO in the Town of Sardinia and gave a breakdown of the 79 calls that were handled in Town.

Supervisor Gambino stated that the Town has received two applications for new fireman and a letter from the Fire Company requesting approval for a current member to remain active after moving out of town. **On a motion by Hochadel, seconded by Kittleson, the following resolution to be known as Resolution #10 of 2025 was moved for adoption.**

WHEREAS, Matthew Shantz is a Resident of Sardinia and Della Newman is non-residents of the Town of Sardinia, and

WHEREAS, the Town has also received a request from **Alexis Kozmycz**, a current member, to change from an active resident member to a non-resident member due to a recent move

WHEREAS, the Sardinia Town Board supports and approves the appointments of Matthew Shantz, Della Newman and Alexis Kozmycz.

NOW THEREFORE, BE IT RESOLVED, that the Town Board approves the appointment of Gina and Charles Wright, Volunteer Fireman to the Chaffee-Sardinia Memorial Fire Department.

DULY ADOPTED, this 14th day of August, 2025 by the following vote: Becker, aye, Hochadel, aye, Krist, aye, Kittleson, aye, Gambino, aye. So resolved, 5 ayes, 0 noes, 0 absent.

Supervisor Gambino stated that everything was ready to go out to bid for the elevator upgrade project and that approval was needed to advertise for bids. **On a motion by Kittleson, seconded by Becker, the advertisement for bids was approved. Carried, 5 ayes, 0 noes, 0 absent.** Next Supervisor Gambino stated that the September Regular Board meeting would be held at Veterans Park in shelter 4 at the regular time of 6:30. Supervisor Gambino noted that an email was received letting the Town know that the monthly Senior lunch for August would be held at Mel's Diner instead of the park.

Councilman Kittleson reported that the site work for the new play ground has started.

Councilman Becker reported that the senior bus trip to Forest Lawn was coming up on September 17th and noted that there are still seats available for the trip in December for the Holiday Pops Concert.

Councilman Hochadel reported that the concerts in the park have gone well with about 200-250 people at the attending and that the last one is on August 19th.

Councilman Kirst reported on some park maintenance items.

Highway Superintendent Dabolt reported that he would be meeting with Erie County regarding possible work being done on Carriers Road.

Supervisor Gambino asked if anyone had any other items for discussion. There were none. There being no further business to come before the Board the meeting was adjourned. **On a motion by Krist, seconded by Kittleson, the August Regular meeting was closed at 6:41 pm. Carried, 5 ayes, 0 noes, 0 absent.**
