Supervisor Gambino called the Regular February meeting to order at 6:30 PM with the Pledge to the Flag led by James Wiedemann.

Supervisor Gambino stated that there was one set of minutes from the Regular meeting held on February 12th to be approved. **On a motion by Krist, seconded by Hochadel, the minutes were approved as submitted. Carried, 3 ayes, 0 noes, 2 absent.**

Warrant #3 of 2026, including vouchers #96 through #142, totaling \$490,897.59 of which \$105,241.42 was for the General Fund, \$31,160.78 was for the Highway Fund, \$353,293.03 was for the Fire Protection Fund and \$1,202.36 was for the Streetlighting Fund. On a motion by Hochadel, seconded by Krist, the Warrant was approved for payment. Carried, 3 ayes, 0 noes, 2 absent.

Department Reports

Deputy Miller updated the Board on ECSO activities in the Town.

Councilman Krist asked if park caretaker Albert Hansen will be taking care of planting trees in the park.

Councilman Hochadel reported that the schedule for the concerts in the park was done and copies were available. He reminded everyone that the concerts would be in June and July this year.

Superintendent Dabolt reported a representative from Legislator Lorigo's office had been out to look at Curriers Road and potential repairs. He also noted that the new doors were installed at the highway garage. Lastly Superintendent Dabolt reported that big trash pickup will be held on April 21st.

Supervisor Gambino stated that the next item was a resolution to reappoint pool director Danielle Scott and recreation director Toni Ann Orsini so they can do interviews over spring break. **On a motion by Krist, seconded by Hochadel, the following resolution to be known as Resolution #6 of 2026 was moved for adoption.**

Moved by Krist, second by Hochadel that Danielle Scott be appointed Pool Director for the 2026 Summer Recreation Season, and Toni Ann Orsini appointed Recreation Director both at the hourly rate of \$24.08
