Public Hearing Local Law #3 – Chapter 105 Flood Damage Prevention

Attorney Trapp presented the Public Hearing, explaining it was mostly modifications of definitions and numbering, nothing substantial. There was no Public comment.

Motion by Trustee Casell, seconded by Trustee Daluisio to adjourn, from the regular meeting at 7:48 and enter into the Public Hearing. Carried.

BUSINESS FROM FLOOR-

Andrea Lingerselter <u>-</u>13346 Baxter Ave., had several questions concerning water. Wondered why we continue to use village water if the survey leaned more toward ECWA? And why we cannot have the residents vote for their preference? Salt is expensive and cumbersome. Attorney Trapp – the state regulates what voting can be held for and this does not qualify. The Mayor reminded her it was a survey and not a vote. It was not a large majority for the survey for ECWA, but we are connecting with a permanent connection on Exchange St. and will take a minimum amount. The connection will cost \$90,000. The village has applied for a grant the past two years but has been denied. To go to ECWA the rate would increase 40%.

Andrea Lingerselter – questioned the new car wash with the additional gas, oil & road salt going into the water system?

Trustee Casell explained the car wash will recycle 80% of their water used. Trustee Overhoff questioned the rate of \$6.50 above and beyond the existing \$6/1000 gallon rate. Mayor Manicki explained there is a 16% water loss we would have to pay for and debt service.

Trustee Overhoff – once again questioned the recent newsletter and the board did not vote on the content. Mayor Manicki – was discussed at Work Session. Trustee Overhoff did not feel the rate comparison was a fair comparison of different types of water and reminded the board they could've hooked into ECWA at no charge. Mayor Manicki reminded Trustee Overhoff that was 25 years ago.
