Public Hearing 3 way stop sign Irving & Emerson streets.

Herb Schmidt, 1555 Emerson St. read the following prepared statement. The following notes are a summary based on related conversations with the residents at the following addresses over an eight-year period. However, several residents have lived on Emerson for 30 years or more. We also believe that these issues extend to all pedestrians within the village especially those South of Broadway using Emerson St. which is a major conduit for children as young as 7 years old who walk to school.

- 1. What has changed over the years?
- i. Emerson is now a pass through for drivers:
- ii. Travelling to the apartment complex.
- iii. Trying to bypass and avoid the signal at Crittenden and Broadway.
- b. There are more cars on the road.
- c. Families are busier and more rushed than ever before.
- d. Drivers are more distracted than ever before.
- 2. Issues Residents would like to be addressed:
- a. Speeding- Drivers tend to hit the gas at one end to get to the other. Many local residents and commuters are in a routine.
- b. Cross Walk Safety- on Emerson St. at Irving St. Most of us have had a close call within the intersection. Drivers tend to drive through and often turn onto Irving St. without slowing or even signaling!
- c. Enforcement- The Village of Alden chose to end local policing with the understanding that the State Police and EC Sheriffs would take over. We are not saying they should give more tickets to local residents, but an increased presence with some warnings (however, we do not want to destroy some young high school student). According to older residents, when Alden had a local police force there was a greater respect within the village. This is why local policing is making a resurgence because it works. Police can be posted regularly during rush hours and certain weeknights and weekends. The goal is to change the driving culture of OUR village to more of a village like East Aurora, Corfu, or Arcade.
- 3. Suggested Remedies:
- a. Designate Emerson St. as a school zone: with signage and enforcement.
- i. According to NYS DOT website: Length of a School Speed Zone
- 1. "Maximum distance is 1320 feet (0.25 miles) along a highway passing a school building

Ron Toczek – 1561 Emerson. Wants stop sign. concerned with traffic all hours of the day, night, summer and weekends, not just during school hours. There have been close calls at the crosswalk on Irving at Emerson. Trustee Overhoff – stop sign will back up traffic, people will not stop and there is no parking within 30' of a stop sign. Parking needs to be looked at, possibly no parking allowed or parking on 1 side of the street only. Trustee Casell - There is already a backup of cars down Emerson during start and end of The new 4 way stop sign at Irving & Westcott school. Patty Aquila -13389 Irving St. has had a huge impact. It slows people down. I have grandchildren on Emerson and it would make a difference. Trustee Daluisio - this is a fact finding mission for us to review public input. If not a stop sign, other signage possibly. Bank does not want the stop sign as it will increase traffic to their private drive. The school feels it will back up traffic & cause issues. There are a lot of issue to absorb. Dan Czelusta – 1677 Meadow Dr. Lucky you have sidewalks, cars speed down our street all the time. If stop signs erected, should have no parking on either side of the street. Ron Toczek does not feel it will back up traffic. Mike Galbraith – 13276 Irving St. Agrees with some of Herbs assessments, but parks on the street and if parking is restricted on Emerson, cars will park on Irving and it is already crowded. As it is the kids are in the street playing. Cars currently park within 30' of the stop sign on Irving. Will change traffic patterns to Park and Crittenden or the bank. Trustee Casell – what changed your mind on the stop sign? Parking restrictions? Herb – yes. Mrs. Zosh – 1548 Emerson – speed is an issue. Mr. Zosh – need a signal at Broadway & Emerson. Mayor Manicki – Broadway is a state road. They did a traffic study recently there for lighted pedestrian crossings. Loren Prucnal – 1602 Westcott – cars are speeding down all the roads and go thru the stop signs. Distractive driving. Mayor Manicki – I live on a corner and 50% roll or do not even stop. Clerk Galbraith – spoke to Linda Hey, Crossing Guard – concerned Broadway & Emerson currently backed up, will get worse. Ron Toczek – all about the kid's safety. One student in the audience commented the 5 students in attendance are all walkers, and have had closes calls on their way to school.

MOTION by Trustee Daluisio seconded by Trustee Casell, to exit the Public Hearing and return to the regular meeting at 8:08 pm. Carried.
