WHEREAS The Pink Cow is requesting site plan approval for a retail store facility; and

WHEREAS the site plan approval is classified as an Unlisted action and is subject to review within the requirements of the New York State Environmental Quality Review Act (SEQR); and

WHEREAS, pursuant to Article 8 of the Environmental Conservation Law, the Pink Cow has prepared a short environmental assessment form, which is now on file with the Village of Alden, and may be reviewed at the Village offices, 13336 Broadway, Alden, New York 14004; and

WHEREAS, pursuant to the Law, the Village of Alden Board of Trustees assumes lead agency status.

NOW, THEREFORE, BE IT:

RESOLVED, that the Village of Alden Board of Trustees hereby assumes the role of lead agency for the purpose of determining what significance this project has on the environment, and be it further

RESOLVED, that the Village of Alden Board of Trustees, as Lead Agency, hereby determines that the proposed Unlisted actions, as described in the attached SEQR Negative Declaration, Notice of Determination of Non-Significance, which attached notice is hereby made part of this resolution, will not have a significant effect on the environment and that an environmental impact statement is not required to be prepared with respect to said proposed action.

- 2) A backflow prevention device must be installed as per all applicable requirements and obtain all necessary approvals.

SEQR Negative Declaration Reasons Supporting Determination For: The Pink Cow, 13119 Broadway

The proposed The Pink Cow retail facility reflects the use of land within the Village of Alden as recommended by the Village of Alden's Comprehensive Master Plan. The properties immediately west, north, and east and south of the subject property are in a C-1 Commercial Zoning District., which is the zoning that is identical to that of the subject property.

The Village of Alden Board of Trustees decided that no potential moderate to large impacts could occur related to changes in use and intensity of use.

Therefore, the Village of Alden Board of Trustees has determined that there is likely to be no adverse environmental impacts relating to this project.

Considering there are no indicators of significant effect on the environment and these changes are consistent with the Village of Alden's Comprehensive Master Plan, a negative declaration is declared. no comment, 5 ayes. Carried.

MOTION by Trustee Warmus and seconded by Trustee Daluisio, to approve the following proclamation:

WHEREAS, as Chairman of the Village Sesquicentennial Celebration he helped to not only celebrate the advantages of life in a small and vibrant Village but to also usher in a new generation of individuals to continue his legacy of public service and sacrifice, and

WHEREAS many of us have had the distinct pleasure and honor of working with an individual of such high character and moral values who never forgot about all those around him,

NOW, BE IT THEREFORE RESOLVED, that the Village of Alden, the Board of Trustees of the Village of Alden, the employees of the Village, and indeed, all of the residents of the Village hereby proudly and unabashedly give thanks to an individual who has stood by the Village and all that it means for so very long, and

WHEREAS, Angelo Daluísio, enriched young minds as a teacher in places from Hawaii to North Tonawanda to Orchard Park after graduating from the State University of New York College at Buffalo, and

WHEREAS, you may not have truly lived until you have been honored with the friendship and culinary wizardry with his homemade pizza and brownies, and

WHEREAS his success and love of professional photography is secondary only to his accomplishments with raising two extraordinary daughters with his wife, Pamela, and

WHEREAS, he has served not just the Village of Alden as a Planning Board member for four years and later as a Village Trustee for six years, but he also faithfully served the Town of Alden Zoning Board of Appeals as well as the Villages of Lancaster and Williamsville as Building Inspector, and

WHEREAS, his devotion to his craft and all the lives that he has touched over the years as a coach, volleyball referee, or volunteer with Alden Meals on Wheels or the Erie County Home Library cannot be adequately measured or honored by a mere passage of words, and

<u>Superintendent Sitzman</u> – weekly e coli testing negative. The currier we previously used has said other customers are changing labs also.

<u>Trustee Daluisio</u> – this is my last meeting, and I have worked with great people. I was appointed 8 years ago, to Ron Smith's position. The next time I ran, I was not elected. One resident said he would not vote for me unless I have lived here 25 years and know Alden. I re-ran and did win that election. I have lived in 2 large cities & 3 villages. Our local Court provides both civil and criminal services to our residents.
