MOTION by Trustee Warmus and seconded by Trustee Overhoff, to appoint Mark Pruitt to the position of Emergency Management Coordinator for the Village of Alden. On the question –5 ayes, Carried.

MOTION by Trustee Kibbe and seconded by Trustee Prucnal, to approve the Fire/EMS calls for November 7-21, 2020. On the question –5 ayes, Carried.

MOTION by Trustee Warmus and seconded by Trustee Kibbe, to approve the request from the Alden Chamber of Commerce to erect a 3'x10' banner on the bandstand from Dec. 5th-January 4th. On the question –5 ayes, Carried.

MOTION by Trustee Warmus and seconded by Trustee Prucnal, to appoint Stephanie Genco to the Planning Board to fill the unexpired term of Esther Kibbe. Term to expire 3/31/2024. On the question –5 ayes, Carried.

BUSINESS FROM FLOOR-

Patrick Martino, Waste Management -handles all municipalities in NYS, was present to answer any questions on the refuse bid proposal. He thanked Keith and the board on the comprehensive bid, it was well done. Cost savings compared to cost stability.

REPORTS FROM COMMITTEES/DEPARTMENT

Attorney Trapp will check for OEM agreement with town.

Superintendent Sitzman – parking ban is in effect.

Trustee Warmus – attended the Town board meeting Nov.17 concerning fire protection. Residents want the current districts to remain, no ETA or risk assessments done, town did not do their homework and it will cost someone their life, very disappointing. If a fire at Tops gas station, Alden H&L 2 minutes out if McDonald's Townline is 4-5 minutes out. Mayor Casell – the next day Nov. 18 – the town wanted us to cover a partial district in the south east corner, where most of the "concerned residents" lived at a decreased compensation. Which we said no. Then they countered to add Sandridge area for \$35,000. The village offered to continue to cover the entire current area for 1 year for the \$35,000. The Village and Alden Hook & Ladder concerns with the safety of town community comes first, cover the pre-existing district. Meeting next day 11/19 – new district map was presented, item was tabled. The town said they lost confidence in the village and no documents were submitted but appears that it is all about Station 2. They have until 12/31 to finalize the contract. The village and fire dept. have offered to meet with the town, but nothing yet.

<u>Mayor Casell</u> need to set meeting to review garbage contract. Consider cost and perception of community. Work session December 2, 7 pm. Posted doors and website. Noon whistle, replace timer? Can it be repaired?
